INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Lutheran SeniorLife Employees' Retirement Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lutheran SeniorLife Employees' Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“U.S. GAAS”). NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following brief description of Lutheran SeniorLife Employees' Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering substantially all employees of Lutheran SeniorLife (the "Company"). Certain union employees hired before January 22, 2005 and employees classified as student or temporary are excluded from the Plan. Participants may enter the Plan immediately for purposes of making salary deferral contributions. Participants are not eligible to receive employer matching contributions unless they have completed one year of service, earned 910 hours, and attained age twenty-one. Effective January 1, 2024, participants only need to attain age twenty-one to be eligible to receive matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

CONTRIBUTIONS

Each year, participants may contribute up to 70% of pretax annual compensation, as defined by the Plan up to the maximum limits of the Internal Revenue Code ("IRC"). Effective January 2024, participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

The Company makes a matching contribution each pay period to the Plan based on the following schedule:

- 100% of the first 2% of the participant's compensation contributed.
- 50% of the next 2% of the participant's compensation contributed.

The Company may make annual nonelective contributions to the Plan as approved by the Board of Directors. There were no nonelective contributions for the years ended December 31, 2024 and 2023. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a person is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the Company's contributions portion of their accounts plus actual earnings thereon is based on years of credited service. Matching contributions vest ratably over five years of continuous service.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. At December 31, 2024, rates on outstanding notes receivable are between 1.25% and 8.50%. Principal and interest is paid ratably through payroll deductions. Notes receivable are stated at their unpaid principal balance plus accrued unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

PAYMENT OF BENEFITS

Upon termination of service, death, disability or retirement, a participant may elect to receive the vested interest in their account in the form of a lump-sum payment or other option. In addition, the Plan allows for hardship distributions if certain criteria are met.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements of the Plan are presented under the accrual method of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except for the fully benefit-responsive guaranteed investment contracts, which are reported at contract value). See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

FULLY BENEFIT-RESPONSIVE GUARANTEED INVESTMENT CONTRACTS

The Plan holds traditional fully benefit-responsive guaranteed investment contracts with Transamerica Life Insurance Company, The Lincoln National Life Insurance Company, Brighthouse Life Insurance Company, Variable Annuity Life Insurance Company, and Equitable Financial Life Insurance Company totaling \$5,192,659 for 2024 and \$5,383,026 for 2023. Transamerica Life Insurance Company, The Lincoln National Life Insurance Company, Brighthouse Life Insurance Company, Variable Annuity Life Insurance Company, and Equitable Financial Life Insurance Company maintain contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan. The crediting interest rates are based on a formula agreed upon with the issuers, but they may not be less than the Guaranteed Minimum Interest Rate. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity dates.

These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Transamerica Life Insurance Company, The Lincoln National Life Insurance Company, Brighthouse Life Insurance Company, Variable Annuity Life Insurance Company, and Equitable Financial Life Insurance Company, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

FORFEITED ACCOUNTS

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be allocated to participant accounts, reduce the Plan's expenses, or reduce future employer contributions. Forfeited nonvested accounts totaled \$104,902 and \$71,206 at December 31, 2024 and 2023, respectively. Forfeitures were not utilized in 2024 or 2023.

SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 2, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The Plan measures its investments at fair value on a recurring basis in accordance with U.S. GAAP. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that authoritative guidance establishes for measuring fair value includes a hierarchy used to classify inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value measurement.

The levels of the fair value hierarchy are as follows:

Level 1 – Fair value is based on unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.

Level 2 – Fair value is based on significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Level 3 – Fair value is based on significant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies (mutual funds) are valued at the quoted net asset value of shares held by the Plan at year end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan is administered under an agreement with Transamerica Retirement Solutions ("Transamerica"), a party-in-interest as defined by ERISA. Transamerica provides various third party administrative services to the Plan. Transamerica serves as an agent for State Street Bank and Trust Company.

During 2024, there were transactions involving the investment of Plan assets in accounts maintained by State Street Bank and Trust Company, Transamerica Life Insurance Company, Variable Annuity Life Insurance Company, The Lincoln National Life Insurance Company, Brighthouse Life Insurance Company, Equitable Financial Life Insurance Company, and New York Life Insurance and Annuity Corporation (the "Trustees"). The Plan's assets are held in trust by the Trustees, parties-in-interest, as defined by ERISA. The Plan's assets are invested in investment options offered by Transamerica as directed by the Plan's participants.

Participants may borrow from their fund accounts and, therefore, these transactions also qualify as party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become one hundred percent vested in their accounts.

6. TAX STATUS

The Plan has been designed to qualify under section 403(b) of the IRC and, therefore, it is not currently eligible to receive a determination letter from the Internal Revenue Service. The Plan is required to operate in conformity with the IRC to maintain its qualification under section 403(b). The Plan Administrator believes the Plan is operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes the Plan is qualified and the related custodial accounts are tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. INFORMATION CERTIFIED BY TRUSTEES

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2502.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustees have certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule, Schedule H, Line 4i – Schedule Of Assets (Held At End Of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year then ended. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

8. RECONCILIATION TO FORM 5500

The DOL regulations [Reg. 2520.103-1(b)(3)] require the notes to the separate financial statements to explain any variances from U.S. GAAP or differences between the information reported in the separate statements and in Schedule H. There were no material differences between the financial statements and the Form 5500.

9. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
