1. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The valuation techniques used in the accompanying financial statements have been consistently applied.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Contributions Receivable

Contributions receivable represent salary deferrals; i.e., matching contributions from the Firm and non-elective Firm contributions received by the Plan after year-end that relate to payroll dates prior to the Plan's year-end.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2024 through October 10, 2025, the date the financial statements were available to be issued.

2. Description of Plan

The following description of Orrick, Herrington & Sutcliffe LLP Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Orrick, Herrington & Sutcliffe LLP (the "Firm"), a California limited partnership, sponsors the Plan and is one of the three employers participating in the Plan. The other participating employers are Orrick, Herrington & Sutcliffe (UK) LLP in the United Kingdom and Orrick, Herrington & Sutcliffe (Europe) LLP in France and Italy, which provide coverage for European partners sited abroad who are U.S. citizens or resident aliens. The Plan is a defined contribution plan established effective December 31, 2001, as restated January 1, 2020. Each participant in the Plan (i.e., partner, non-partner attorney or non-attorney staff) who attains 30 days of service is entitled to voluntarily elect to reduce their salary or draw payments and to have the Firm contribute such amounts to the Plan as their salary or draw payment contributions (deferrals in the Plan document). Employees classified as temporary, limited, or contract employees are required to complete one year of service for participation. Excluded from the Plan are employees that are governed by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Participant Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan document, for up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 10% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Employer Contributions

Two types of Firm contributions are available to participants - Firm matching and Firm non-elective. The two types of Firm contributions are described below.

- Firm Matching - Each non-attorney staff participant in the Plan is entitled to a Firm match in an amount that equals 50% of the first 1.5% of total compensation deferred. In 2024 and 2023, Firm matching contributions totaled \$763,956 and \$789,386, respectively.

Matching contributions are made on behalf of eligible staff, provided they remain an employee of the Firm on the last business day of the year for which the contribution is made, unless termination is due to death or disability or employment terminates at or after age 60. All participants are 100% vested.

- Firm Non-Elective - The contribution design for partners was simplified effective January 1, 2010. The Firm "discretionary" contribution was discontinued. Instead, the Firm "basic" contribution was increased to the statutory limit and renamed the "non-elective" contribution.

For 2023, the non-elective contribution limit for partners age 40 or older on January 1 with adjusted Firm earnings of \$330,000 (IRS compensation limit) or greater was \$43,500 (the difference between the IRS annual additions limit [\$66,000] and the elective deferral limit [\$22,500]).

For 2024, the non-elective contribution limit for partners age 40 or older on January 1 with adjusted Firm earnings of \$345,000 (IRS compensation limit) or greater was \$46,000 (the difference between the IRS annual additions limit [\$69,000] and the elective deferral limit [\$23,000]).

For 2023, the non-elective contribution limit for partners under age 40 was \$22,000 (the difference between one half of the IRS annual additions limit [\$33,000] and one half of the elective deferral limit [\$11,250]).

For 2024, the non-elective contribution limit for partners under age 40 was \$23,000 (the difference between one half of the IRS annual additions limit [\$34,500] and one half of the elective deferral limit [\$11,500]).

The non-elective contributions earned by individual partners and contributed on behalf of the of counsel attorneys totaled \$19,136,000 and \$18,661,500 for the years ended December 31, 2024 and 2023, respectively.

The Firm's basic contribution to non-attorney staff was also renamed "non-elective," and the rate for both 2024 and 2023 was 7.5% of eligible pretax compensation, up to the IRS compensation limit, resulting in a maximum amount per individual of \$25,875 and \$24,750 for 2024 and 2023, respectively. Non-elective contributions for non-attorney staff totaled \$8,048,498 and \$7,950,638 for the years ended December 31, 2024 and 2023, respectively.

Non-elective contributions are made on behalf of eligible staff and partners, provided they remain an employee or partner of the Firm on the last business day of the year for which the contribution is made, unless termination is due to death or disability or employment terminates at or after age 60. All participants are 100% vested.

Poor investment performance by the various investments or self-directed investments selected by the participants may cause their balances to be lower than the amounts contributed to the Plan on their behalf. Participants may change their investment options at any time.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 10%% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Firm contributes a discretionary match of 50% of the first 1.5% of base compensation that a participant contributes to the Plan. The Plan requires a participant to be employed as of year end to be eligible to receive employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, Firm matching contributions, and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Firm's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined annually, is set at the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to 5 years except for a home loan which is 10 years for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions of account balances less than \$1,000 are made upon termination of employment.

Account balances between \$1,000 and \$5,000 are automatically rolled over to an Empower Retirement Account or Empower Brokerage Account Individual Retirement Account if the Plan's participant doesn't request a withdrawal within 80 days of the date of the Notice of Benefits Eligibility letter sent by the trustee upon notification of the Plan participant's termination. In addition, the Plan allows for hardship distributions if certain criteria are met.

Transfers Into or Out of the Plan

From time to time, employees may no longer meet the eligibility requirements of the Plan and become eligible to participant in another qualified plan sponsored by the Firm or vice versa. These employees have their account balances transferred between the Plan and another qualified plan sponsored by the Firm.

In November 16, 2023, the assets of Buckley LLP Profit Sharing and Section 401(k) Plan were merged into the Plan. The total amount of \$96,116,756 is reflected in transfers in from another plan on the statement of changes in net assets available for benefits in 2023.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments Measured at Net Asset Value: Consisting of common-collective trusts, valued at the net asset value ("NAV") of units of a bank collective trust. NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-Directed Brokerage Accounts: Investments include common stocks, interest bearing cash, money market accounts, U.S. government and government agencies obligations, corporate bonds, mutual funds, and exchange-traded funds. Mutual funds, interest bearing cash, common stocks, money market funds, and exchange-traded funds market values are based on quoted market prices. U.S. government and government agencies and corporate bonds are valued based on a model that uses discounted cash flows. Inputs may include interest-rate yield curves, cross-currently-basis index spreads, or country credit-spreads, which are similar to the valued bond in terms of issuer, maturity, and seniority.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Retirement, LLC, the Custodian of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by the custodian, and therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services of the self-directed brokerage account are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Empower Retirement, LLC receives revenue from investment fund service providers for services Empower Retirement, LLC provides to the funds. This revenue is used to offset certain amounts owed to Empower Retirement, LLC for its administrative services to the Plan. If the revenue received by Empower Retirement, LLC from such investment fund service providers exceeds the amount owed for its services, Empower Retirement, LLC remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan sponsor may make a payment to Empower Retirement, LLC for administrative expenses not covered by revenue sharing.

Additionally, the Plan invests in various investments that comprise the self-directed brokerage account, which are managed by an affiliate of Charles Schwab Bank. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Plan adopted a volume submitter plan offered by Orrick, Herrington & Sutcliffe LLP. The volume submitter plan received an IRS Determination Letter, dated November 26, 2013, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the IRS Determination Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, two and one investments represented a concentration of greater than 10% of the Plan's net assets available for benefits, respectively.
