INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of
The McGuire Group 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The McGuire Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following description of The McGuire Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of The McGuire Group, Inc. (the Company) and its wholly owned subsidiaries including Autumn View Health Care Facility, LLC (Autumn View), Autumn Woods Residential Health Care Facility, LLC (Autumn Woods), Brookhaven Health Care Facility, LLC (Brookhaven), Garden Gate Health Care Facility, LLC (Garden Gate), Harris Hill Nursing Facility, LLC (Harris Hill), North Gate Health Care Facility, LLC (North Gate), Seneca Health Care Center, LLC (Seneca), RCA Healthcare Management LLC, RCA Servicer at Gasport, LLC (Gasport), RCA Servicer at Three Rivers, LLC (Three Rivers), RCA Servicer at Allegany, LLC (Allegany), RCA Servicer at Orchard Brooke (Orchard Brooke), RCA Servicer at Aurora Park, LLC (Aurora Park), and RCA Servicer at Westfield, LLC (Westfield), VestraCare, Inc., Susquehanna Nursing and Rehabilitation (Susquehanna), Chautauqua Nursing and Rehabilitation (Chautauqua), Clinton Square Operations d/b/a Bishop Rehabilitation and Nursing (Bishop), and Roscoe Regional Healthcare d/b/a Roscoe Rehabilitation and Nursing (Roscoe), VS Servicer at Ulster, LLC (Ulster), VS Servicer at Beacon, LLC (Beacon), and VS Servicer at Fishkill, LLC (Fishkill), (collectively, the Employers).

Effective February 1, 2023, the Sunset Nursing and Rehabilitation Center Inc. covering all employees of Sunset Nursing and Rehabilitation Center Inc., merged into the Plan. As a result, net assets including notes receivable from participants of \$1,659,231 were transferred to Plan.

All employees who attained 30 days of service and are age 21 or older, and who are not union employees, nonresident aliens with no U.S. source income, leased employees, employees of any controlled group employer that does not affirmatively adopt this Plan, part-time, temporary, and seasonal employees, or contractors are eligible to participate in the Plan. Plan entry dates are the first day of the month on or next following date the eligibility requirements are met.

The Plan is subject to the provisions of ERISA. The 401(k) Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions: Each year, participants may contribute up to maximum amount allowed by law of pretax annual compensation, except highly compensated employees who may only defer up to 5%, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows for Roth elective deferral contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan allows the Employers to make a discretionary employer matching contribution on a payroll basis not to exceed 5% of compensation to all eligible participants. In order for a participant to receive the discretionary employer matching contribution, the employee must fulfill the eligibility requirements. Effective January 1, 2023, the employer discretionary match was suspended and reinstated effective September 3, 2023. For the period September 3, 2023 through March 30, 2024, for employees of the Plan, the Employers contributed 25% based on 1% of the participants eligible compensation, not to exceed 5% of the participants eligible compensation. Effective March 31, 2024 and through the year ending December 31, 2024, for employees of the Plan, the Employers contributed 25% based on 2% of the participants' eligible compensation.

The Plan allows the Employers to make a discretionary nonelective contribution. The discretionary nonelective contribution will be allocated in the same ratio as each participant's compensation bears to the total of such compensation of all eligible participants. In order for a participant to receive the discretionary nonelective contribution, the employee must fulfill the eligibility requirements. During the years ended December 31, 2024 and 2023, the Employers did not make a discretionary nonelective contribution.

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts: Each participant's account is credited with the participant's contribution and any discretionary employer matching contributions, as well as allocations of any employer discretionary nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are 25 percent vested in discretionary matching contributions and nonelective contributions after one year of service, as defined by the Plan, with a 25 percent annual increase each of the next three years.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: On termination of service due to death, disability, retirement, or when a participant ceases to be an employee of the Employers, a participant may elect to receive a lump sum, installment or partial amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum, installment or partial distribution. A participant can also withdraw all or any portion of his or her account in the event of financial hardship. In addition, in-service distributions, without penalty, may be made upon the attainment of age 59 ½.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$65,122 and \$12,777, respectively. These accounts will be used to reduce expenses and future employer contributions. During the year ended December 31, 2024, forfeitures were used to reduce employer contributions by \$43,444 (\$134,141 – 2023).

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Excess Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowed by the IRS and recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants after March 15, 2025. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Payment of Benefits: Benefit are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through, October 14, 2025, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board (FASB) ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash reserve account: Valued at cost plus accrued interest. Cash reserve account is classified as Level 1 investments.

NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These investments are classified as Level 1 investments.

Money market funds: A money market fund is a public investment vehicle valued using \$1 for the NAV and is classified as a Level 1 investment.

Collective investment trusts: The fair value of the collective investment trust (CIT) is determined using the NAV per unit, which is valued daily by the fund manager. The NAV is based on the market prices of the investments held within the CIT, which includes both publicly traded and non-publicly traded securities. CIT's are not publicly traded, however the daily price of the funds are publicly available through the Nasdaq Fund Network. CIT's are classified within Level 2 of the fair value hierarchy.

NOTE 4. GROUP ANNUITY CONTRACT WITH COMPANIES

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica Retirement Solutions Corporation (Transamerica) totaling \$4,454,170 and \$4,550,211 for the years ended December 31, 2024 and 2023. The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica Financial Life Insurance Company (TFLIC) totaling \$107,777 for the year ended December 31, 2024. The Plan did not have a contract with this company for the year ended December 31, 2023. Transamerica and TFLIC maintains the contributions in a general account. The account is credited with interest based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the current six month period and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is obligated to repay the principal and a specified interest rate that is set semi-annually and announced 45 days in advance of the date the new rate becomes effective. There is no minimum interest rate and there is no scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 4. GROUP ANNUITY CONTRACT WITH TRANSAMERICA LIFE INSURANCE COMPANY (CONTINUED)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5. PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by State Street Bank and Trust Company. State Street Bank and Trust Company is the trustee of the Plan and Transamerica is the Plan's recordkeeper. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment administrative services amounted to \$147,290 for the year ended December 31, 2024 (\$130,302 – 2023).

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. TAX STATUS

Effective June 30, 2020, the Plan adopted a volume submitter plan sponsored by Transamerica Retirement Solutions, LLC. The volume submitter plan has received an advisory letter from the IRS regarding the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9. FINANCIAL CERTIFICATION

The following unaudited financial information as of December 31, 2024 and 2023, as well as transactions for the years ended December 31, 2024 and 2023, has been furnished by the Plan Administrator and certified by Transamerica Retirement Solutions, LLC on behalf of State Street Bank and Trust Company and Transamerica Financial Life Insurance Company (TFLIC), the trustee of the Plan. The incorporation of this financial information in the accompanying financial statements and supplemental schedule of assets (held at end of year) is based solely on their certifications, and the information relating to assets as well as transactions has not been audited by independent accountants. In addition, the Plan's trustee has certified the unaudited financial data contained in the supplemental schedule at December 31, 2024.
