Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Flynn's Tire and Automotive Group 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Flynn's Tire and Automotive Group 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Flynn's Tire and Automotive Group 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE A - DESCRIPTION OF PLAN

The following description of Flynn's Tire and Automotive Group 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan, adopted on July 1, 1995, is a defined contribution plan under the provisions of Section 401(a) of the Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility:

All employees of Flynn's Tires of Pennsylvania, Inc., Flynn's of Ohio, Inc., Flynn's of New York, Inc., Flynn's Tires, LLC, Flynn's Tire Wholesale, LLC, and Urra Company, Inc. who have completed a minimum of two consecutive months of service are eligible to make a salary deferral contribution three months after their date of hire. Additionally, employees that have been credited with 1,000 hours of service and have attained one year of service are eligible for employer matching contributions. Employees meeting this employer match requirement are eligible to participate in the Plan on January 1 of the same day of the month completed or in each successive three-month period thereafter.

Contributions:

Participants may make contributions to the Plan up to the maximum percentage allowable not to exceed the limits of Code Section 401(k) of \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans prior to meeting the eligibility requirements for participation in the Plan.

The Plan has an automatic 4% salary deferral feature of eligible compensation, which can be modified by notifying the Company directly. The definition of compensation for purposes of determining salary deferrals and employer discretionary contributions includes all compensation.

The Company may make an annual discretionary contribution to each eligible participant in accordance with the nondiscriminatory formula. Discretionary contributions are determined by multiplying the discretionary contribution by a fraction, the numerator of which is the participant's deferral and the denominator of which is the deferred compensation of all participants eligible to receive such an allocation. The discretionary contribution was \$145,436 and \$148,774 for the years ended December 31, 2024 and 2023, respectively. Additional profit-sharing amounts may be contributed at the discretion of the Company. There were no additional profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts:

Participant accounts are valued on a daily basis based on quoted market prices. Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, forfeitures and plan earnings, and charged with an allocation of administrative expenses as defined by the Plan agreement. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary and profit sharing contributions, and actual earnings thereon is based on years of continuous service. A participant is vested according to the following table:

1	0%
2	25%
3	50%
4	75%
5	100%

Regardless of the vesting schedule, participants shall become fully vested upon attainment of normal retirement age or if a participant terminates employment due to disability or death.

Forfeitures:

Forfeitures shall be used to reduce the Company's discretionary contribution to the Plan. During 2024 and 2023, forfeited nonvested accounts totaled \$4,265 and \$1,084, respectively. Forfeitures are allocated against discretionary matching contributions. Allocated forfeitures totaled \$1,226 and \$782 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, \$4,564 and \$1,226, respectively, remained in the forfeiture account.

Cash and Cash Equivalents:

The Plan considers highly liquid debt instruments purchased with original maturity dates of three months or less to be cash equivalents. Deposits may at times exceed federally insured amounts.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the plan administrator. All installment payments are made through employer payroll deductions with equal installments made each payroll period. The repayment period of principal and interest shall not exceed five years unless the purpose of the note is for the purchase of the principal residence of the participant. The term of repayment for the purchase of a principal residence shall not exceed ten years.

Payment of Benefits:

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Withdrawals:

The value of rollover contributions and transfers and the earnings thereon are available for in-service withdrawals during a plan year. Participants that have reached the Plan's normal retirement age may withdraw the total value of the vested interest held in their account. Hardship withdrawals are permitted in the Plan. A participant may withdraw part of the value of their vested portion and earnings thereon in their account during a plan year.

Administrative Expenses:

Quarterly administrative expenses are charged directly to the individual participant accounts. Participants who take a note from the Plan incur a one-time fee for establishing the note. Participants may elect to pay additional fees for express delivery of any type of distribution. Administrative expenses are paid by the plan sponsor to the extent not paid by the Plan.

Investment Elections:

Each participant may direct their account balance into one or more of the approximate 20 investment options offered by the Plan.

Basis of Accounting:

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with U.S. generally accepted accounting principles. Investments held by a defined contribution plan are required to be reported at fair value.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

SECURE 2.0 Act:

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. The Plan is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2025.

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a description of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Collective Trust Funds Valuation and Inputs:

The share prices reported on the plan summary report for collective trust funds are generally obtained directly from the fund house or other investment provider.

The observable inputs include an attempt to receive share prices from more than one source and performing a systematic comparison of any difference in quoted share prices for the same fund. The difference is resolved by contacting the investment provider directly to ensure the correct share price is recorded. Variance reports are also reviewed, which show the percentage of share price changes from the prior day. The internal pricing analyst and management will review the overall movement of market indices and will apply judgment in determining whether any further research with investment providers will be pursued for share price variances from the prior day. Daily, after all research and validation has been performed, and variances have been resolved, share prices are closed and loaded to the recordkeeping system.

The unobservable inputs exist due to the various unique investments that may be allowed in a collective trust fund, and the various redemption restrictions that may be imposed. A plan sponsor should individually review the prospectus and operations of each of these types of investment options.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payments of Benefits:

Benefit payments to participants are recorded when paid.

Subsequent Events:

Management evaluated all activity of the Plan through October 14, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

NOTE C - INFORMATION CERTIFIED BY THE CUSTODIAN

In accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to restrict the scope of the auditor's examination with regard to statements or information prepared and certified by the custodian. Mid Atlantic Trust Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS

FASB ASC 820 Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs). - Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted market prices of shares held by the Plan at year-end.

Common collective trust funds: Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED PARTY TRANSACTIONS AND TRANSACTIONS WITH PARTIES-IN-INTEREST

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$86,467 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The plan sponsor pay directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

NOTE F - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE G - INCOME TAX STATUS

On June 30, 2020, the Internal Revenue Service stated in a determination letter that the volume submitter adopted by the Plan on May 21, 2019, as then designed, qualifies under Section 401(a) of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

NOTE J - ADP TEST CORRECTION

During the Plan year ended December 31, 2024, the Plan failed to satisfy the Actual Deferral Percentage (ADP) test as required by Internal Revenue Code Section 401(k). To correct this failure, the Plan refunded excess contributions totaling \$55,174 on March 13, 2025, to certain highly compensated employees to correct the ADP test failure for the Plan year ended December 31, 2024.

NOTE K - PROHIBITED TRANSACTIONS

During the Plan year ended December 31, 2024, the employer failed to remit certain employer contributions to the Plan within the time frame required by Department of Labor regulations due to an oversight of the Plan Administrator, AMI Benefit Plan Administrators, Inc. The total amount of late contributions was \$27,873. These contributions were remitted to the Plan on January 3, 2025. In connection with the late remittance, the employer restored lost earnings to the Plan in the amount of \$211. The employer is a party-in-interest as defined by ERISA. The late remittance of contributions constitutes a prohibited transaction under ERISA and the Internal Revenue Code.
