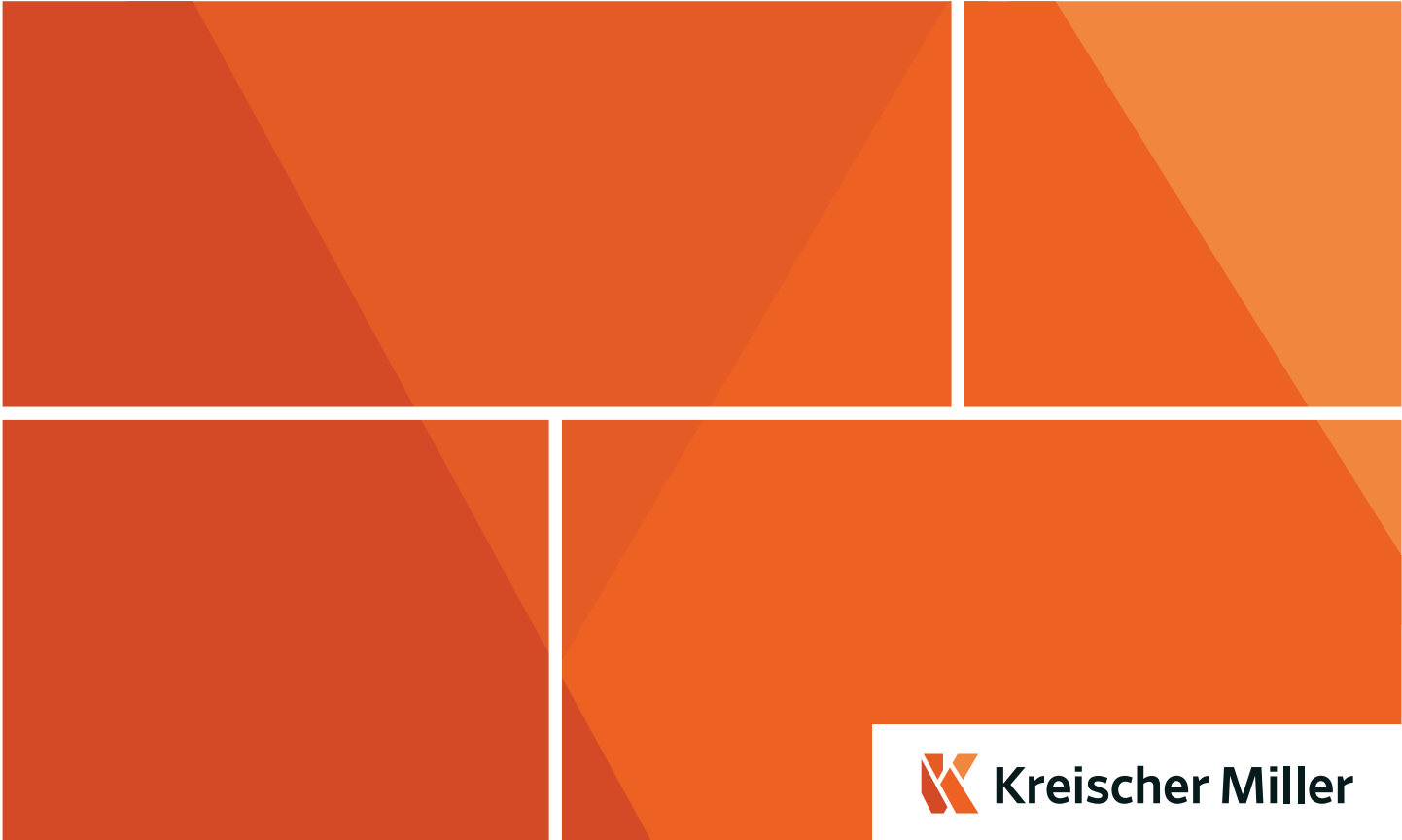

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Phoenix Services, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

(1) Description of Plan

Phoenix Services, LLC 401(k) Plan (the Plan) provides only general information for employees of Phoenix Services, LLC and affiliated employers (the Company). Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for the benefit of substantially all eligible employees of the Company who are not covered by a collective bargaining agreement with the Company and have completed three months of service and attained 21 years of age. Effective September 1, 2023, employees who have attained the age of 18 are eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

Employee Contributions

Each Plan year, participants may elect to make voluntary salary reduction contributions up to 100% of eligible compensation to their tax-deferred account or after-tax account subject to certain statutory Internal Revenue Service (IRS) limitations. Participants who are age 50 or older at the end of the calendar year may make an additional pretax or after-tax contribution subject to IRS limitations. The participant may elect to rollover contributions that were received from another qualified plan. Participants may change their deferral rate at any time, and the change will take effect on the first day of the following pay period. Participants direct the investment of their contributions into various investment options offered by the Plan. Unless an eligible employee requests not to participate in the Plan, all eligible employees are automatically enrolled in the Plan with 5% of their eligible compensation.

Employer Contributions

The Plan has a provision for a safe harbor employer matching contribution equal to 100 percent of the participant's elective deferrals that are not in excess of 5% of the participant's eligible compensation, as defined by the Plan document. Profit sharing contributions may be permitted at the discretion of the Company. These contributions, if made, are allocated to all eligible participants based on the ratio of the participant's compensation to the total compensation of all eligible participants. The Company may also make qualified matching contributions determined by the Company in its sole discretion, to satisfy certain plan provisions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and the Company's matching contributions plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts plus actual earnings thereon is based in the following:

Years of Service	Vested Percentage
1 year	25%
2 years	50%
3 years	75%
4 years or more	100%

Notes receivable from Participants

Effective September 1, 2023, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at fixed rate ranging from 8.75% to 9.50%. Principal and interest are paid ratably through payroll deductions. Loan terms shall not exceed five years except for principal residence.

Payment of Benefits

Upon termination of employment due to death, disability, or retirement, a participant (or participant's beneficiary in the event of death) may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum, substantially equal installments, or a direct rollover to another qualified retirement plan. In-service withdrawals of a participant's vested account balance are permitted for participants who have obtained the age of 59 ½ or normal retirement age. Other in-service withdrawals may be permitted in accordance with the Plan documents. Hardship withdrawals are permitted by the Plan where the participant can demonstrate an immediate and heavy financial need, as defined by the Plan agreement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,489 and \$48,144, respectively. These accounts may be used to reduce future Company contributions and/or pay plan expenses. During 2024, forfeited nonvested accounts were used to reduce employer matching contributions by \$23,111 and pay plan expenses of \$3,821.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenue and expenses during the reporting periods. Actual results could differ from those estimates.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an annual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to certain participant transactions and to the administration of notes receivable from participants are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

(3) Financial Information Certified by the Trustees

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Empower Trust Company LLC (Empower), the qualified institution.

(4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at NAV at year-end, based on information provided by the trustee and using the audited financial statements of the trust at year-end. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is used as a practical expedient to estimate fair value.

(5) Investment Contract

The Plan has an investment in the MetLife GAC-25053 Class 0 Fund (the "Fund"), which is a common collective trust fund. The Fund generally invests in bonds with short-to-intermediate term maturities, and insurance contracts which aim to provide price protection. In addition, the Fund maintains a wrapper contract issued by insurance companies and other financial institutions designed to allow the portfolio to maintain a constant NAV and to protect the portfolio in extreme circumstances. Participants may generally redeem units on a daily basis at NAV. NAV represents contributions made to the collective trust fund plus earning less participant withdrawals and administrative expenses.

Certain events may limit the ability of the Plan to transact at NAV with the Fund. Such events include Plan sponsor events that cause a significant withdrawal from the Plan, such as a Plan level liquidation, and the availability of uncommitted cash and liquid investments available on the requested redemption date. The plan administrator believes that no events are probable of occurring that would limit the Plan's ability to transact at NAV with participants.

(6) Related Party Transactions and Party-In-Interest Transactions

The Plan's investments include investments managed by Empower, the Trustee, as defined by the Plan and, therefore, those transactions are considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their account balances.

(8) Tax Status

The Plan is a volume submitter plan sponsored by Pentegra Services, Inc. The IRS had determined and informed Pentegra Services, Inc. by a letter dated June 30, 2020 that the volume submitter plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and , therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

(8) Tax Status, Continued

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(10) Prohibited Transactions

During 2024, participant's contributions from multiple payrolls were not remitted to the Plan within the time frame specified by the Department of Labor's Rules and Regulations, as well as a multiple participants' contributions being withheld but not remitted to the Plan, thus constituting nonexempt prohibited transactions between the Plan and the Company. The Company is in the process of calculating the missed earnings on the \$134,321 delinquent contribution and making the appropriate correction during 2025.

During 2023, one participant's loan repayments and one participant's contribution were not remitted to the Plan within the time frame specified by the Department of Labor's Rules and Regulations, thus constituting nonexempt prohibited transactions between the Plan and the Company. The Company is in the process of calculating the missed earnings on the \$1,240 delinquent contribution and making the appropriate correction during 2025.
