INDEPENDENT AUDITOR'S REPORT

To the Trustees of
Teamsters Managed Health Care Trust Fund:

Opinion

We have audited the financial statements of Teamsters Managed Health Care Trust Fund, which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of Teamsters Managed Health Care Trust Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of Teamsters Managed Health Care Trust Fund (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Cash

Cash consists of monies held in checking accounts and highly liquid accounts without significant withdrawal restrictions.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations or some other pricing method using unobservable inputs.

Inputs and Valuation Methods

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes are presented below.

Money Market Accounts: The money market accounts are carried at cost, which approximates fair value (Level 2).

Mutual Funds: The fair value of mutual funds is based on quoted market prices in active markets (Level 1).

Valuation Methods, Consistency

The valuation techniques used in the accompanying financial statements have been consistently applied.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Employer contributions due and not paid prior to year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Benefit Obligations

The amount currently payable for insurance premiums was based upon the actual premiums due for December and prior coverage but unpaid at December 31. Accumulated eligibility credits were based upon the premiums due for January coverage based on work performed during December. Coverage for retired participants is provided only when the full contribution amount is received each month by the Plan. The Plan has no future obligation to provide benefits to retirees; therefore, there are no post-retirement benefit obligations presented on the financial statements.

Cost of Benefits

Benefits are recorded when paid.

Other Receivable

The Plan has amounts due under the American Rescue Plan Act of 2021 - Consolidated Omnibus Budget Reconciliation Act ("COBRA") Premium Assistance program. This program provided immediate relief to eligible participants impacted by the COVID-19 crisis for the covering period from April 1, 2021 to September 30, 2021. Outstanding balance owed to the Plan by the Internal Revenue Service as of December 31, 2024, is \$182,657.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investments. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The Plan was established under the terms of an Agreement and Declaration of Trust dated May 21, 1991, between Industrial Employers and Distributors Association, Beard Affiliates, LLC, Teamsters Local 853 and Teamsters Local 860 for the purpose of providing health and welfare benefits for eligible individuals and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility is granted in a month based on work performed in the prior month.

Benefits of the Plan include medical, life, dental, chiropractic, substance abuse, accidental death and dismemberment, prescription drug and vision care. The Plan has a group insurance contract with Prudential Insurance Company of America to provide life insurance and accidental death and dismemberment benefits. Participants may elect medical and prescription drug coverage through Kaiser Foundation Health Plan or United Healthcare; vision coverage through Vision Service Plan; dental coverage through Delta Dental, United Healthcare Dental or Liberty Dental Plan; and chiropractic benefits through Physmetrics, LLC. Substance abuse assistance is provided through Teamsters Assistance Program.

The Plan also provides self-pay COBRA and retiree coverage for eligible participants. Retirees pay for the full cost of their coverage. The Board of Trustees reserves the right to increase the self-pay contribution rates or to reduce benefits for retirees. Retiree contributions constituted 100% of the estimated cost of providing post-retirement benefits in the current and prior year.

Participants should refer to Plan booklets for more complete benefit information and eligibility requirements.

3. PRIORITIES UPON TERMINATION

It is the intent of the trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the trustees. In the event of termination, the trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated October 22, 1991, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and the related trust is tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by employer and retiree contributions and by contributions from members electing COBRA coverage. Contribution rates are established by the Board of Trustees based upon recommendations by the Plan's consultant and within the limits provided in the collective bargaining agreements. Substantially all employer contributions are from employers in the production, trucking and warehousing industry located in Northern California.

7. RELATED PARTY TRANSACTIONS

Employer contributions for both this Plan and the Teamsters Managed Annuity Trust Fund (the "Annuity Plan"), an affiliated plan, are deposited in a lockbox bank account sponsored by the Teamsters Managed Health Care Trust Fund. The amount due to the Annuity Plan is calculated and transferred monthly.

In addition, this Plan is jointly administered with the Teamsters Managed Annuity Trust Fund. Certain joint expenses are paid by this Plan, a portion of which is reimbursed by the Annuity Plan. As of December 31, 2024 and 2023, the Plan has no receivable from Annuity Plan, respectively. For the year ended Dember 31, 2024 and 2023, the amount payable by the Plan is \$197 and \$0, respectively.

8. CONCENTRATION OF CASH

The Plan maintains its cash at one financial institutions. The balance is insured by the Federal Deposit Insurance Corporation for up to \$250,000 per institution. Cash balances may at times exceed the insured deposit limits. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Company's financial condition, results of operations and cash flows.
