### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Diagnostic Radiology & Imaging 401(k) Profit Sharing Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### (1) Description of Plan

The following description of Diagnostic Radiology & Imaging ("Company") 401(k) Profit Sharing Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- (a) **General** - The Plan is a qualified defined contribution plan covering all employees of the Company who are at least 19 years of age with six months of eligible service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). All investments are participant directed.
- (b) **Contributions** - Participants may contribute to the Plan, through payroll deduction, amounts up to 100% of their annual earnings, subject to certain limitations. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Company funds a safe harbor match contribution of 4% of participant's compensation. The Company also funds, as a regular employer discretionary contribution, a maximum 2% of participant's compensation. Participants must complete one year of service to be eligible for employer contributions.

Each year the Company may make additional discretionary contributions to the Plan. No additional discretionary contributions were recorded for 2024 or 2023.

- (c) **Participant Accounts** - Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions, Plan earnings (losses), and administrative fees. Allocations are based on participant earnings or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
- (d) **Vesting** - Participants are immediately vested with respect to their elective deferral contributions and safe harbor contributions and actual earnings thereon. Vesting in regular employer match and discretionary contributions and actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years and vests an additional 20% every year thereafter, until reaching 100% after six years of credited service.
- (e) **Forfeitures** - Forfeitures of employer discretionary contributions are used to reduce future employer contributions. During 2024 and 2023, forfeitures were used to reduce employer contributions by \$0 and \$16,691, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,919 and \$5,714, respectively.
- (f) **Payment of Benefits** - In the event of termination of employment, disability, death or retirement (age 60), a participant may elect to receive benefits either by a lump sum distribution or periodic installments over a period of time as described in the Plan Agreement. Distributions of vested account balances of \$5,000 or less will generally be made in a single sum payment. Hardship distributions of participant's contributions are permitted.
- (g) **Plan Termination** - The Company expects to continue the Plan indefinitely, but reserves the right to terminate the Plan in whole or in part at any time upon giving written notice to all parties concerned subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

- (h) **Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.
- (i) **Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or a maximum equal to 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan funds. Loan terms are typically based on a five-year term and bear interest at the then current prime rate (7.50% at December 31, 2024) plus 1%. The loans must be adequately secured with at least 50% of the present value of the participant's vested interest in the Plan. Principal and interest are paid through salary reductions each pay period.

### (2) **Summary of Accounting Policies**

- (a) **Basis of Accounting** - The financial statements are prepared using the accrual method of accounting.
- (b) **Management Estimates** - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- (c) **Investment Valuation** - The Plan's mutual funds are valued at quoted market prices as reported by the custodian.  
  
Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment changes include the Plan's gains and losses on investments bought and sold as well as held during the year.
- (d) **Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement.

### (3) **Fair Value Measurements**

FASB ASC 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable and Level 3 inputs have the lowest priority and are unobservable inputs of market activity. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- *Common collective trust funds:* Valued at the NAV of units of a financial institution collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

#### (4) Tax Status

The Plan is based on a Loren D. Stark Company prototype defined contribution plan. Loren D. Stark Company obtained an opinion letter dated March 31, 2014 in which the Internal Revenue Service stated that the prototype plan is designed in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving this letter. However, the Plan administrator, trustees and tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan, by expiration of the statute of limitations, is generally no longer subject to examinations by tax authorities for a period of up to three years after the date on which those returns are filed.

#### (5) Information Certified by the Custodian

The investment assets and investment income information in the statements of net assets available for benefits and changes in net assets available for benefits, as well as the Schedule, were summarized from information supplied and certified by the custodian, Empower Annuity Insurance Company of America for the year 2024 and 2023. The information obtained from the custodians was not audited by independent public accountants as permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### (6) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### (7) Prohibited Transactions

During the 2023 Plan year, \$17,021 of participant contributions were not timely remitted to the Plan in accordance with the DOL's regulations, resulting in lost earnings of \$201. The third-party administrator reimbursed the lost earnings back to the Plan in 2024.
