INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Retirement Plan of Saratoga Hospital

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Retirement Plan of Saratoga Hospital, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Retirement Plan of Saratoga Hospital's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Retirement Plan of Saratoga Hospital's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Retirement Plan of Saratoga Hospital's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplementals of Schedule H, Line 4a – Schedule of Delinquent Participant Contributions and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 — DESCRIPTION OF THE PLAN

The following brief description of the Retirement Plan of Saratoga Hospital (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General Information

The Plan is an employer-sponsored defined contribution plan established in 1989, and subsequently amended, under Internal Revenue Code (“IRC”) Section 403(b) and is designed to provide retirement benefits to eligible employees of Saratoga Hospital (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

All employees of Saratoga Hospital are eligible to participate in the Plan upon their date of hire.

Contributions

Participants may make voluntary pre-tax and Roth contributions subject to certain limitations under the terms of the Plan and the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an autoenrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation with an annual increase of 1% up to a maximum of 8%, and their contributions invested in designated target date fund until changed by the participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

For the purposes of employer contributions, participants are eligible to receive such contributions upon their date of hire. Prior to January 1, 2022, employees were required to attain 21 years of age to be eligible for employer contributions. Employer contributions to the Plan consist of two components, a discretionary matching contribution and a discretionary nonelective contribution. Employees who work a minimum of 975 hours in the plan year, and who defer a portion of their eligible annual compensation to the Plan, are eligible to receive an employer matching contribution. Employees who work a minimum of 975 hours during the plan year are eligible to receive the nonelective employer contribution regardless of whether they contribute to the Plan. During 2024 and 2023, the discretionary nonelective contribution was 2.75% of eligible gross annual compensation for each eligible employee. The matching contribution is based on eligible years of service in the Plan. For 2024 and 2023, the following percentages of eligible gross annual compensation were used to determine the matching contribution.

Participant Accounts

Contributions made by the participants and the employer are reported to the Plan’s recordkeeper and are allocated to the respective participant’s account. Each participant’s account is credited with the participant’s contributions, the employer’s contributions, and an allocation of investment earnings (losses) and charged with an allocation of any administrative expenses. Allocations of investment earnings (losses) and administrative expenses are based on a participant’s account balance relative to the total account balances of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participant contributions – Participants are always 100% vested in their own contributions to the Plan and earnings thereon.

Employees become vested in the employer matching and non-elective contributions (and earnings thereon) based on the years of service in which they met the eligibility requirements described in Contributions section above, in accordance with the following schedule:

5	100%

In the event that a participant dies or is permanently disabled prior to attaining the Plan’s Normal Retirement Age (“NRA”), contributions credited to the participant’s account become fully vested. Employees who achieve NRA (age 59½) are fully vested in all employer contributions.

Payment of Benefits

Upon termination of service for retirement, death or disability, participants with a vested account balance less than \$5,000 may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For terminated participants with a vested account balance greater than \$5,000, participants may elect to receive either a single lump-sum payment, installment payments, annuities, or partial withdrawals. If no action is taken by a participant, those with a vested account balance less than \$5,000 but greater than \$1,000 will have their vested account balance automatically rolled over to an IRA in accordance with the Plan’s Automatic Rollover provision. Participants with balances less than \$1,000 will receive an involuntary cash out of their account balances.

In-service distributions may be made from the Plan by a participant that has attained normal retirement age, as defined by the Plan and these distributions may be made from a participant’s vested account balance. Withdrawals from a participant’s salary deferral account (excluding earnings) may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan.

Forfeitures

At December 31, 2024, and 2023, unapplied forfeited non-vested balances were \$761,954 and \$264,747, respectively. These accounts will be used to reduce administrative expenses or to reduce employer matching or nonelective contributions. Forfeitures used during the year ended December 31, 2024, and to offset employer contributions were approximately \$277,500. Forfeitures held in plan assets at December 31, 2024, and 2023, are presented as unallocated cash balances in the statements of net assets available for benefits.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and change therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. (See Note 5.)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by Saratoga Hospital and are therefore excluded from these financial statements. The administrative expenses for participant account management fees are paid through reductions to participant account balances and are reported in the accompanying financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective September 15, 2025, all Plan assets were transferred from State Street Bank and Trust Company to Empower Trust Company, LLC.

NOTE 3 — INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, State Street Bank and Trust Company, the custodian of the Plan, has furnished certain financial information to the plan administrator and certified as to its completeness and accuracy. These certifications are as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and include investment information related to unallocated cash balances, investments, interest and dividend income and net realized and unrealized appreciation (depreciation) on fair value of investments that is included in the Plan's financial statements and supplemental schedule of assets held at end of year.

NOTE 4 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 inputs consist of unadjusted quoted prices in active markets, that the Plan has the ability to access, for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices of identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 were not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and reported as Level 1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 — METLIFE ANNUITY CONTRACT

The Stable Value Fund is a group annuity contract (“Contract”) issued by Metropolitan Life Insurance Company (“MetLife”) and is backed by assets invested in a separate MetLife account (pooled separate account). The Contract is reported at contract value, which equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. MetLife guarantees the Contract will pay participant-initiated withdrawals up to the full amount of the Plan’s guaranteed Contract value, as long as the Contract remains active. The Contract provides a fixed interest rate for a fixed period that applies to the entire guaranteed value. Interest is credited to the Contract at interest rates that reflect the performance of the underlying separate account, net of fees to MetLife. The crediting rate resets annually on January 1.

MetLife resets the rate by amortizing the difference between the market value of the separate account portfolio and the guaranteed value over the weighted average duration of the Fund’s investments.

Participants will receive the principal and accrued earnings credited to their accounts on withdrawal for allowed events. These events include transfers to other Plan investment options, and payments because of retirement, termination of employment, disability, death and in-service withdrawals as permitted by the Plan.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on MetLife’s ability to meet its financial obligations. MetLife’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with MetLife. Examples of such events include the following:

1. The Plan’s failure to qualify under IRC Section 403(b)
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan’s prohibition on competing investments options
5. Bankruptcy

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with MetLife. In addition, certain events allow MetLife to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

NOTE 6 — TAX STATUS

The IRS has determined and informed the Plan by a letter dated March 31, 2017, that the Volume Submitter 403(b) Plan adopted by the Plan and related trust, as then designed, are in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 — PLAN TERMINATION

Saratoga Hospital intends to continue the Plan indefinitely; however, the Plan is voluntary on the part of Saratoga Hospital and Saratoga Hospital reserves the right to modify or terminate the Plan at any time. In the event of Plan termination, the account of each participant shall become fully vested in their employer contributions and distributed in accordance with the Plan document.

NOTE 8 — PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are funds managed by State Street Bank and Trust Company at December 31, 2024, and 2023, the custodian for the periods then ended, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA.

NOTE 9 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The Plan is subject to various legal proceedings and claims that arise in the ordinary course of administering the Plan. While it is not possible to predict the outcome of these matters with certainty, it is not expected that the results of any of these actions would have a material adverse effect on the Plan.

NOTE 10 — DELINQUENT PARTICIPANT CONTRIBUTIONS

Saratoga Hospital did not timely remit certain participant contributions totaling \$641,481 during the year ended December 31, 2023. This is deemed to be a prohibited transaction in accordance with ERISA and the IRC. Saratoga Hospital filed a correction under the IRS Voluntary Correction Program in 2024 and as of October 10, 2025, is pending a response. During 2024, Saratoga Hospital did calculate lost earnings on the delinquent remittances and made the appropriate corrective contributions.
