NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Cortese Dodge Inc. 401(k) Profit Sharing Plan and Trust (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Cortese Chrysler Jeep Dodge, Inc. (the Company). Cortese Ford Lincoln and Cortese Imports Inc. are companies under common ownership whose employees are also eligible to participate in The Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

Effective July 2023, Pentegra Services, Inc. is the Plan administrator. Prior to July 2023, Northeast Retirement Services, Inc. was the Plan administrator. Empower Trust Company, LLC (formerly Great-West Trust Company, LLC (Great-West)) and Empower Life & Annuity Insurance Company of New York are the trustees of the Plan’s assets. Empower Retirement (Empower) is the Plan’s recordkeeper.

Eligibility

Generally, all employees who have completed eleven months of service, as defined in the Plan document, and have attained 21 years of age are eligible to participate in the plan on the date of employment. An employee’s entry date will coincide with the first day of the Plan year quarter following the date they satisfy the eligibility requirements.

Contributions

Each participant may elect to contribute up to 100% of his or her eligible compensation subject to the limitations set by the Internal Revenue Code (\$23,000 in 2024 and \$22,500 in 2023) as a contribution to the Plan. Participants who are age 50 or older before the end of the plan year are allowed to make an additional “catch-up” contribution. This contribution was limited to \$7,500 in both years 2024 and 2023. In addition, each participant may contribute rollover contributions received in a lump sum from another qualified defined contribution or defined benefit retirement plan.

The Company provides an annual matching contribution of 50% of employee deferrals, up to a maximum of 6% of the eligible participant’s compensation. The Company matching contributions are allocated to participants’ accounts on an annual basis. The Plan also allows for discretionary profit-sharing contributions, as determined by the Company on an annual basis. No profit-sharing contributions were made in 2024 and 2023.

Participant Accounts

Participants direct the investment of their accounts into various investment options offered by the Plan. Each participant’s account is credited with the participant’s contributions, employer matching contributions, and actual earnings and losses thereon. Investment income and loss and expenses are allocated to the participant’s account based on the ratio of the account balance of the individual participant to the aggregate of account balances of all participants in the fund within the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. DESCRIPTION OF PLAN (Continued)

Payment of Benefits

Upon termination due to disability, death or retirement, or separation from service with the Company, a participant may elect to receive a lump sum payment, installment payments, or to have their account rolled over to another qualifying investment. For in-service payment of benefits after a participant has attained 59 ½ years of age, a participant may elect to receive any portion or all of his or her account as a lump-sum distribution.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted under certain circumstances.

Vesting

All participants are immediately vested in their contributions plus actual earnings and losses thereon. Vesting in employer matching contributions plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after one year, 40% vested after two years, and 100% vested after three years of credited service.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company. Distribution and loan fees are charged directly to the participants for the transactions and are paid out of the proceeds of the distribution or loan. Other administrative expenses paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Notes Receivable from Participants

Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at prevailing rates. Principal and interest are paid through payroll deductions.

Forfeitures

Forfeitures of non-vested account balances may be used to pay administrative expenses or reduce nonelective contributions. At December 31, 2024 and 2023 there were \$2,052 and \$2,757 forfeited funds on hand, respectively. During the Plan year ended December 31, 2024, the Company used \$1,217 of forfeitures to reduce employer contributions and used \$1,536 to pay for expenses of the Plan. No forfeitures were used to reduce company contributions or administrative expenses during the plan year ended December 31, 2023.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

2. SIGNIFICANT ACCOUNTING POLICIES (Continued)

Valuation of Investments

Investments held by a defined-contribution plan are required to be reported at fair value or net asset value (NAV) as a practical expedient for fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on assets bought and sold as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to participant contributions.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the accompanying financial statements.

3. FINANCIAL CERTIFICATION

4. FAIR VALUE OF FINANCIAL INSTRUMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 (ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan have the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. FAIR VALUE OF FINANCIAL INSTRUMENTS (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at fair value based on quoted market prices in active markets.

Fixed annuity: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The fixed annuity is benefit responsive for participant-initiated transactions. However, there is a provision that prevents the immediate and full payout of the contract value for plan-initiated transactions, therefore it is not deemed to be fully benefit responsive.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. EXCESS CONTRIBUTIONS PAYABLE

Contributions were reduced for excess employer and participant contributions of \$56,068 for the year ended December 31, 2023. Excess employee contributions will be returned to the participant, while excess employer contributions will be applied to future employer contributions or Plan administrative expenses. For the year ended December 31, 2024, no contributions were reduced for excess employer and participant contributions.

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
