- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Nasdaq, Inc. 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following description of Nasdaq, Inc. 401(k) Savings Plan (the “Plan”) provides general information only. Participants should refer to the summary plan description and Plan Document for more complete information.

General

The Plan is a defined contribution plan established to provide a 401(k)-benefit program for employees of Nasdaq, Inc., and related participating employers (collectively, the “Company”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”).

Plan Merger

The trustees of the Plan and the Nasdaq, Inc. Pension and 401(k) Committee approved an amendment to merge the Verafin USA 401(k) Plan (“Verafin”) into the Plan. The merger was effective January 1, 2024 and all assets of Verafin were transferred into the Plan.

The trustees of the Plan and the Nasdaq, Inc. 401(k) Committee approved an amendment to merge the Adenza 401k Plan (“Adenza”) into the Plan. The merger was effective January 1, 2025. On December 31, 2024, the PIMCO Stable Income Fund was transferred into the Plan in the amount of \$1,214,590. The remaining assets were transferred in January 2025.

Eligibility

Regular full-time employees scheduled to work at least 20 hours per week on a regular basis and for an indefinite period are eligible to participate in the Plan upon their date of hire. Regular part-time employees, as defined, are eligible to participate in the Plan on the date following the completion of one year of employment with at least 1,000 hours of service, as defined. Temporary, seasonal, or intern employees, as defined, are eligible to participate in the Plan on the date following the completion of a two-year period of employment, in which each year the employee completed at least 1,000 hours of service, as defined. closest to the Plan’s entry dates and upon the attainment of 18 years of age.

Participants Contributions

The Plan provides eligible employees with an opportunity to make elective salary deferral contributions to the Plan, subject to the limitations of the Internal Revenue Code (“IRC”).

Subject to Internal Revenue Service (“IRS”) restrictions, employees can contribute, on a pre-tax and after-tax combined basis, between 1% and 50% of base salary. The Plan allows participants who are age 50 or older at the end of the Plan year to make annual catch-up contributions.

The Plan also allows participants to defer funds as a “Roth 401(k) deferral.” These deferrals are subject to federal and state income taxes and the maximum allowable contribution is \$23,000 combined between both the Roth and the pre-tax deferral.

Participants may also make rollover contributions from other qualified plans if certain criteria are met, as outlined in the Plan Document.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a common collective trust, and self-directed brokerage options as investment options for participants.

Participants are eligible to receive the employer match immediately upon participation in the Plan. The basic match is 100% eligible contributions, not to exceed 6% of eligible compensation, as defined.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 12%.

Vesting

Participants are fully vested in their own contributions immediately and are fully vested in the Company's employer matching contributions and actual earnings thereon.

Participant Accounts

Each participant's account is credited with their participant contributions, employer contributions, and earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Note Receivable from Participants

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. The interest rate is set periodically to be in line with current market rates for similar types of loans. Loan terms range from six months to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended to 10 years. Participants are allowed one loan at any given time. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service or disability, a participant may receive a lump-sum amount equal to the value of his or her account or may request other partial distribution amounts from time to time. Participants may choose to remain in the Plan until no later than April 1 following the calendar year in which the participant reaches age 70 ½. Upon death, the participant's account will be distributed to the designated beneficiary as soon as administratively possible.

Terminated employees have 60 days to decide as to whether they would like to roll their funds into another qualified plan or request for distribution all or any portion of the participant's individual account. If an election is not made and the employee's account balance is equal to or less than \$1,000, a lump-sum payment is automatically made. If the employee's account balance is greater than \$1,000, the employee can keep funds in the Plan until a request for distribution is made.

Additionally, the Plan allows for hardship distributions and in-service withdrawals when a participant reaches age 59 ½. Distributions to participants are recorded when paid.

During the year ended December 31, 2020, the Plan adopted the distribution provisions of the *Coronavirus Aid, Relief, and Economic Security Act* ("CARES Act"). A CARES Act distribution allows certain eligible participants to take a coronavirus related distribution up to \$100,000 from the Plan retroactive to January 1, 2020 and through December 30, 2020. The Plan has not been formally amended to reflect these provisions. Plan amendments related to coronavirus related distributions must be adopted by December 31, 2025.

In-Service Roth Conversions

Participants may make in-service Roth conversion elections with respect to all or a portion of their eligible convertible account balance. Such conversion to Roth status consists of a taxable deemed in-service distribution for the portion of the participant's eligible convertible account, which is then transferred as a direct rollover to the participant's Roth Conversion account and held thereunder, subject to the terms of the Plan.

Effective January 1, 2022, the Plan was amended to allow participants to convert to Roth status their traditional after-tax participant contributions. The amendment adds provisions which authorize the participant to make a standing election to automatically convert after-tax participant contributions to Roth status on an ongoing basis after they are made. This can be done as frequently as every pay period.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Common stocks and U.S. government securities are valued at the closing price reported on the active market on which the individual securities are traded. Corporate bonds are valued on the basis of yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less a discount. If a quoted market price for unrestricted common stock of the issuer is not available, restricted common stocks are valued at a multiple of current earnings consistent with multiples of similar companies based on current market prices. Mutual funds are valued at the net asset value ("NAV") of shares held by the Plan at year-end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, as the loans are secured by the balance in the participant's account. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses consist of fees for record-keeping, investment management, advisory and audit services. The Company may, at its discretion, pay the expenses incidental to administering the Plan. In the event that the Company does not pay the Plan expenses, the expenses shall be paid by the Plan.

Subsequent Events

Management evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Revision

During the year ended December 31, 2024, the Company identified an error in previously issued financial statements related to the fair value hierarchy disclosure of their investments in common collective trusts (See Note 4 for fair value hierarchy). Common collective trusts were incorrectly included as level 1 investments in the fair value hierarchy instead of at net asset value. As a result, the Company has revised its financial statement disclosures for the prior period, with no change to the value of the investments recorded at fair value for the period.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company ("Vanguard"), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Unadjusted quoted prices in active markets for identical assets.

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar; quoted prices for similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.

Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, except as disclosed in Note 2.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant Directed Brokerage Option: Consists of equities, mutual funds, and money market funds. Equities are valued on the basis of readily determinable market prices. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds are open-ended funds that are registered with the Securities and Exchange Commission and deemed to be actively traded. These funds are required to publish their daily NAV and to transact at that price. The money market fund is valued at the closing price reported by the fund sponsor from an actively traded exchange.

Common Collective Trust: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain investment contracts, and other securities. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Vanguard. Vanguard is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$459,029 of record-keeping fees to Vanguard during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer reserves the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The IRS has determined and informed the Company by a letter dated February 3, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended and restated since the IRS made its determination, to reflect recently revised Internal Revenue Service regulations. Although the Plan has been restated since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax exempt.

The Financial Accounting Standards Board has issued a standard regarding the accounting and recognition of income tax positions taken or expected to be taken by the Plan. The Plan Administrator assesses the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Such securities are subject to various risks that affect the value of the funds. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities it is at least reasonably possible that the changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
