Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Monnig Global 401(k) Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Monnig Global 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General: The Plan is a safe harbor defined contribution plan covering employees of Monnig Global and certain affiliated companies (the Company). The Plan was established July 1, 1983, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees who have completed two months of service and have attained the age of 18 are eligible to participate in the Plan. Union employees and non-resident aliens are not eligible to participate in the Plan.

Contributions: Participants may contribute up to 92% of pre-tax or post-tax annual compensation, as defined in the Plan, not to exceed maximum amounts specified by the Internal Revenue Service (IRS), in accordance with a participant salary deferral agreement. Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$7,500 for 2024 and 2023, under certain conditions. Participants may also contribute amounts representing rollover distributions from other qualified plans. During the year ended December 31, 2023, the Company was required to make a safe harbor matching contribution equal to 100% of each participant's deferral contributions up to 4% of the participant's salary. Effective January 1, 2024, the Plan was amended to increase the required safe harbor matching contribution to 100% of each participant's deferral contributions up to 5% of the participant's salary. Additional employer profit sharing amounts may be contributed at the discretion of the Company. There were no additional discretionary profit sharing contributions during 2024 and 2023. Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's contributions, Company contributions, the participant's rollover contributions from other qualified benefit plans, and an allocation of Plan earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are automatically 100% vested in both their elective salary deferrals and the Company's safe harbor contributions. Participants vest in Company discretionary contributions at a rate of 20% after two years of service and in 20% increments each subsequent year with full vesting in Company discretionary contributions occurring after six years of service. A participant is considered to have one year of service for each one-year period in which he or she has worked 1,000 hours or more.

Participants become automatically 100% vested in Company discretionary contributions upon attaining normal retirement age, total disability, or death.

Forfeitures: Forfeitures may be used to pay Plan expenses or used to reduce Company contributions. During the years ended December 31, 2024 and 2023, no forfeitures were used to pay Plan expenses or to reduce Company contributions. At December 31, 2024 and 2023, forfeited nonvested amounts available to be used to pay future Plan expenses or to reduce future Company contributions were \$41,168 and \$16,573, respectively.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are payable ratably through payroll deductions.

Distribution of benefits: Distributions to Plan participants are generally made to participants after the participant's termination from employment. A participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, a partial payment, an annuity, or installment payments.

Administration: Paychex Retirement Services was the Plan's third-party administrator (TPA) and record-keeper for participant accounts until February 5, 2023. Mid Atlantic Trust Company (MATC) was the Plan's custodian through that date. Effective February 6, 2023, Fidelity Management and Research Company (Fidelity) became the Plan's TPA and record-keeper for participant accounts and Fidelity Management Trust Company (FMTTC) became the Plan's custodian. The custodian holds the Plan's assets, administers investment activity, and invests contributions into funds designated by each participant. The record-keeper maintains the individual participant accounts and provides records of balances and transactions to the Plan administrator and participants. Certain administrative and record-keeping costs are being absorbed by the Company. The Company's Board of Directors is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Valuation of investments: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Realized investment gains and losses are determined on the specific identification basis. Dividends are recorded on the declaration date. Interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions: Contributions from plan participants and the matching contributions from the Company are recorded in the year which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Investment related expenses are included in net appreciation in fair value of investments.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events: Events that have occurred subsequent to December 31, 2024, have been evaluated through October 14, 2025, which represents the date the Plan's financial statements were approved by management and, therefore, available to be issued.

3. TAX STATUS

The IRS has determined and informed Paychex Inc. by a letter dated August 31, 2020, that the non-standardized pre-approved profit sharing plan as amended through December 31, 2018, is in a form acceptable under section 401 of the Internal Revenue Code (IRC). The Plan adopted this prototype profit sharing plan effective May 20, 2022, as an amendment and restatement of the existing plan to bring the Plan into compliance with legislative and regulatory changes.

Effective February 6, 2023, the Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Fidelity as a restatement of the existing plan. As a result of this restatement, the Plan's name was changed from the "Bob Monnig Industries, Inc. 401(k) Profit Sharing Plan and Trust" to the "Monnig Global 401(k) Profit Sharing Plan & Trust," hardship withdrawals were removed, and participant loans were added to the Plan. The IRS has determined and informed Fidelity by a letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan as amended through November 5, 2018, is in a form acceptable under section 401 of the IRC. Effective January 1, 2024, the Plan was amended to increase the required safe harbor matching contribution to 100% of each participant's deferral contributions up to 5% of the participant's salary, and to increase the initial employee automatic enrollment deferral percentage from 3% to 5% of eligible compensation with annual increases of 1% until a deferral rate of 10% is reached.

The Company may rely on the opinion letters issued by the IRS as evidence that the Plan is qualified under the applicable sections of the IRC. The Plan is relying on the opinion letters. Although the Plan has been amended since receiving the opinion letters, the Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. TERMINATED PARTICIPANTS

Net assets available for benefits at December 31, 2024 and 2023 included approximately \$1,318,000 and \$1,107,000, respectively, allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts may be paid within the next year, at the request of the participants. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

6. CERTIFICATION OF INVESTMENT INFORMATION

Certain information in the accompanying financial statements and the ERISA-required supplemental schedule of assets held at year-end related to notes receivable from participants and investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company for the period February 6, 2023 through December 31, 2024, and Mid Atlantic Trust Company for the period January 1, 2023 through February 5, 2023, which are qualified institutions.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. FAIR VALUE OF INVESTMENTS

Plan investments are held in a trust managed by the Plan's custodians and are unsecured. Therefore, these transactions qualify as party-in-interest transactions.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of balances that are required or permitted to be measured at fair value for reporting in financial statements. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets recorded at fair value.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund on an active market which is based on the underlying net asset value (NAV) of shares held by the Plan at year-end. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include transactions with fiduciaries or employees of the Plan, any person providing services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, and relatives of parties-in-interest. The Plan has various parties-in-interest. Investments are held with parties-in-interest and certain fees are paid to parties-in-interest.

9. PROHIBITED TRANSACTIONS

The DOL considers late deposits to be nonexempt prohibited transactions. During the year ended December 31, 2024, the Company inadvertently failed to remit certain January, February, March, April, and May 2024 employee deferrals totaling \$956 to the Plan within the timeframe required by the DOL under plan asset rules. The Company remitted the late March 2024 employee deferrals and a portion of the late April 2024 employee deferrals totaling \$143 to the Plan in April 2024. The remaining employee deferrals totaling \$813 have not yet been remitted to the Plan and are included in contributions receivable at December 31, 2024. No determination of any missed earnings due to the Plan has yet been made.

During the year ended December 31, 2023, the Company inadvertently failed to remit certain employee deferrals totaling \$12,262 to the Plan within the timeframe required by the DOL under plan asset rules. The Company remitted the late employee deferrals to the Plan in 2024 and paid \$2,477 in missed earnings to the Plan in April 2024.
