Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ron Bouchard's Auto Sales, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ron Bouchard's Auto Sales, Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan:

The following brief description of the Ron Bouchard's Auto Sales, Inc. 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General – The Plan is a defined contribution plan covering all full-time employees of Ron Bouchard's Auto Sales, Inc., Paula R. Bouchard Auto Sales, Inc. and RB Automotive Group, Inc. (the Companies) who are not union employees, leased employees, or residents of Puerto Rico. To be eligible to participate in the Plan employees must have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

The Plan was amended and restated effective January 1, 2022.

Contributions – Each year, participants may elect to defer up to 100% of pre-tax compensation as defined by the Plan, and up to annual limits as established by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. The Plan contains an automatic enrollment provision for all participants entering the Plan on or after January 1, 2022. Eligible participants are automatically enrolled in the Plan with pre-tax deferrals of 5% of eligible compensation. Additionally, on the first day of the plan year, the Plan will, on behalf of the participants, increase their elective deferral by 1% until the participant reaches a deferral rate of 10%. Effective on September 30, 2022, the Plan was amended to allow participants to defer funds as a Roth 401(k) deferral. These deferrals are subject to applicable federal and state income taxes. An employee may enter the Plan on the first day of the month coinciding with or next following the date on which the employee met the eligibility requirements. Participants may also contribute amounts representing distributions from other qualified retirement plans to the extent permitted by the Internal Revenue Code (IRC).

The Companies may make a discretionary matching contribution, under which the Companies have elected to match a percentage of the participant's elective contribution. This matching contribution was 20% of the participant's elective contribution up to 1% of compensation for 2024 and 2023. The Companies may also make non-elective contributions to the Plan. Non-elective contributions may be made on behalf of participants meeting the eligibility requirements described above. Contributions are allocated in the ratio that each participant's compensation bears to the compensation of all eligible participants. No non-elective contributions were made during the year ended December 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contributions, the Companies corresponding matching contributions and discretionary contributions, if any, and an allocation of Plan earnings and/or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies discretionary matching and non-elective contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in employer contributions after six years of credited service.

Forfeited Accounts – The Plan provides that forfeitures, the unvested portion of the Companies discretionary matching and non-elective contributions, will serve to reduce future contributions made by the Companies and to pay administrative expenses incurred by the Plan. During the year ended December 31, 2024, forfeitures totaling \$1,795 were used to reduce the Companies matching contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,357 and \$1,796, respectively.

1. Description of the Plan (continued):

Payment of Benefits – A participant may not make withdrawals from their Participant's Elective Account except for:

- (1) Normal retirement – age 65;
- (2) Total and permanent disability;
- (3) Death;
- (4) Termination of employment;
- (5) Attainment of age 59½; or
- (6) Financial hardship

Distributions will be paid as soon as administratively possible following termination date, except for financial hardship withdrawals which are payable immediately. Distributions for financial hardship are only available to be made from elective deferral source funds. Distributions are paid to participants in a single lump sum, equal installments, or partial withdrawals.

Participant Notes Receivable – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from 1 to 5 years and may exceed 5 years for the purchase of a primary residence. Only one loan is permitted at any one time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Interest rates range from 6.25% to 8.50%. Principal and interest is paid ratably through payroll deductions.

2. Significant Accounting Policies:

The following are the significant accounting policies followed by the Plan:

Basis of Accounting – The accounting records of the Plan are maintained on the accrual basis.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Costs – Investment related transaction fees and loan administration fees are borne by the participants. All other recordkeeping fees such as accounting, legal and custodian services are borne by the Plan sponsor.

Payment of Benefits – Benefits are recorded when paid.

2. Significant Accounting Policies (continued):

Contributions – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Subsequent Events – In preparing these financial statements, management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

3. Tax Status:

The Internal Revenue Service has determined and informed the Companies by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination:

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Companies may determine.

5. Certification by the Investment Custodian:

The Plan administrator has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Charles Schwab Trust Bank serves as the Plan's custodian. The custodian has provided the Plan administrator with certifications as to the completeness and accuracy of investment balances, investment transactions, supplemental schedule, interest and dividend income, realized gains (losses) on the sale of investments and unrealized appreciation (depreciation) of investments in accordance with the Department of Labor Regulations. The employer contributions receivable total \$84,867 and \$74,920 as of December 31, 2024 and 2023, respectively.

6. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Investments, at Contract Value:

The participant's investment options include a benefit-responsive investment contract with The Standard. The Standard maintains the contributions in a group annuity contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by The Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

8. Investments, at Contract Value (continued):

The group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by The Standard for the group annuity contract, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$128,156 and \$190,749, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.50 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition competing investment options or deleting of equity wash provisions, (3) bankruptcy of the Plan sponsor or other plan sponsor event that would cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The current rate for The Standard group annuity account or fixed account maintains an annual effective yield but is not to be less than 1.50%. The annual rate of interest applied to the investment account may at times be higher or lower than the current rate. The following is a presentation of the effective average yields applied to the investment based on the years ended December 31, 2024 and 2023, as provided by The Standard:

9. Fair Value Measurements:

The Financial Accounting Standards Board (FASB) has issued Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of the different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
