NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Burns & Scalo 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan covering all employees of Burns & Scalo Roofing Company, Inc., Burns & Scalo Ohio, Inc., Cuddy Roofing, Inc., Scalo Solar, D.H. Hood Roofing (final in 2024), Burns & Scalo Roof Asset Management, Nexgen Design Systems, Inc., and Scalo, Inc. (collectively, "the Company") who have completed one year of service, are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 1, 2022, The Contractors Retirement Plan for Burns & Scalo Roofing Company (Contractor's Plan) was merged into the Plan. Participants in the former Contractor's Plan consist of employees rendering services to the Company on contracts subject to the Davis-Bacon Act, Service Contract Act or other federal, state or municipal prevailing wage laws. These employees are hereafter referred to as the "Contractors". There is no age requirement for Contractors to receive prevailing wage contributions.

Contributions

Each year, participants may contribute up to the lesser of 75% of pretax eligible annual compensation, as defined in the Plan, or \$23,000 and \$22,500 for the years ending December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds from the Fidelity Management Trust Company (FMTC) platform. Company matching contributions are limited to 50% of the participant's salary reduction election up to 6% of the participant's salary. Additional profit-sharing contributions are at the discretion of the Board of Directors. Contributions are subject to certain limitations.

The Company may make discretionary matching contributions of a percent, if any, to be determined during the contribution period based on a percentage of the employees deferral contributions.

The Company may make annual discretionary non-elective contributions in an amount to be determined at the Plan year end by the Board of Directors. You must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year. You do not need to satisfy these requirements if you die, become disabled or retire during the Plan year. The Company made \$-0- in discretionary non-elective contributions for the year ended December 31, 2024.

Contractors receive prevailing wage contributions determined by the Company based on rates that satisfy the wage determination issued by the governmental agency responsible for certain contracts. Such contributions cannot exceed the lesser of 100% of the Contractor's compensation or \$69,000 and \$66,000 per year for 2024 and 2023, respectively.

Funding Policy

The Company shall, within the time period and manner permitted by the Internal Revenue Code, remit to the trustee an amount equal to the sum of the elective deferral contributions and the Company matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) forfeitures of terminated participant's non-vested accounts, and (c) investment earnings and appreciation in the value of the investment. Each participant's account is charged with (a) participant withdrawals and distributions, (b) participant's share of investment losses and depreciation in value of investments, and (c) an allocation of administrative fees and expenses paid out of the Plan.

Investment of Contributions

The participant, with the consent of the trustee, shall direct the investment of all elective deferral, matching and employee rollover contributions made on the participant's behalf. Fidelity Management Trust Company (the "Trustee") offers various investment options under the trust or group contract. The participant may allocate the participant's contribution in any proportion the participant chooses among these options. The participant may also direct the transfer of any portion of the participant's account balance between these investment options.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments over a period not to exceed the participant's life expectancy.

Notes Receivable from Participants

Participants may borrow from their Plan account up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 3.25% to 8.00%, which is consistent with the local prevailing rates as determined periodically by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms range from one to five years, unless the loan is for the purchase of a principal residence, the administrator may permit a longer term.

Investment Options

The Company uses Fidelity Management Trust Company to provide and manage the retirement plan for the years ended December 31, 2024 and 2023. As of December 31, 2024, the Plan was invested in twenty-four (24) different funds. Participants may direct their voluntary contributions and Company contributions in any of the investment options.

Participants may make transfers between funds and make changes in the allocation of future contributions among funds at any time by either calling the automated voice response system or by accessing their account on the trustee's website.

Vesting

Discretionary matching and non-elective contributions are vested in accordance with the number of years of service as described below:

Participants in the Plan are 100% vested at all times in their participant contribution and rollover accounts as well as related earnings. They are entitled to the vested portion of their entire account balance if their participation ceases for any reason whatsoever.

Contractors are 100% vested at all times in prevailing wage contributions.

Forfeitures

Any participant who terminates employment forfeits his or her non-vested amounts in discretionary employer contributions. Forfeitures may be used by the Plan for several purposes, including to pay any administrative expenses; and to reduce any matching or non-elective contributions. The Plan had forfeitures available in the amount of \$38,792 and \$14,995 as of December 31, 2024 and 2023, respectively. The Plan utilized \$-0- of forfeitures during the year ending December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States and have been consistently applied in the preparation of the financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Accrual Basis of Accounting

The Plan management's policy is to prepare the Plan's financial statements on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded as expenses when paid through the Benefit Payments and Deemed Distributions accounts. Distributions to participants during 2024 were in the amount of \$716,755.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through October 10, 2025, which was the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

NOTE 4 – PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Case Sabatini & Company is the Plan auditor and qualifies as a party in interest.

NOTE 5 – PLAN TERMINATION

The Company expects to continue the Plan indefinitely, but is not contractually bound to do so. In order to protect both employees and the Company against unforeseen contingencies, the Company reserves the right to amend or terminate the Plan, or to discontinue contributions at any time without the consent of any other party. In the event of termination, all participants' accounts will be fully vested and are to be paid in the time and manner set forth in the Plan agreement.

NOTE 6 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by the letter dated August 7, 2001, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Effective May 1, 2022, the Plan was restated to conform to the CARES act.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) – Schedule of Assets Held for Investment Purposes at December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
