## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of the NewPath Child & Family Solutions 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the NewPath Child & Family Solutions 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

***General***

The Plan is a defined contribution plan established by NewPath Child & Family Solutions (the “Company”) under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees classified by the Company as full-time are automatically enrolled in the Plan at the attainment of age 21. For all employees classified as part-time or seasonal who have completed 1,000 hours of service within a 12-month time period, as defined, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was originally adopted July 1, 2020 but has been amended since that time.

***Plan Administration***

The Plan is administered by Empower Retirement (the Plan Administrator), which was appointed by the Board of Directors of the Company. Empower Trust Company, LLC (the Plan’s Trustee) is responsible for the custody and management of the Plan’s assets.

***Contributions***

Eligible employees can contribute in any amount up to the maximum percentage of compensation and dollar amount as defined by the Plan, subject to certain limitations under the IRC. The Company provides a safe harbor matching contribution of up to 4% of the participant’s compensation. In addition, the Plan has the ability to make an additional discretionary non-elective contribution to the Plan. The Plan uses a Pro Rata Allocation Method to allocate the non-elective contribution to each eligible participant’s account based on their compensation. The participant, safe harbor and non-elective contributions may be allocated to the investment alternatives made available by the Company, as defined, as the participant directs. The Company’s policy is to fully fund all contributions as they accrue.

***Participant Accounts***

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related allocation of profit-sharing contributions, forfeitures of terminated participants non-vested accounts, charged with an allocation of administrative expenses and debited with withdrawals, as well as the participant’s share of the Plan’s income and any related administrative expenses. Allocations of income and expenses are based on the proportion that each participant’s account balance bears to the total of all participant account balances.

***Vesting***

Participants are immediately vested in their contributions, the Company’s safe harbor and discretionary non-elective contributions plus the actual earnings thereon.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

***Payment of Benefits***

On retirement, death, disability, or termination of service, a participant (or participant’s beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant’s vested account balance. A participant with a vested account balance of \$5,000 or less will receive a lump-sum distribution equal to the vested value of their account as soon as administratively feasible following the participant’s employment termination date without the participant’s consent.

***Notes Receivable – Participant Loans***

A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms can range up to a maximum of five years for any participant loans, except for loans to purchase a home. The participant loans are secured by the balance in the participant’s account and bear interest at a rate of prime plus 1%, and mature between January 9, 2025 and November 15, 2049. Principal and interest are paid through payroll deductions.

***Forfeited Accounts***

As of December 31, 2024 and 2023 there was \$-0- and \$1,433, respectively, of non-vested forfeitures to be used to pay plan expenses or to reduce future employer contributions. All forfeitures are to be reallocated as additional employer non-elective contributions or used to reduce reasonable plan expenses in accordance with plan provisions. During the year ended December 31, 2024, the Plan used \$1,433 of forfeitures to reduce employer contributions.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”). The Accounting Standards Codification (“ASC”) as produced by the Financial Accounting Standards Board (“FASB”) is the sole source of authoritative U.S. GAAP.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan’s management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

***Investment Valuation and Income Recognition (Continued)***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

***Contributions***

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Contributions from the Company are recorded in the period in which the related participant contributions are due. No allowance for credit losses had been recorded as of December 31, 2024 and 2023.

***Notes Receivable – Participant Loans***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Operating Expenses***

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

ASC topic *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)**

*Level 2* - Inputs to valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to valuation methodology are unobservable and significant to the fair value measurement. Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobservable assumptions would reflect our own estimates of assumptions that market participants would use in pricing the asset or liability. Such valuation techniques include the use of option pricing models, discounted cash flow models and similar techniques.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan holds an investment contract with Empower Annuity Insurance Company. Under this contract, Empower Annuity Insurance Company maintains the contributions in a general account. The accounts are credited with the earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. There was no reserve against the contract value as of December 31, 2024 and 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Empower Annuity Insurance Company announces in advance the prevailing interest rates it will credit to participant account balances. When establishing interest crediting rates, Empower Annuity Insurance Company considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The rates are established without use of a specific formula. These rates are reviewed on a semiannual basis for resetting.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid overtime. There are no events that allow the issuer to terminate the contract and which require the Company to settle at an amount different than contract value paid either within 90 days or over time.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become fully vested in their account balances.

**NOTE 6 – TAX STATUS**

The plan sponsor adopted a Prototype Non-standardized Safe Harbor Profit Sharing Plan, for which a letter from the Internal Revenue Service has been received indicating that an employer who adopts this prototype plan will be considered to have a plan qualified under applicable sections of the Internal Revenue Code (IRC). The Plan Sponsor has elected not to request a separate determination letter for the Plan. The plan sponsor and the plan's administrator believe that the Plan is currently designed and being operating in compliance with applicable requirements of the IRC. Therefore, they believe the Plan was qualified as of the financial statement date.

**NOTE 6 – TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – RELATED PARTY TRANSACTIONS**

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments. The Plan Sponsor provides certain accounting, recordkeeping, and administrative services to the Plan, for which it received no compensation. Certain Plan investments are shares of fixed income funds managed by Empower Investments, an affiliate of the Plan’s trustee, and the Plan makes loans to participants and charges the participants a fee for each loan. These transactions qualify as party-in-interest transactions. Administrative fees of \$37,773 were paid to Empower Retirement and affiliates for the year ended December 31, 2024.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEES (UNAUDITED)**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Empower Trust Company, LLC, the Trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.
