### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the DAYRISE RESIDENTIAL, LLC 401(K) RETIREMENT PLAN (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the DAYRISE RESIDENTIAL, LLC 401(K) RETIREMENT PLAN's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

**NOTE 1—PLAN DESCRIPTION**

The following description of the Dayrise Residential, LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - employees are eligible to participate in the Plan following the completion of three months of service and have attained age 21. Employees are allowed to join the Plan immediately once such requirements are met. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA), as amended.

2. Contributions

*Elective Deferrals*

Participants may choose to contribute by payroll deduction up to 100% of their compensation, to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants who are at least age 50 may make an additional "catch-up" contribution of \$7,500 in 2024 and \$7,500 in 2023. The Plan offers both pre-tax and after-tax (Roth contributions) deferral options.

*Matching Contribution*

Each plan year, the Company may elect to make a discretionary matching contribution equal to a uniform percentage of each participant's salary deferrals. The Company made a discretionary matching contribution of 1% of the eligible annual compensation for the employee who is employed as of December 31, 2024 and worked at least 1,000 hours for the Plan year ended December 31, 2024. The Company made a discretionary matching contribution of 1% of the eligible annual compensation for the employee who is employed as of December 31, 2023 and worked at least 1,000 hours for the Plan year ended December 31, 2023.

3. Participant Accounts - Each participant's account is credited with the participant's contribution and matching contribution, if any. Participants direct the investment of their accounts into a variety of mutual funds. Participants may change their investment options daily.
4. Vesting - Participants are 100% vested in their voluntary contributions and actual earnings thereon. Participants also have immediate non-forfeitable right to their employer matching contributions if there is any made.
5. Payment of Benefits - On termination of service, death, disability or retirement, a participant's vested benefits will be paid in a lump sum.
6. Income Allocation - Plan earnings under the terms of this Plan shall be allocated to the account of each participant in the relation that the account bears to the total of all account balances.
7. Plan Expenses - All administrative expenses are paid by the Plan unless paid by the Company.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are held by Voya Financial. The Plan's investments consist of investment options that invest solely in shares of an underlying mutual fund or a fixed interest account.

Dividend and interest income are recognized when received. Net appreciation (depreciation) on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**BENEFITS**

Benefits are recorded when paid.

**FORFEITURES**

Forfeitures of participants' Company discretionary matching accounts can be applied to pay any administrative expenses of the Plan or to reduce employer contribution. Forfeitures totaled \$7,825 in 2024 and \$3,465 in 2023 that are available for future use. No forfeitures were used in 2024 or 2023.

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**NOTE 3—FAIR VALUE MEASUREMENTS (Continued)**

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

Mutual funds are valued at quoted net asset values of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements*

Pooled Separate Accounts contain value based on the NAV of units held by the Plan at year end, as calculated by the issuer, as a practical expedient to estimate fair value. NAV is calculated based on the fair value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding.

Level 3 fair value measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4—GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has invested in a traditional fully benefit-responsive guaranteed investment contract with the Voya Retirement Insurance and Annuity Company. The Voya Retirement Insurance and Annuity Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The average yield and crediting interest rate were 1.50% at December 31, 2024 and 1.33% at December 31, 2023 with a guaranteed minimum interest rate of 1%.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value as reported to the Plan by the Voya Retirement Insurance and Annuity Company represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. Consult the plan's group annuity contract for further information.

**NOTE 5—INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) for 2024 and 2023. Accordingly, the Plan's record keeper, Voya Retirement Insurance and Annuity Company has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H - Line 4(i).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 6—PARTICIPANT LOANS**

Participants may borrow from the employee contribution portion of their account balance. The amount the Plan may loan to participants is limited by rules under the Internal Revenue Code (IRC). Any new loans, when added to the outstanding balance of all other loans from the Plan, will be limited to the lesser of: a) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over participants' current outstanding balances of loans as of the date of the new loan; or b) 1/2 of their vested interest in the Plan. The amount the Plan may loan to participants can also be limited by Plan rules such as which Employee and Employer Contributions are available for loan use, the number of loans that can be outstanding at any one time or how often participants may request a loan.

**NOTE 7—TAX STATUS**

The Plan, through its adoption of FIS Business Systems LLC Prototype Volume Submitter Profit Sharing Plan with CODA, has obtained an opinion letter issued to FIS Business Systems LLC from the Internal Revenue Service (IRS) dated March 31, 2014 stating that the prototype plan is qualified under Section 401(a) of the IRC and that any employer adopting this plan will be considered to have a qualified plan under the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan presently meets the requirements of Section 401(a) of the IRC and, accordingly, its income is exempt from federal income taxes under Section 501(a). A similar status exists for Illinois income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 9—PARTY-IN-INTEREST TRANSACTIONS**

Certain expenses of the Plan are paid by the Plan sponsors. Other expenses are paid directly by the Plan.

The Plan's investments are managed by AFC Pensions, Inc., the Plan's Third-Party Administrator (the TPA). The assets are held by Voya Financial, which takes the record-keeping role. The TPA, the trustee, the record keeper and auditor are all considered parties-in-interest. Administrative fees paid by the Plan were \$5,950 for 2024 and \$4,400 for 2023. The fees paid for both 2024 and 2023 were based on customary and reasonable rates for such services.

**NOTE 10—SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 3, 2025, the date which the financial statements were available for issue. There were no subsequent events which require disclosure.
