INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
H&K Equipment, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of H&K Equipment, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP); and

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the H&K Equipment, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Plan participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan, established July 1, 1985 and amended and restated effective April 1, 2020, is a defined contribution plan covering all eligible employees of H&K Equipment, Inc. (the "Sponsor") and certain affiliated companies (collectively, the "Company").

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Employees are eligible to participate in the Plan beginning on the first day of the month subsequent to attaining 21 years of age and completing 30 days of consecutive service.

Participant Contributions - Participants may elect to contribute a portion of their pre-tax or post-tax compensation subject to certain limitations under the Internal Revenue Code (IRC). The Plan allows for participants who are age 50 or older to make catch-up contributions subject to limits established by the IRC and also accepts rollover contributions for eligible employees from other qualified plans.

The Plan's automatic enrollment provision provides for a 6% deferral for newly eligible employees, unless otherwise waived by the employee.

Employer Contributions - The Plan provides for discretionary matching contributions. During the years ended December 31, 2024 and 2023, the Company contributed 50% of the first 6% of eligible participant contributions. The Plan also provides for discretionary nonelective profit sharing contributions to eligible employees. These contributions are allocated to eligible participants based on their compensation and earnings integration level as set forth in the plan document. No employer discretionary nonelective contribution was made for the 2024 or 2023 plan year.

Participant Accounts - Each participant's account is credited with the employee and applicable employer contributions and an allocation of the Plan's earnings. The benefit to which a participant is entitled is the value of the participant's vested account.

Investment Options - Participants may direct their contributions and employer contributions into various investment options and may change their investment options at any time.

Vesting - Participants are 100% vested in their contributions plus actual earnings thereon. The employer matching and discretionary nonelective contributions vest based upon years of service according to the following schedule:

Years of Service

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Upon death, total and permanent disability or attaining age 65, participants are fully vested.

Forfeitures - Forfeited balances of terminated participants' non-vested accounts may be applied to reduce the Plan expenses or employer contributions, as defined in the plan document. Forfeitures of approximately \$63,000 and \$80,000 were used to offset employer contributions during the years ended December 31, 2024 and 2023, respectively. Furthermore, forfeitures of approximately \$9,000 and \$19,000 were used to pay plan expenses during the years ended December 31, 2024 and 2023, respectively. Forfeited non-vested accounts totaled approximately \$35,000 and \$16,000 at December 31, 2024 and 2023, respectively.

Payment of Benefits - Upon early termination of employment or termination of service due to death, disability, or normal retirement, participants may receive the value of their benefits in a lump-sum distribution. If the participant's account balance is less than or equal to \$5,000 (or \$7,000, effective January 1, 2024), the Company may make a lump-sum payment without the participant's consent. A participant may request a withdrawal from their account based upon financial hardship or at age 59 1/2, as defined by IRC regulations. A hardship withdrawal may be granted to a plan participant for an event considered to be an immediate and heavy financial need of the participant.

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of prime plus 2% at the time of inception. Interest rates on outstanding loans at December 31, 2024 and 2023 ranged from 3.25% to 10.5%. Repayment is required within five years or within a reasonable period of time if the loan is for a primary residence. Principal and interest are paid through regular payroll deductions.

Administrative Expenses - The Plan's expenses are paid by the Company or the Plan as provided by the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The Plan's financial statements are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in assets and liabilities at the dates of the financial statements. Actual results could differ from these estimates.

Investment Valuation and Income Recognition - The Plan's investments, except for the group annuity contract, are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividend income is recorded on the ex-dividend date.

U.S. GAAP establishes a framework for measuring the fair value of financial assets which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but they are observable either directly or indirectly; and
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: The funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year end using a quoted price in an active market (level 1 measurement).

Common Collective Trusts: These funds are valued at NAV of the units owned and their NAV is used as a practical expedient to estimate fair value. The funds seek to build a portfolio with a diverse

collection of growth stocks and are primarily comprised of U.S. large cap equities, non U.S. equities and cash. There are no unfunded commitments related to these investments. As the funds are valued at NAV, they are not categorized in the fair value hierarchy.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting dates.

The Plan's group annuity contract is valued at contract value, which is based upon contributions, earnings, administrative expenses and withdrawals. The group annuity contract is not available for sale nor is it traded on any securities exchange (see Note 3) and is reported at contract value, which is outside of the fair value hierarchy.

Net Change in Fair Value of Investments - The Plan presents the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the net unrealized appreciation (depreciation) on those investments in the statements of changes in net assets available for benefits.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Contributions - Participant and employer matching contributions to the Plan are recorded in the period during which the Company makes payroll deductions from the participant's earnings. Employer nonelective profit sharing contributions are recorded in the period earned.

Employee and employer contributions to the Plan are subject to certain statutory limits established by the Internal Revenue Code.

Benefits - Benefits are reflected when they have been approved for payment and are paid by the Plan.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events - Management has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

3. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (EAICA), the Fixed Income Fund, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the group annuity contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with EAICA. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The group annuity contract does not permit EAICA to terminate the agreement prior to the scheduled maturity date.

4. INCOME TAX STATUS

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan from Dunbar, Bender & Zapf, Inc. The Internal Revenue Service has stated in a letter dated June 30, 2020 that the plan is acceptable for use by employers under IRC Section 401. Although the Plan has been amended since receiving the letter, the Plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 and 2023. The Plan is no longer subject to U.S. federal or state income tax examinations by tax authorities for tax years before 2021.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

6. CERTIFIED FINANCIAL INFORMATION

Empower Trust Company, LLC, the custodian, and EAICA, the issuer of the Fixed Income Fund (see Note 3), have certified the following data included in the accompanying financial statements as complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying schedule.

7. RELATED PARTIES AND PARTIES-IN-INTEREST

Empower Trust Company, LLC serves as custodian of the Plan. EAICA (an affiliate of Empower Trust Company, LLC) is the issuer of the Empower T. Rowe Price Mid Cap Institutional Fund and the Fixed Income Fund and, accordingly, is a party-in-interest.

Neither the Company nor the employees of the Company involved in administering the Plan receive any compensation from the Plan.
