Note 1: The Plan and its significant accounting policies:

The following description of The Anchin, Block & Anchin (the Company) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established by the Company on January 1, 1983, to provide benefits to eligible employees. The Plan covers all full-time employees of the Company, other than union and leased employees and non-resident aliens. There are no age and service requirements to participate in the Plan. Plan entry dates are the first day of the quarter after eligibility requirements are met. The Plan is subject to the provisions of ERISA. The Investment Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective April 1, 2021, the Plan was amended and restated through adoption of an Internal Revenue Service pre-approved plan with the same plan administrator.

Effective December 12, 2023, the Plan was amended to exclude interns from eligible employees.

Effective July 24, 2024, the Plan was amended to remove a participating employer. As a result, investments totaling \$281,333 were transferred out of the Plan.

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Administration - Under the terms of the Plan, Charles Schwab Trust Bank acts as trustee and custodian. The Company has contracted with Sentinel Benefits & Financial Group (Sentinel) to act as recordkeeper. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are investment related expenses and accounting fees.

Investment valuation and income recognition - Investments of the Plan are held by Charles Schwab Trust Bank and invested based solely upon instructions received from participants. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. The Plan administrator believes all notes receivable from participants are collectible.

Payment of benefits - Benefits are recorded when paid.

Income taxes - The Internal Revenue Service has determined and informed Sentinel by a letter dated November 30, 2020, that their Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA (Cash or Deferred Arrangement) plan was designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustments to or disclosures in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Adoption of new accounting policy - On January 1, 2024, the Plan adopted ASU 2016-13 *Financial Instruments – Credit Losses (topic 326): Measurement of Credit Losses on Financial Instruments*, as amended, which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The measurement of expected credit losses under CECL methodology is applicable to financial assets measured at amortized costs, including contribution receivables and held-to-maturity debt securities. The Plan adopted ASC 326 using the modified method for all financial assets measured at amortized costs. The Plan has analyzed its financial assets and deemed that no adjustment is necessary. Therefore, total net assets available for benefits and change in net assets available for benefits are unchanged due to the adoption of this new standard. The Plan will continue to analyze their financial assets for expected credit loss under this new standard.

Note 2: Participation and benefits:

Participant contributions - Participants may elect to have the Company contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions withheld are invested in accordance with the participant's direction. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The 6% rate will be automatically increased by 1% annually and capped at a maximum rate of 10%.

The Plan also has a Roth 401(k) deferral option. Participants who select this option elect to have the Company contribute a portion of their compensation to the Plan on an after-tax basis, and in return, the deferrals and, in most cases, the earnings on the deferrals, are not subject to federal income taxes upon distribution after the distribution requirements applicable to Roth deferrals are met.

Participants are allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. The Plan also permits participants who are current employees of the Company to rollover contributions to an In-Plan Roth rollover contribution account as described in the Plan document. All contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions - The Company is allowed to make discretionary matching contributions as defined in the Plan and as approved by the Company. To be eligible for the Company discretionary matching contribution, a participant must complete a year of service as defined by the Plan during the plan year and be employed on the last day of the plan year. In 2024, the Company matched 6.25% of the first 4% of each eligible participant's contribution. If a participant contributed less than 4% of compensation to the Plan, then the Company matched 6.25% of the participant's contribution to the Plan. The Company made matching contributions of \$150,382 for the year ended December 31, 2024.

Participant accounts - Each participant's account is credited with the participant's contributions, Plan earnings or losses, administrative expenses and an allocation of the Company's contribution, if any. Allocation of the Company's matching contributions is based on participant contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary deferral and rollover contributions and related earnings. Participants vest ratably and are fully vested in the employer's discretionary matching contributions allocated to their account after six years of credited service. Participants will become fully vested in the Company's discretionary matching contributions upon death or total and permanent disability.

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$886 and \$774 respectively. These accounts are used to pay administrative fees and reduce future employer contributions. Forfeitures of \$11,263 were used to pay Plan administrative fees for the year ended December 31, 2024.

Payment of benefits - Upon termination, the participant or beneficiary will receive the benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for automatic lump-sum distributions of participant vested account balances which do not exceed \$7,000. If the account balance is \$7,000 or less, the value of the participants' interest in their account will be automatically rolled over to an Individual Retirement Account (IRA), unless the participant makes an election to receive a lump-sum payment. If the participant's account balance exceeds \$7,000, the participant must consent to receive a distribution and may elect to receive an immediate lump-sum payment or rollover into an IRA or to defer payment, as defined by the Plan.

The Plan permits in-service distributions to participants who have reached normal retirement age. It also allows for hardship withdrawals.

Notes receivable from participants - The Plan allows participants to borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate in effect at the time of the loan. The loans must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a primary residence. The specific terms and conditions of such loans are established by the Plan administrator. Principal and interest is paid ratably through payroll deductions for employees and reductions of drawings for partners. A participant may have no more than three loans outstanding at any time. Interest rates for loans in place in 2024 were 3.25% - 9.50%.

Note 3: Certified information:

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee/custodian of the Plan.

Note 4: Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts - valued at the net asset value (NAV) of units held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The Plan's common collective trusts seek to provide investors with long-term capital gains, income, and growth. Investments in common collective trusts are redeemable daily.

Note 5: Related party transactions and party in-interest transactions:

Certain Plan investments are shares of mutual funds and cash managed by Schwab Asset Management. Charles Schwab Trust Bank is the trustee of the Plan. Schwab Asset Management and Charles Schwab Trust Bank are affiliates of the Charles Schwab Corporation; the Plan pays applicable fees to all of these parties in-interest.

Fees incurred by the Plan for investment advisory services by USI Advisors, Inc. are included in net appreciation in the fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Also, the Plan paid Snyder Cohn, PC for Plan audit fees for the prior two years. Additionally, the Plan issues loans to participants, which are secured by the participants' accounts.

All of these party in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan termination and/or modification:

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, or partial termination of the Plan, participants' accounts shall be fully vested as of the date of such termination. The Company determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

Note 7: Subsequent events:

Effective August 1, 2025, the Plan was amended to change the entry date to the date requirements are met for all contributions, decrease the number of allowable loans outstanding from three to two, limit the term for home loans to ten years, and allow deferral modifications to be made during any payroll period.

Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.
