### 1. Plan Description

---

The following description of the Malnove Holding Company, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Malnove Holding Company, Inc. including all employees of Malnove Incorporated of Nebraska; Malnove Incorporated of Utah and Malnove Incorporated of Florida; (collectively, the Company).

Employees are eligible to make salary deferral contributions, receive safe harbor matching contributions, discretionary matching contributions, and discretionary profit sharing contributions after attaining age 18 and completing 60 days of service. Eligible employees may become participants on the first day of the month following the date on which entry requirements were fulfilled. Employees must be employed on the last day of the Plan year or had more than 501 hours of credited service within the Plan year in order to receive discretionary profit sharing contributions.

#### ***Contributions***

Participating employees may contribute up to 75% of their pre-tax or Roth after-tax annual compensation up to the maximum dollar limits allowable by law. Participants are automatically enrolled with an initial 3% salary deferral contribution once an employee becomes eligible for the Plan. A participant can elect not to contribute at any time and may increase or decrease his or her deferral rate quarterly to any rate allowed under Plan provisions. Participant deferral rates will automatically increase annually by 1% of eligible compensation up to a maximum of 20%. Participants will also have the option to schedule an annual increase of their affirmative deferral rate, up to 20%. Effective January 1, 2024, participants with a deferral rate of less than 3% will be automatically increased up to 3% and subject to the automatic increase feature. Safe harbor matching contributions are made in amounts equal to 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation that the employee contributes to the Plan. The Company may also make discretionary matching contributions and profit sharing contributions. There were no discretionary matching contributions or profit sharing contributions made during the years ended December 31, 2024 and 2023. Participants who are age 50 or older may make additional catch-up contributions. Participants may also contribute rollover distributions from other qualified plans. Contributions are subject to certain limitations.

### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of a) the Company's safe harbor matching contributions and discretionary matching contributions b) the Company's discretionary profit sharing contributions and c) Plan earnings or losses. The Company's safe harbor matching contributions and discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments directed by each participant. Effective November 14, 2024, investments are maintained in individual member accounts managed by Voya Retirement insurance and Annuity Company (Voya). Prior to November 14, 2024, investments were maintained in individual member accounts managed by John Hancock Trust Company LLC (John Hancock).

### *Vesting*

Participants are vested immediately in their contributions, Company safe harbor matching contributions, discretionary matching contributions, and discretionary profit sharing contributions and the related earnings credited to their account.

### *Payment of Benefits*

Upon termination, retirement, hardship, disability, or death, the participant or beneficiary may receive lump sum, partial or installment payments equal to the value of the vested funds allocated to the participant's account. Hardship withdrawals and age 59.5 in-service distributions are also permitted by the Plan. The Plan requires benefit payments between \$1,000 and \$7,000 (\$5,000 prior to November 14, 2024) be directly rolled over to an individual retirement account designated by the Plan administrator in the event the participant does not elect otherwise. Benefit payments under \$1,000 will be paid out in the event the participant does not elect a payout option. Benefit payments are recorded when paid.

### *Forfeitures*

As of December 31, 2024 and 2023, forfeited non-vested account balances relate to participants who terminated employment prior to March 1, 1998 (at which time participants became fully vested immediately) were \$80,299 and 1,044, respectively. Forfeited non-vested accounts may be used to reduce administrative expenses or reduce future Company contributions. There were no forfeitures used to reduce administrative expenses or Company contributions during the years ended December 31, 2024 and 2023.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on a modified cash basis of accounting and present the net assets available for benefits and changes in those net assets. Under this accounting basis, revenue is recognized when collected rather than when earned, and expenditures are generally recognized when paid rather than when incurred. Consequently, contributions receivable, accounts payable and accrued expenses are not included in the financial statements. Accordingly, these financial statements are not presented in accordance with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements under the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments, except for fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further disclosure of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invests in investment contracts through a guaranteed interest account.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the modified cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Expenses*

Investment management, recordkeeping and audit expenses are paid by the Plan and are included in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 13, 2025, noting no items requiring disclosure.

### 3. Information Certified by John Hancock and Voya

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are

required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at the NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements. Participants can redeem the accounts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

*Common Collective Trust:* The estimated value of the collective trust fund is at NAV. The use of NAV as fair value is deemed appropriate as the collective trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate fair value as long as certain requirements are met. Participants can redeem the accounts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Investment Contract With Voya and John Hancock

---

The Plan has entered into an investment contract with Voya, effective November 14, 2024. Voya maintains the contributions in pooled separate accounts and a guaranteed interest account. The accounts are credited with earnings on the underlying investment and charged for Plan withdrawals and administrative expenses charged by Voya.

The pooled separate accounts as reported to the Plan by Voya, are included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed interest account is fully benefit-responsive, contract value is relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The Plan had entered into an investment contract with John Hancock. John Hancock maintained the contributions in mutual funds and a common collective trust. The accounts were credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by John Hancock.

The mutual funds and common collective trust, as reported to the Plan by John Hancock, were included in the financial statements at fair value, which represented contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

#### 7. Related Party Transactions

---

Certain Plan investments are mutual funds and a common collective trust managed by Voya, effective November 14, 2024, and John Hancock, prior to November 14, 2024. Voya and John Hancock are the custodians as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.

#### 8. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

#### 9. Change in Custodian and Asset Transfer

---

Effective November 14, 2024, Voya was appointed as the new custodian of the Plan. The conversion initiated a "Black Out" period beginning November 12, 2024, and continued through December 13, 2024. During the Black Out period, funds could not be applied to the employee selected funds or withdrawn from the Plan until Voya had time to accurately complete the conversion. Employee contributions continued to be made through payroll deductions, and contributions were wired to Voya and invested as requested.
