Notes to Financial Statements
December 31, 2024

1. Plan Description

The following description of Hudson Valley Lighting, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Summary Plan Description or the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit-sharing plan that provides cash or deferred future benefits pursuant to applicable sections of the Internal Revenue Code ("IRC"). The Plan covers all eligible employees of Hudson Valley Lighting, Inc. and Troy-CSL Lighting, Inc. (collectively, the "Companies"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

Eligible employees who have reached 21 years of age and have completed one thousand hours of service within a twelve-month period are eligible to participate in the Plan. Employees are not eligible to participate in the Plan if (1) the employee is included in a unit of employees covered by a collective bargaining agreement in which retirement benefits were the subject of good faith bargaining and if two percent or less of the employees who are covered in that agreement are professionals as defined in Treasury Regulation section 1.410(b)-9; (2) the employee is a non-resident alien; or (3) the employee became an employee as a result of a transaction described in Code section 410(b) (6)(C). Effective May 20, 2022, the Plan was amended to allow eligible employees to enter the Plan immediately upon meeting the age and service requirements. Prior to the plan amendment, eligible employees could enter the Plan on the first day of the month, the first day of the plan year or the first day of the seventh month.

Contributions

Employees may elect to contribute to the Plan from 1% to 96% (in whole percentages) of their pre-tax compensation, up to a maximum dollar amount in accordance with Section 402(g) and Section 415(c) of the IRC. Participants may also contribute amounts representing distributions from other qualified plans. At the employer's sole discretion, the Companies may make a matching contribution on behalf of each participant up to 100% of the participant's contribution for the first 3% of the employee's eligible compensation and 50% of the following 2%, a total maximum of 4% of the employee's eligible compensation. Participant Accounts

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. All investments of the Plan are participant directed.

Vesting

Plan members are immediately vested in their voluntary pre-tax contributions, matching contributions and allocations of earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participant's vested account balance and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loan repayments must be made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the term is not to exceed 10 years. Principal and interest is paid ratably through periodic payroll deductions. Participants are limited to one outstanding loan at any one time.

Payment of Benefits

Under the terms of the Plan, a participant may make a withdrawal for reasons of economic hardship prior to attaining age 59½. Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Administrative fees incurred in connection with loans and participant activity charges are borne by the individual and deducted from their respective Plan assets. Investment related expenses are included in net appreciation in fair value of investments.

Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments were valued using level 1 inputs.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

4. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document, dated August 31, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

5. Party-In-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

6. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments were valued using level 1 inputs.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company, a qualified institution.

4. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document, dated August 31, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

5. Party-In-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

6. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
