Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Huntingdon Valley Bank Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 (liquidation basis), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of a Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, on March 24, 2023, the Board of Directors of Huntingdon Valley Bank approved termination of the Plan and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan used the liquidation basis to present the December 31, 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. 1. Description of Plan

The following description of the Huntingdon Valley Bank Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Huntingdon Valley Bank (the "Employer" or "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Citizens Financial Services, Inc. ("CZFS"), First Citizens Community Bank ("FCCB"), HV Bancorp, Inc. (the "Holding Company") and the Company entered into an Agreement and Plan of Merger dated as of October 18, 2022 (the "Merger Agreement"), pursuant to which the Holding Company will merge with and into CZFS, with CZFS as the surviving corporation (the "Merger"), to be followed by the merger of the Company with and into FCCB, with FCCB as the surviving institution. On June 16, 2023, the Company merged into FCCB. Under the terms of the Merger Agreement, the Plan adopted an amendment effective June 15, 2023, to terminate the Plan. All outstanding indebtedness of the Plan was repaid by delivering a sufficient number of unallocated shares of company stock to the Company. All remaining shares of company stock held by the Plan were converted to shares of CZFS common stock or cash.

The purposes of the Plan are to enable Plan participants to share in the growth and prosperity of the Company; provide participants with an opportunity to accumulate funds for their future security; and for the Plan to receive loans (or other extensions of credit) to finance the acquisition of Company stock, with such loans to be repaid by Company contributions to the Plan and other permissible sources (such as dividends on Company stock).

On January 11, 2017, the Plan purchased 174,570 shares of the Company's common stock for \$2,429,592, which was financed by a loan from the Company to the Plan (see note 6).

Plan Termination

The Company has taken action to terminate the Plan effective June 15, 2023 (the "Termination Date"). Upon termination of the Plan, the account of each participant is fully vested and non-forfeitable, and distributions of the account of each participant and beneficiary shall be made in the form of a lump sum payment.

Eligibility

Prior to the termination date, an employee became eligible to participate in the Plan upon attainment of age 21 and completion of 1,000 hours of service.

Contributions

Prior to the termination date, the Company may make a discretionary contribution equal to the Plan either in cash or Company stock. Contributions paid in the form of Company stock were based on Company stock value on the date issued to the Plan. No participant contributions, including rollover contributions, were permitted.

Contributions (*continued*)

Prior to the termination date, for each year in which an acquisition loan was outstanding, Reliance Trust Company (the “custodian”) would use any Company contributions made for such plan year to make principal and interest payments then due on the acquisition loan or loans outstanding at the end of such plan year. Each such payment by the custodian would release shares of Company stock from the loan suspense account of the Plan to be allocated to participant accounts. Participants were eligible to share in the Company contribution after meeting certain time and hours of service requirements. Employer contributions and Plan forfeitures are allocated to each account based upon the relation of the Participant’s eligible compensation to total eligible compensation of all Participants for the Plan year.

Vesting

Prior to the termination a participant was 100% vested in their contributions plus allocated earnings thereon. The participants’ vesting in the Company’s contribution was determined in accordance with the following schedule:

As a result of the Plan termination, participants became fully vested in the Plan.

Participant Accounts

Each participant's account is credited with allocations of: (a) Company contributions paid in Company stock or cash, (b) Plan earnings (losses) thereon and (c) all financed shares released from the loan suspense account purchased and paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the custodian prior to the time that such rights are to be exercised. Any allocated shares with respect to which voting instructions are not received from participants (or beneficiaries) will be voted in the same proportion as those shares for which instructions are received. Shares of Company stock which are not then allocated to participants accounts will be voted by the custodian as directed by the Company, unless the custodian requires that an independent fiduciary direct such vote solely with respect to any corporate matter.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount, under the Plan equal to the value of the Participant's vested interest in his or her account in a single lump sum.

Put Option

The purpose of the put option is to ensure the participant has the ability to ultimately obtain cash should the Company or CZFS delist its stock from a public exchange. Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years.

Diversification

Prior to the Termination Date, diversification was offered to participants close to retirement so that they could have the opportunity to move part of the value of their investment in the Company's common stock into investments which were more diversified. Participants who were at least 55 with at least 10 years of participation in the Plan could elect to diversify a portion of their account. Diversification was offered to each eligible participant over a six-year period. In each of the first five years, a participant could diversify up to 25% of the number of shares allocated to his or her account since the inception of the Plan, less any shares previously diversified. In the sixth year, the percentage changed to 50%. A participant could diversify the percentages described above by either requesting a distribution of that amount in cash or by rolling over that amount in cash to another qualified defined contribution plan maintained by the Employer which provides investment options.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. Prior to termination of the Plan (see note 1), these accounts were used to pay Plan expenses, reallocate to participants or reduce future Employer contributions. During 2024, no forfeitures were reallocated to Plan participants.

Plan Expense Account

The Plan and Empower entered into a service-based pricing arrangement whereby a portion of the revenue earned by certain Plan investments is passed through to the Plan for payment of permitted Plan expenses. The Plan Expense Account is a nonparticipant directed account within the Plan. At December 31, 2024, the Plan Expense Account balance was \$0. During 2024, revenue credits amounting to \$3,000 was received by the Plan and \$3,000 was used to reduce Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

As a result of the termination of the Plan (see Note 1), the Plan changed its basis of accounting from the going concern basis to the liquidation basis. There were no material changes to the financial statements as a result of this change in accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

At December 31, 2024 and 2023, all of the Plan's investments are valued using Level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value. The common stock and money market fund are valued at the closing price reported on the active market on which the security is held.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to record-keeping services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net asset value of the respective investment vehicles and, consequently, those expenses are not separately reflected but are a component of net depreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (liquidation basis) as of December 31, 2024, including investments held at December 31, 2023 and 2022, and net depreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Reliance Trust Company, qualified institutions.

Reliance Trust Company held the Plan's investment assets and executed investment transactions as of December 31, 2023 and for the period from January 1, 2024 to November 30, 2024 and Empower Trust Company, LLC held the Plan's investment assets and executed investment transactions for the period December 1, 2024 to December 31, 2024.

At December 31, 2024 and 2023, the common stock represented 67% and 69% (CZFS stock) of the Plan's total assets.

5. Income Tax Status

The Plan obtained a determination letter on October 30, 2018, in which the Internal Revenue Service ("IRS") stated that the Plan is in compliance with the applicable requirements of the Internal Revenue Code. On February 25, 2025, the IRS issued a determination letter approving the Plan's termination effective June 15, 2023. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-In-Interest Transactions

The investments of the Plan predominantly consist of the Company's common stock and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees, who may be participants in the Plan, perform administrative services for the Plan at no costs to the Plan.

7. Risks and Uncertainties

The Plan invests primarily in common stock of CZFS. This investment is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with this investment, it is at least reasonably possible that changes in its value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
