We have performed audits of the accompanying financial statements of CRH Healthcare, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). Note 1—Description of the Plan

The following description of the CRH Healthcare, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution retirement plan under Section 401(k) of the Internal Revenue Code ("IRC"), covering substantially all employees of the CRH Healthcare, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established on January 1, 2013 and most recently amended on April 1, 2022.

Administration – The Plan sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Eligibility – Substantially all employees of the Plan who are 21 years of age and who have completed six months of continuous employment are eligible to participate in the Plan.

Employees of Patients First Appleyard, Inc.; Patients First Lake Ella, Inc.; Patients First Mahan, Inc.; Patients First North, Inc.; Patients First Northhampton, Inc.; Patients First Parkway, Inc.; and Patients First Raymond Diehl, Inc. employed on January 1, 2017 are waived from age and service requirements. Employees of CRH Maryland, LLC employed on April 1, 2020 are waived from age and service requirements.

Contributions – Participants may elect to contribute a portion of their pretax annual compensation as defined in the Plan, subject to certain IRC limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Company has the right to make a discretionary matching contribution to the Plan. No discretionary matching contribution was made during 2024.

The Company also elects to make a safe harbor contribution to the Plan of 100% of the first 3% and 50% of the next 2% of eligible wages per pay period that employees contributed to the Plan. The safe harbor contribution totaled \$824,949 for the Plan year ended December 31, 2024.

Catch-Up Contributions – For the year ended December 31, 2024, if a participant is eligible to make deferrals and turns 50 before the end of the calendar year, the participant may defer an additional \$7,500 into the Plan as a pre-tax contribution subject to certain IRC limitations. Catch-up contributions are eligible for Company matching as defined by the Plan.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of the Company's discretionary matching and safe harbor contributions and Plan earnings. Participant accounts are charged with withdrawals and an allocation of Plan losses and certain administrative fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1—Description of the Plan (continued)

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company's discretionary matching portion of their accounts (provided employment continues through December 31 of the applicable calendar year) plus earnings thereon. Any nonelective contributions to the Plan are vested according to the following schedule:

Less than 2 years	0%
At least 2, but less than 3 years	20%
At least 3, but less than 4 years	40%
At least 4, but less than 5 years	60%
At least 5, but less than 6 years	80%
6 or more years	100%

Investment Options – Upon enrollment in the Plan, each participant may make direct contributions into various investment options offered by the Plan. Participants may change their investment options at any time. All investments held in the Plan are participant-directed.

Notes Receivable from Participants – Participants may borrow from their fund accounts in any amount greater than \$500, but less than 50% of their vested account balance, not to exceed \$50,000. Loans are secured by the balance in the participant's account and bear interest at an agreed-upon percentage based on prevailing market rates ranging from 3.25% to 8.50%. Generally, loans to participants are to be repaid through payroll deductions in installments not to exceed five years. A loan used for financing the purchase of a participant's principal residence may be repaid over a longer period of time. Principal and interest are paid ratably through payroll distributions.

Benefits Paid to Participants – Upon termination of service due to death, disability, retirement, or any other reason, a participant, or the participant's beneficiary in the case of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In the event a participant terminates employment with the Company and the participant's vested balance is less than \$5,000, the Company may pay the entire vested balance out of the Plan to the participant.

Under certain provisions of the Plan, Roth IRA balances may be automatically rolled over into an individual retirement account.

Forfeited Accounts – Forfeited balances of terminated participants' nonvested account balances may be used to pay Plan expenses and reduce future Company contributions. The forfeited nonvested accounts balance was \$29,486 and \$28,068 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to pay Plan expenses or pay Company contributions.

Plan Costs – The Company absorbs certain costs of the Plan such as accounting and administrative expenses, as permitted by the Plan. Additionally, the Plan absorbs some administrative expenses in accordance with Plan provisions.

Note 2—Summary of significant accounting policies

Basis of Presentation – The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Accounting Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Allocation – Investments in the Plan are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Contributions Receivable – Contributions due and payable by the Company are reflected as Company contributions receivable in the Plan’s financial statements.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Agreement.

Benefits Paid to Participants – The Plan records benefit payments to withdrawing participants when paid. Under the rules for preparation of Form 5500, the Plan’s Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to year-end, and who had requested a distribution which was approved but not yet paid at period-end, if any. There were no such unpaid distributions at December 31, 2024 or 2023.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant’s account.

Fair Value Measurements – The Plan follows the *Fair Value Measurements* topic of the Financial Accounting Standards Board Accounting Standards Codification 820, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The standard describes three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies, and

Level 3 – Inputs to the valuation methodology are unobservable inputs in the situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual Funds – These public investment vehicles are valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 1 of the valuation hierarchy based on the underlying assets of the account, which are traded on an active market.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3—Information certified by the qualified institution (unaudited)

Plan management has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (“Voya”), the “qualified institution” of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

Note 5—Investment contract with insurance company

The Plan has an annuity contract with Voya that invests contributions in the Voya Fixed Account. The Voya Fixed Account is intended to be a long-term investment for participants seeking stability of principal.

The Voya Fixed Account guarantees principal and a minimum guaranteed interest rate for the life of the investment as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate decreased for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate. The current rate, the guaranteed minimum floor rate, and the minimum guaranteed interest rate are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to a participant’s account daily yields the then current credited rate. Voya’s determination of credited interest rates reflect a number of factors, including mortality and expense risks, interest rates guarantees, the investment income earned on invested assets, and the amortization of any capital gains and/or losses realized on the sale of invested assets.

Under this option, Voya assumes the risk of investment gain or loss by guaranteeing the principal amount the participant allocates to this option and promising a minimum interest rate during the accumulation period and also throughout the annuity payout period, if applicable.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Note 5—Investment contract with insurance company (continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Voya. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7—Tax status

The Company has adopted a prototype non-standardized defined contribution plan whose sponsor obtained its latest determination letter on June 30, 2020, in which the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan sponsor believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8—Party-in-interest transactions

Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Certain Plan investments are managed by the qualified institution of the Plan. Fees paid by the Plan for investment management services amounted to \$20,850 for the year ended December 31, 2024.

Notes receivable from participants also qualifies as party-in-interest transactions.

Note 9—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
