### ***Opinion***

We have audited the financial statements of IDS Engineering Group, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### ***Basis for Opinion***

## Notes to Financial Statements

### Note 1. Description of the Plan

The following description of the IDS Engineering Group, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the *Plan document* for a more complete description of the Plan's provisions, which is available from Plan management.

#### General

IDS Engineering Group, Inc. (the Company), the sponsoring company, established the Plan on February 28, 1985. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 3, 2012, the plan sponsor changed its name with the Texas Secretary of State from Pate Engineers, Inc. to IDS Engineering Group, Inc. Accordingly, the Plan changed its name from Pate Engineers, Inc. Employee Stock Ownership Plan to IDS Engineering Group, Inc. Employee Stock Ownership Plan, effective November 21, 2012.

#### Eligibility

Employees of the Company are generally eligible to participate in the Plan after six months of service. Eligible employees are admitted to the Plan on the next entry date, January 1 or July 1. Participants who do not have at least 1,000 hours during the Plan year, or are not employed on the last working day of the Plan year, are generally not eligible for an allocation of Company contributions for such year.

#### Contributions

The Company, at its discretion, can make contributions to the Plan based on the Company's performance. During 2024 and 2023, the Company made a contribution of \$630,000 and \$700,000, respectively. Employee contributions are not permitted.

#### Payment of Benefits

Distributions from the Plan will not be made until a participant retires, dies (in which case payment shall be made to his or her beneficiary or, if none, his or her legal representatives), becomes disabled, or otherwise terminates employment with the Company. A participant terminating as a result of death, disability, or retirement is entitled to receive the vested interest in his or her account in the Plan the following year through either the issuance of a five year note payable from the Plan or, at the Company's option, one lump sum payment.

A participant who terminates for reasons other than death, disability or retirement is entitled to receive the vested interest in his or her account in the Plan after five years through either the issuance of a five year note payable from the Plan or, at the Company's option, one lump sum payment. A distribution of benefits is recorded when paid or upon issuance of a note payable from the Plan.

#### Administrative Expenses

As provided by the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### **Voting Rights**

Since the Company stock is not a registered security, participants may vote the Company stock in their account only on corporate matters such as merger or consolidation, recapitalization, reclassification, liquidation, dissolution or sale of substantially all assets of the Company. On all other matters, the Trustee votes all shares of Company stock at its discretion. If the Company stock becomes a registered security, the participants may vote the Company stock in their account on any matter which is put to a shareholder vote.

### **Participant Accounts and Forfeitures**

The Plan is a defined contribution plan under which account balances are maintained for each participant. Each participant's account is credited as of the last day of the Plan year with an allocation of the Company's contribution, if applicable, and an allocation of shares of the Company's common stock, if applicable. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation.

The Company may make a discretionary contribution to the Plan at the option of the Company's board of directors. Allocations of any Company contribution are based on an active participant's eligible compensation, relative to total eligible compensation.

If a participant has a termination of employment, the participant's non-vested account balance shall be forfeited after the participant has incurred five consecutive one-year breaks in employment. Forfeited shares of the Company's common stock of terminated participants' non-vested accounts are allocated to active participants based on the participant's eligible compensation, relative to total eligible compensation. The Plan had \$21,578 and \$18,236 of forfeitures in 2024 and 2023, respectively.

New shares sold to the Plan by outside shareholders, unallocated shares of the Company's common stock within the Plan and interest expense, if any, related to the release of the unallocated shares, are allocated to each participant's account based on the ratio of the active participant's account balance at the beginning of the year to the sum of all active participants' account balances at the beginning of the year.

Plan net income or loss is allocated to each participant's account based on the ratio of each active and inactive participant's account balance at the beginning of the year to the total account balances for the Plan at the beginning of the year.

### **Vesting**

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Beginning with the effective date of the Plan (February 28, 1985) or their date of employment, if later, employees vest in their accounts at 20% upon completion of three years of service, but less than four years; 40% upon completion of four years, but less than five years; 60% upon completion of five years, but less than six years; 80% upon completion of six years, but less than seven years, and 100% upon completion of seven years or more. The Plan has been amended in accordance with the Pension Protection Act resulting in 100% vesting for participants with six years of credited service effective January 1, 2007. Amounts in participants' accounts prior to January 1, 2007 will retain the seven year vesting schedule. Amounts in participants' accounts on or after January 1, 2007 vest at 20% upon completion of two years of service, but less than three years; 40% upon completion of three years, but less than four years; 60% upon completion of four years, but less than five years; 80% upon completion of five years, but less than six years, and 100% upon completion of six years or more. Notwithstanding the foregoing, in the event of a partial termination of the Plan as defined by Revenue Ruling 2007-43, all affected participants will be fully vested in accordance with Code Section 411 (d)(3).

### **Put Option**

Under Federal income tax regulations, employer stock that is held by the Plan and its participants, and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company or the Plan buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure the participant has the ability to ultimately obtain cash.

### **Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least 55 years of age with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a stock distribution with a put option.

## **Note 2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Cash and Cash Equivalents**

The Plan considers all highly liquid investments with a maturity of three months or less when purchased to be cash equivalents.

### **Investment Valuation and Income Recognition**

The shares of Company stock are reported at fair value. See Note 4 for discussion of fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*IDS Engineering Group, Inc. common stock:* The fair value of the common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. The valuation process involves the selection of an independent appraiser. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparable and estimated fair value of company assets and liabilities. This appraisal was then based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser prepares a preliminary report with Plan management, along with the ESOP trustee, reviews in detail, discusses and approves. The results of the process are documented in the minutes of the Plan fiduciary.

*Money market fund:* Valued using the net asset value (NAV) of the shares held by the Plan.

The valuation process involves the trustee's selection of an independent appraiser. Plan management accumulates the data for the appraiser from audited financial statements of the Company. The appraiser prepares a preliminary report with Plan management, along with the ESOP trustee, reviews in detail, discusses and approves. The results of the process are documented in the minutes of the Plan fiduciary.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5. Administration of the Plan

The Plan's assets, which consist principally of sponsor Company common shares, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received and makes distributions to participants.

The administration of the Plan is the responsibility of a committee, which was appointed by the Board of Directors of the sponsoring Company. The committee is authorized to take such actions as may be necessary to carry out the provisions and purposes of the Plan and shall have the authority to control and manage the operations and administration of the Plan.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses of the Trustee, if any, are paid directly by the Company.

### Note 6. Notes Payable

As described in Note 1 under Distributions, the Company has the option to issue a five year note payable from the Plan to liquidate the accounts of participants terminated for reasons other than death, disability or retirement. As of December 31, 2024 and 2023, the Plan had notes payable outstanding totaling \$1,464,397 and \$812,858, respectively. The notes bear interest at fixed rates ranging from 3.25% to 8.50%. Interest expense totaled \$43,537 and \$32,976 for 2024 and 2023, respectively. The loans are collateralized by the Company stock sold by the participants.

### **Note 7. Related Party Transactions and Party in Interest Transactions**

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party in interest transaction. As described in Note 1, the Company pays all plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

### **Note 8. Risks and Uncertainties**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows, and/or other such techniques. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### **Note 9. Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Company directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

### **Note 10. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated March 13, 2018, stating that the Plan qualified under the IRS and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operating, in compliance with the applicable requirements of the IRS. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financials statement date.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 11. Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available for issuance and has determined that there are no events, other than discussed below, that required recognition in the financial statements or disclosure in the notes to the financial statements.
