Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Beloit College Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

Notes to Financial Statements

Note 1. Description of Plan

The following description of Beloit College Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Beloit College (the Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Upon hire, all nonexcludable classes of employees, as defined in the plan document, can make elective deferrals as soon as enrollment is administratively feasible. Nonexcludable classes of employees, as defined in the plan document, are also eligible for Employer contributions upon attainment of age 21 and after completion of two years of service. Participants enter the Plan, for purposes of employer contributions, on the first day of the month after meeting the eligibility requirements. The Retirement Plan Committee is responsible for oversight of the Plan.

Contributions: Each year, participants may contribute annual compensation (participant contributions), as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Prior to August 16, 2018, only pretax deferrals were permitted; both pretax and Roth deferrals are now allowed according to the plan document. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Employer contributions are based on a service graded formula. Effective August 16, 2018, employer contributions for participants who have worked greater than two, but less than or equal to six years, receive a contribution equal to 3.5% of eligible compensation. Participants who have worked greater than six years receive a contribution equal to 7% of eligible compensation. Prior to August 16, 2018, these employer contributions were 5% and 10% of eligible compensation, respectively. Eligible compensation for purposes of calculating the employer contribution is defined in the plan document. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts: Each participant's account is credited with the participant's salary reduction contributions, rollover contributions and an allocation of the Employer's contribution and plan earnings (net of administrative expenses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in participant, rollover and employer contributions plus earnings thereon.

Participant loans: On January 1, 2020 the Plan was amended to allow participant loans. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. These loans are secured by the balance in the participant's account. The loans bear interest at the Federal Reserve Board Bank prime rate plus 1% at the time of the loan origination. The term of the loan will not exceed five years unless the loan is used to acquire a dwelling unit that is to be used within a reasonable time as the participant's principal residence, in which case such period shall not exceed 15 years. Principal and interest are paid ratably through payroll deductions. Prior to the 2020 Plan year, participant loans were not permitted by the Plan.

Investment options: Upon enrollment in the Plan, participants may direct the investment of their account balances into a variety of investment options as more fully described in the Plan's literature. Participants may change their investment options daily.

Note 1. Description of Plan (Continued)

Payment of benefits: Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65 and early retirement is not offered. The total of a participant's account balance is distributed in the form of a lump-sum payment or an annuity contract. Participants experiencing financial hardship may withdraw a portion of their account balance as defined by the Plan.

Participants invested in the Teachers Insurance and Annuity Association (TIAA) Traditional Annuity, an annuity contract, are subject to liquidity restrictions on certain benefit payment withdrawals. The TIAA Traditional Annuity does not allow lump-sum withdrawals. All participant-initiated withdrawals and transfers must be spread over 10 annual installments (over a period of nine years plus one day).

Administrative expenses: All reasonable plan administrative expenses, including those involved in retaining necessary professional assistance, may be paid from the assets of the Plan to the extent permitted by the participant's individual agreements. These expenses may be allocated to all plan participants, or for expenses directly related to one participant, charged against that participant's account balance. The Employer may, at its discretion, pay a portion or all of these expenses.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

Payment of benefits: Benefits paid to participants are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent events: The Plan's management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following are descriptions of the valuation methodologies for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Shares of registered investment companies: Shares of registered investment companies are valued at the daily closing price, as reported by the fund. Shares of registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Fixed annuity account: The TIAA Traditional Annuity account is reported at contract value, which is equal to the accumulated cash contributions and interest less any withdrawals, and approximates fair value. The annuity is not available for sale or transfer on any securities exchange. The TIAA Traditional Annuities are fixed annuity contracts unconditionally guaranteed by TIAA, a New York domiciled nonprofit legal reserve life insurance company.

Variable annuity accounts: The CREF variable annuities are valued at the daily unit value published on NASDAQ; however, the accounts are not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the accounts.

Pooled separate account: The TIAA Real Estate Account is a pooled separate account in which daily unit values are published on NASDAQ. The account is not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the account. TIAA has also placed redemption restrictions on the Real Estate Account.

Note 5. Investment Contract With Insurance Company

The Plan has entered into a fixed annuity contract with TIAA. The TIAA Traditional Annuity is a fixed annuity contract that is fully and unconditionally guaranteed by TIAA, a New York domiciled nonprofit legal reserve life insurance company. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some recent contracts between 1% and 3%), and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1. Additional interest is not guaranteed for future years. When the accumulation is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. There are no probable or likely events or circumstances that would limit the Plan's ability to execute transactions at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Note 6. Related-Party Transactions and Party-in-Interest Transactions

Certain investments of the Plan are managed by TIAA and CREF, the issuer/agent, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. As disclosed in Note 1, fees incurred by the Plan for investment management services and professional services are offset against appreciation in fair value of the Plan's investments, rather than a direct payment, and are also considered party-in-interest transactions. Fees paid by the Plan for the investment management and recordkeeping services totaled approximately \$29,000 for the year ended December 31, 2024, and are party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8. Income Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Approximately 62% and 70% of the Plan's investments are held in contract with TIAA and CREF as of December 31, 2024 and 2023, respectively.
