Independent Auditor's Report

Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

Note 1: Description of the Plan

The following description of the Custom Wood Products, Inc. Profit Sharing/401(k) Plan & Trust (the Plan), provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 1984, is a defined contribution plan covering all employees of Custom Wood Products, Inc. and Kitchen Bath & Home, Inc. (the Company), who are nineteen years of age or older, and are eligible to begin deferring contributions the first day of the Plan year following the age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution, the Company's matching contribution, any employer discretionary profit-sharing contribution, and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund. All investments are participant directed.

Employee Contributions

Participating employees may elect to contribute a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred basis or after-tax basis. Employees age 50 and over may elect to defer an additional "catch-up" contribution, as defined in the Plan document. Transfers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Company may make a matching contribution equal to a uniform percentage of the employee's salary deferral, which percentage is determined annually at the discretion of the Company's Board of Directors. During 2024 and 2023, the Company has chosen to match 50% of the first 6% of earnings contributed by the participant.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Company has elected not to provide a discretionary contribution for 2024 or 2023.

Vesting

Participants are fully vested in their employee contributions plus actual earnings thereon. Vesting in the Company contributions and earnings thereon is based on years of service and is determined as follows:

Participant Loans

Under the terms of the Plan, participants may not borrow from their accounts.

Forfeitures

Forfeitures of non-vested company contributions attributable to matching contributions are used to reduce future company contributions. Forfeitures applied to company contributions for the Plan years ended December 31, 2024 and 2023 were \$20,202 and \$19,886, respectively. Any forfeitures pertaining to discretionary contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. For the Plan years ended December 31, 2024 and 2023, the amounts forfeited were \$18,628 and \$27,483, respectively. The forfeiture account balances at December 31, 2024 and 2023 were \$6,298 and \$10,951, respectively.

Payment of Benefits

On termination of service due to termination of employment, the participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Retirement, death or disability distributions are 100% vested. In-service distributions are available under certain circumstances and can only be made from 100% vested amounts.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Other expenses are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from the employee are accrued when withholding is made from the employees' payroll. Benefit payments are reported in the year paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had \$0 and \$15,818, respectively, pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

Investment Valuation and Income Recognition

The investments in all of the funds are presented at fair value, based on the quoted market prices of the underlying securities within each fund. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following on the next page is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds and Exchange Traded Funds

Valued at the daily closing price as reported by the fund. Mutual funds and Exchange traded funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds, ETF and money market funds held by the Plan are deemed to be actively traded.

Note 4: Cash Equivalents

Cash and cash equivalents are valued at face value. These accounts are not subject to market fluctuations. Therefore, they are not included in the fair value hierarchy table.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6: Tax Status

The Plan received a determination letter from the Internal Revenue Services dated June 30, 2020, stating that the Plan is qualified, under the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving its determination letter. However, the Plan Administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Related Parties and Parties in Interest Transactions

The Plan Sponsor absorbs the cost of some administrative fees of the Plan, the cost of audit fees related to the Plan, and the cost of fidelity bonds. Certain Plan investments are shares of proprietary funds managed by Alerus Financial NA (the Custodian). Also, certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. These transactions qualify as exempt party-in-interest.

Investment related expenses are included in the net appreciation of fair value of investments. These transactions qualify as exempt party-in-interest transactions.

Additional party-in-interest transactions include audit fees to Varney & Associates, CPAs, LLC and Keating & Associates for investment services and third-party administration.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9: Reconciliation of Financial Statements to Form 5500

The financial statement amounts reconcile with the annual Form 5500 filing to the Internal Revenue Service.

Note 10: Information Prepared and Certified by Custodian (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 and 2023 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

Note 11: Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.
