## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of Roane Transportation Services Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of this publication are available from the Plan Sponsor.

#### **General**

The Plan is a multiple-employer defined contribution plan covering substantially all full-time employees of Roane Transportation, LLC and KW Waste, LLC (collectively, the “Plan Sponsor”) who have completed 90 days of service and are 18 years of age or older. Effective September 1, 2025, the Plan was amended to include Roane Logistics, Inc. as a participating employer. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute, on a pre-tax or Roth basis, up to 100% of their eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 6% of eligible compensation, increasing each year by 1%, up to a maximum withholding of 10% of compensation, as defined by the Plan Document.

The Plan Sponsor makes safe harbor matching contributions equal to 100% of participant deferrals up to 1% of eligible compensation plus 50% of participant deferrals from 1% to 6%. The Plan Sponsor may also make discretionary matching or profit-sharing contributions. No such contributions were made during 2024 or 2023.

Cash contribution receivables, if any, are unsecured.

### 1. Description of the Plan (continued)

#### Participant Accounts

Individual accounts are maintained for each participant to reflect the participant's contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their elective salary deferral contributions, rollover contributions from other qualified plans, qualified nonelective contributions, and related earnings thereon.

For any Plan Sponsor safe harbor matching contributions, vesting is based on years of credited service as follows:

#### Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participants' non-vested accounts may be used to reduce future Plan Sponsor contributions to the Plan or plan expenses. If a terminated participant is rehired by the Plan Sponsor, the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan Agreement.

**Forfeitures (continued)**

As of December 31, 2024 and 2023, there was \$214,955 and \$92,305, respectively, in the forfeiture account, which is included in Plan assets. Forfeitures totaled \$180,430 during 2024. Forfeitures were used to reduce Plan Sponsor contributions by \$63,099 during 2024.

**Payment of Benefits**

At any time on or after the age of 59½ or upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount or installments equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

In-service hardship withdrawals are available in certain circumstances.

**Termination of the Plan**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Plan Sponsor contributions.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Empower Trust Company, LLC (Empower) holds the Plan's investments in various mutual funds and a fixed annuity option of Empower Annuity Insurance Company of America (EAICA).

**2. Summary of Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition (continued)**

The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments. The investments, with the exception of its fully benefit-responsive contract, are stated at fair value. Fully benefit-responsive contracts are valued based on contract value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Certain investment related expenses are netted in net realized and unrealized appreciation in the fair value of investments.

**Subsequent Events**

In preparation of the accompanying financial statements, the Plan's management has evaluated subsequent events that have occurred since December 31, 2024 through October 10, 2025, the date the financial statements were available for issuance.

**3. Income Tax Status**

The Plan Sponsor adopted a prototype plan sponsored by ERISA Services, Inc. that received a favorable opinion letter from the IRS dated June 1, 2021, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

#### 4. Certified Information (Unaudited)

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments and investment income (including \$12,324 from the EI Fixed Account) for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower.

#### 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used as of December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### 6. EI Fixed Account

The Plan invests in a fixed annuity contract of EAICA that is fully benefit-responsive. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with EAICA. Such events include amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

#### 7. Other Related Party and Party-in-Interest Transactions

Certain investments are held and managed by Empower and EAICA; therefore, these transactions qualify as party-in-interest transactions.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Delinquent Participant Contributions**

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2023, contributions totaling \$25,926 were not remitted within the required time period. As of October 10, 2025, the Plan Sponsor is in the process of correcting these delinquent contributions, including remitting the associated lost earnings to the Plan.
