NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the W.T. Byler Co., Inc. (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan for the Company was amended and restated effective October 21, 2021. This amendment and restatement bring the Plan into compliance with current legislative and regulatory changes. The original Plan was adopted effective September 15, 2001. The Plan is a salary deferral plan covering all full-time employees of the Company or other participating employers within the controlled group of affiliated employers. The full-time employees must have one year of service and be age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan remains a Safe Harbor Plan, as previously amended and restated effective January 1, 2016.

Administration

The Plan is administered by the Company. Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements.

Contributions

Participants may elect to contribute an amount up to 100% of eligible pre-tax compensation, not to exceed the limits of the Internal Revenue Code (IRC). Participants direct the investment of their contributions into various investment options offered by the Plan.

The plan includes a Safe Harbor matching contribution based on a basic match of 100% of the participant's salary deferral contributions up to the first 3% of a participant's compensation plus 50% of the participant's salary deferral contributions up to the next 2% of compensation. The Plan trustees may also approve discretionary profit sharing or additional matching contributions to participants who are employed on the last day of the year. For the year ended December 31, 2024, the Plan trustees made no discretionary matching or profit-sharing contributions above the Safe Harbor match.

Forfeited Amounts

During the years ended December 31, 2024 and 2023, there were no forfeitures.

Participant Accounts

Each participant's account is credited with the participant's contribution and earnings (losses) on those contributions. Each account is also credited by the Company's contribution and earnings (losses) on the Company's contribution. Each account is also charged with an allocation of fees and fee credits. Expense allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF THE PLAN - (continued)

Vesting

Participants are immediately 100% vested in their contributions (deferrals) plus actual earnings thereon. For all safe harbor contributions, the participant is also immediately 100% vested. Vesting in the Company's discretionary match over the safe harbor match and profit-sharing contributions plus actual earnings thereon is based on years of continuous service. Subject to the Break in Service rules, a former employee is reinstated as an eligible participant immediately upon rehire, if the employee had satisfied the Plan's age and service requirements prior to termination of employment. A participant is 100% vested after four years of credited service. An employee earns a vesting year of service in each year in which the employee completes 1,000 hours of service or per the Plan if hours are not available. The non-vested balance is forfeited upon termination of service.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in varying increments to any of the investment options offered by the Plan custodian. Additional investment information is available from the Plan custodian.

Payments of Benefits

Account balances in excess of \$5,000: On termination of service due to death, disability, or retirement, a participant or beneficiary may receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account or substantially equal installments as permitted by the plan.

Account balances of \$5,000 or less: On termination of service due to death, disability, or retirement, a participant or beneficiary will receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account.

Plan Termination

The Plan trustee terminated the Plan as of January 9, 2025. The Plan termination is subject to the provisions of ERISA. The Plan discontinued its contributions as of January 9, 2025, all participants became 100% vested in their accounts. All benefits will be distributed to eligible participants as soon as administratively possible.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value, see Note 8. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Plan Fees and Administrative Expenses

Plan fees and administrative expenses are generally paid by the Plan, unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain transactional fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are generally included within net investment earnings.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, there is one subsequent event that was identified that is required to be disclosed. On January 10, 2025, the Company was acquired by a subsidiary of Quanta Services, Inc., and the Plan was terminated on January 9, 2025. See Plan Termination at Note 1.

New Accounting Pronouncements

The Company considered the applicability and impact of all accounting standards updates (ASU's) issued by the Financial Accounting Standards Board (FASB). Most ASU's were assessed and determined to be either not applicable or are expected to have minimal impact on the financial position and results of operations of the Company.

NOTE 3 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 – TAX STATUS

The IRS has determined the Volume Submitter Profit Sharing Plan, used by W.T Byler Co., Inc 401(k) Plan, is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees by a letter dated June 30, 2020. The Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan is identified as a Volume Submitter Profit Sharing Plan and was restated effective October 21, 2021 to be identical to the Volume Submitter Profit Sharing Plan receiving the determination letter. The Plan trustees and the Plan custodian believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan trustees have analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN (Unaudited)

The Plan trustees have elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA of 1974. Accordingly, Ameritas Life Insurance Corp., the Plan custodian of the Plan, has certified to the completeness and accuracy of the following information included in the financial statements and supplemental schedule of assets (held at end of year) as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain Plan investments are managed by Ameritas Life Insurance Corp., the Plan custodian and record-keeper of the Plan. The Plan's participants paid \$2,008 in administration fees to Ameritas Life Insurance Corp. during 2024.

The Company paid certain administrative expenses of the Plan, including recordkeeping and audit fees. Two officers of the Company are the Plan trustees as defined by the Plan and therefore qualify as parties-in-interest to the Plan. There were no fees paid by the Plan for trustee services for the years ended December 31, 2024 and 2023.

NOTE 7 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under this framework are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quotes prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

NOTE 7 – FAIR VALUE MEASUREMENTS - continued

Pooled separate accounts: These investments are purchased and held by the Third-Party Administrator (TPA) as directed by the participant in the plan. These investments are public investment vehicles valued using the net asset value (NAV) provided by the Plan custodian of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within level 1 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In regards to the classification of investment options offered by the Plan, there were no reclassifications in or out of levels 1, 2, or 3 during the year ended December 31, 2024. The nature, risks, and investment objectives of the investments for which fair value is estimated using the NAV as a practical expedient can be found in the Plan's enrollment literature. These investments can be redeemed immediately and without a redemption notification period. As of December 31, 2024, there were no unfunded commitments associated with any of these investments.

NOTE 8 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

As of December 31, 2024 and 2023, the Plan held assets of \$603,139 and \$660,490, respectively, in a fully benefit-responsive investment contract with Ameritas Life Insurance Corp. Ameritas Life Insurance Corp. maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTE 8 – INVESTMENT CONTRACT WITH INSURANCE COMPANY - continued

The average yield for the Ameritas Guaranteed Account for the year ended December 31, 2024 was 3.47%. The weighted average interest crediting rate, as of December 31, 2024 was 3.29% and for December 31, 2023 was 3.35%. The new deposit rate as of January 1, 2024 has a guaranteed rate of 4.30%.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Ameritas Life Insurance Corp., represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligation may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan trustees do not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the contract issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the contract issuer.
