OPINION

We audited the accompanying financial statements of the Manganaro Employee Stock Ownership Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the Statement of Net Assets Available for Benefits as of December 31, 2024, the related Statement of Changes in Net Assets Available for Benefits for the period from January 3, 2024 (inception) to December 31, 2024, and the related notes to the financial statements.

NOTE 1 **DESCRIPTION OF PLAN**

The following description of the Manganaro Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan document or the Summary Plan Description for a more complete description of the Plan's provisions.

General

Manganaro North America, Inc. (Company) established the Plan effective January 1, 2024. The Plan operates as an employee stock ownership plan (ESOP), designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (Code), as amended, and subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

The Plan covers all administrative employees, except leased, non-resident alien, and union, of the Company who complete one year of service and are at least 21 years old. Notwithstanding the foregoing, any employee who is employed on December 31, 2024 and has accrued 1,000 hours of service during 2024 shall become eligible as of the later of January 1, 2024 or the date in which they first performed an hour of service. Employees become participants on the first entry date on or after the date they meet those requirements. Participants who do not have at least 1,000 hours of service during such Plan year or who are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

Payment of Benefits

No distributions from the Plan are made until a participant retires, dies, or otherwise terminates employment with the Company. Distributions are made in cash or Company common stock shares, at the discretion of the plan administrator.

Upon termination of service, death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the vested benefit of the participant's account or a series of annual, quarterly, or monthly installments generally over a period not to exceed five years.

Under the provision of the Plan, the Plan is obligated to repurchase participant shares, which are distributed under the terms of the Plan, unless the shares are repurchased by the Company.

Voting Rights

On certain corporate issues, each participant is entitled to exercise voting rights attributable to the shares allocated to the participant's account and is notified by the Trustee prior to the

time such rights are to be exercised. The Trustee is required to vote for any share for which instructions were not given by a participant.

Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend, suspend, or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account will be established for each participant. Each participant's account will be credited at least annually with an allocation of shares of the Company's stock and forfeitures of terminated participants' non-vested accounts.

Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive a contribution allocation. A variable contribution is allocated based on the participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning-of-year cash balance to all participants' beginning-of-year cash balances. Dividends are allocated to eligible participants based on the number of shares held on the record date the dividend is declared.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, the participant will vest in the participant's account balance based on the total years of service with the Company.

Participants are 100% vested in their account after three years of service.

Put Option

Under federal income tax regulations, the Company stock held by the Plan and its participants and not readily tradable on an established market or subject to trading limitations includes a put option. The put option is a right to demand the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Plan can elect to pay the purchase price over a period of time not exceeding five years. To the extent the payout exceeds five years, the payments beyond this period would earn interest at a reasonable rate on the unpaid installment balance. The purpose of the put option is to ensure participants have the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement, so they have the opportunity to withdraw part of the value of their investment in Company stock and convert it into investments, which are more diversified. Participants who are at least 55 years old, and who are either fully vested in the Plan or reach the tenth anniversary of the date they became a participant, may elect to withdraw a portion of their account. In each of the first four years, a participant may withdraw up to 25% of the number of shares allocated to the participant's account, less any shares previously withdrawn. In the fifth year and thereafter, a participant may elect 50% to be withdrawn.

Forfeitures

Forfeitures of terminated non-vested account balances are allocated to each eligible participant's account based upon the relation of the participant's compensation to total compensation for the Plan year.

NOTE 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation

Investments are stated at fair value. The fair value of the common shares of the Company is determined by an annual independent appraisal. The appraised value per share used to record the Company's common stock in the financial statements was \$252.51 as of December 31, 2024. The latest appraisal was as of December 31, 2024. See Note 3 for a discussion of fair value measurements.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Plan Expenses

Benefits are recorded when paid.

Plan Expenses

Expenses associated with administering the Plan are payable from the Plan unless the Company elects to pay all or a portion of these expenses. Costs generally associated with the sale or purchase of Company stock will be considered to constitute either an additional cost of Company stock purchased or a reduction of the proceeds from the sale.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date the financial statements were available to be issued.

NOTE 4 VALUATION OF INVESTMENTS

The Fair Value Measurements and Disclosures Topic of the Codification establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or

liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2024.

Investment in Employer Stock: The fair value of the common stock is based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques. The significant unobservable inputs used in the valuation included projected net cash flows, long-term growth rate, discount rate, weighted average cost of capital, and discount for lack of marketability.

NOTE 5 **NOTE PAYABLE – MANGANARO NORTH AMERICA, INC.**

On January 3, 2024, the Plan purchased 137,500 shares of common stock from the Company for a \$6,875,000 note payable. The unallocated shares of common stock are collateral for the note payable. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral times the ratio of current year payments to the total of all payments. This resulted in 3,055.5556 shares being released for the Plan year ended December 31, 2024. The note bears interest at 4.54% and requires annual principal and interest payments of \$360,921 through December 31, 2068.

NOTE 6 **INCOME TAX STATUS**

The Plan is a defined contribution plan designed to qualify under Section 401(a) of the Internal Revenue Code and, therefore, is not subject to tax under present income tax law. The Plan has applied to the Internal Revenue Service and is waiting for a determination letter. The Plan Administrator believes the Plan is qualified and the trust established under the Plan was tax exempt, under the appropriate sections of the Code.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions as of December 31, 2024.

NOTE 7 **RELATED-PARTY TRANSACTIONS**

The Plan pays consulting, recordkeeping, accounting, legal, appraisal, and other fees to parties in interest. There were no payments to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
