### Note 1 – Plan Description

---

The following description of the APG Polytech Savings Plan for Bargaining Unit Employees (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan sponsored by APG PolyTech, LLC (“the Company”) which covers hourly employees who have become eligible after 105 working days until amended during 2024 to 3 months of service. The service requirement may be waived if employed on May 1, 2018, or before, by M&G Polymers USA, LLC, or Polymer Sales & Logistics LLC and if a part-time eligible employee. The Plan does not cover employees not covered by a collective bargaining agreement, non-resident aliens, or salaried employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 15, 2024, certain revisions to eligibility conditions, compensation definitions, vesting schedules, and employer contributions were adopted, which included the adoption of a flexible discretionary match.

#### *Cash*

The Plan’s cash consists of funds held in accounts with the trustee which have not yet been allocated to participant balances.

#### *Contributions*

Participants may elect to contribute from compensation with certain exclusions, amounts designated as either pretax or after tax (Roth) contributions, as defined in the Plan. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Prior to amending the plan in 2024, the Company made employer matching contributions equal to 65% of the participant’s elective deferrals, up to 6% of the participant’s compensation. Effective March 15, 2024, the Company makes employer contributions at the following rates of eligible employee wages: 2.5% after three (3) months of service, 5% after four (4) years of service, and 7.5% after eight (8) years of service. The Company may also make nonelective contributions at the discretion of the employer. These contributions will be allocated in the same ratio as each participant’s compensation bears to the total compensation of all participants. All participants share in the allocations regardless of service completed during the plan year or employment status on the last day of the plan year. There were no nonelective contributions made in the current year.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, an allocation of Plan earnings, and allocated expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

Participants are immediately vested in their elective deferrals, rollover contributions, plus actual earnings thereon. Prior to March 15, 2024, vesting in the non-elective and employer matching contributions plus actual earnings thereon was based on years of service, in which a participant became 100% vested after three years of credited service. Following the amendment, participants are immediately vested in all contribution types plus actual earnings thereon. Participants will become 100% vested upon normal retirement, death, or disability while employed by the Company.

### *Notes from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum of \$50,000 or 50% of their vested account balance, whichever is less. Note terms range from one year to five years or no more than 30 years for the purchase of principal residence. The notes are secured by the balance in the participant's account and bear interest at 1% over the Prime Rate. Generally, principal and interest are paid through payroll deductions.

### *Payment of Benefits*

Upon retirement, death, disability, or termination, a participant can elect to receive a lump-sum or partial withdrawal equal to the vested value of his or her account. In-service distributions are allowed, as defined by the Plan document.

### *Administrative Costs*

The Plan permits administrative expenses to be allocated to all employees' accounts, individual accounts, or the employer may pay certain expenses.

### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,168 and \$3,905, respectively. These accounts will be used to pay Plan expenses or reduce employer contributions. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or to pay Plan expenses.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein and disclosures. Actual results may differ from those estimates.

### *Valuation of Investments and Income Recognition*

The Plan's investments are recorded at fair value except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

### *Benefit Payments*

Benefits are recorded when paid.

### *Subsequent Events*

Evaluation of subsequent events was considered through October 13, 2025, the date the financial statements were available to be issued.

---

## **Note 3 – Fair Value Measurements**

---

The Plan's mutual fund investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4 – Investment Contract with Insurance Company

Participants may also invest in one account that is a traditional investment contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment issuer is financially obligated to repay the principal and the specified interest rate to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the investment contract held by the Plan was \$302,524 and \$203,244 at December 31, 2024 and 2023, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investment has a portfolio investment rate design in which all deposits in the investment are credited with the same interest rate on a daily basis, with no set maturity. Such interest rates are reviewed on a quarterly basis for resetting. There is a minimum interest rate of 1.0%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination, or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or

any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

---

### Note 5 – Related Party and Party-in-Interest Transactions

---

Certain functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

The Plan permits expenses for recordkeeping, administrative, and consulting services to be paid for by the Employer, Plan assets and individual accounts when incurred directly by the participant. Expenses paid by Plan assets and individual accounts totaled \$6,546 for the year ended December 31, 2024.

---

### Note 6 – Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

---

### Note 7 – Tax Status

---

The Plan is an adoption of a pre-approved, non-standardized Defined Contribution plan sponsored by USI Consulting Group Incorporated effective March 14, 2021. The Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Company has obtained the most recent favorable opinion letter from the IRS dated June 30, 2020. The Company believes the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

---
