INDEPENDENT AUDITOR'S REPORT

To the Trustees of

Opinion

We have audited the financial statements of U.A. Local No. 159 Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of U.A. Local No. 159 Defined Contribution Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of U.A. Local No. 159 Defined Contribution Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about U.A. 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements for U.A. Local No. 159 Defined Contribution Plan (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

General - Investments are carried at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value), which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

The Plan’s investments in fully benefit-responsive investments contracts are reported at contract value. Contract value is the relevant measure to the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations or some other pricing method using unobservable inputs.

Inputs and Valuation Methods - In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes are presented below.

Mutual Funds: Mutual fund investments are held through unitized investment options, which are valued using the net asset value (“NAV”) per share (or its equivalent) as a practical expedient. These investments do not have readily determinable fair values and are not classified within the fair value hierarchy. The NAV is provided by the fund manager and is based on the fair value of the underlying assets held by the fund, less its liabilities. The NAV-based investments are redeemable at NAV under normal market conditions and do not have significant restrictions on redemption. The use of NAV as a practical expedient is considered appropriate for these investments as it represents the price at which the Plan would transact with the fund under current market conditions.

Common/Collective Trust: The Plan was invested in the Vanguard Retirement Savings Trust. This trust invests in fully benefit-responsive investment contracts. The fair value of the Vanguard Retirement Savings Trust has been estimated using the NAV of the investments as a practical expedient to estimate fair value. This investment is a direct filing entity with the Department of Labor; therefore, information regarding the investment strategy is not disclosed. Participant-directed redemptions have no restrictions. Units of the trust can be redeemed on a monthly basis. There were no unfunded commitments related to this investment at December 31, 2024 and 2023. As of December 31, 2024 the Plan fully liquidated its interest in the Vanguard Retirement Savings Trust.

Valuation Methods, Consistency - The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. The Plan presents, in the statements of changes in net assets available for benefits, the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Contributions Receivable

Contributions due and not paid prior to year-end are recorded as contributions receivable. Allowance for credit losses for contributions receivable is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Participant Withdrawals and Payments

Benefits are recorded when paid.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in mutual funds and a common/collective trust. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The Plan was established to provide retirement benefits for eligible employees. The Plan is financed by contributions from employers and participants and by the net earnings of the investments of the Plan. The Plan is a defined contribution plan covering all eligible employees whose employment is subject to the terms and conditions of various collective bargaining agreements between Local Union 159 of the United Association of Journeymen and Apprentices of Plumbing and Pipe Fitting Industry of the United States and Canada, AFL-CIO and various associations of employers and individual employers engaging in the plumbing and pipe fitting industry in the San Francisco Bay Area. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Employers contribute a specified amount per hour for each hour worked by each of their employees in covered employment to the Plan.

Pursuant to the collective bargaining agreements, a participant may elect to enter into a written wage reduction agreement. The wage reduction agreement shall provide that the participant agrees to accept a reduction in wages from his or her employer. The total compensation deferral may not exceed the limitations prescribed by law. In accordance with such wage reduction agreement, the employer shall make monthly employee contributions to the employee's account on behalf of the participant for each such month in an amount equal to the total amount by which the participant's compensation from the employer was reduced during the month pursuant to the wage reduction agreement.

If any distribution to a participant remains unclaimed for three years from the date of notification, the trustees may declare the benefits to be forfeited. These benefits shall revert to the general assets of the Plan but shall be restored should a valid claim be made.

Participants are fully vested in their accounts as of the first day on which they participate in the Plan.

The Plan's custodian and recordkeeper, Empower Trust Company, maintains a separate account for each participant consisting of the sum of the amount contributed on the participant's behalf by any individual employer plus participant contributions (if any) plus the pro rata share of investment earnings and asset appreciation or depreciation minus the pro rata share of expenses of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants may change their investment options at any time. Participants must evaluate their own investment goals and objectives and choose the investments best suited to achieve those goals and objectives. Poor investment performance by the investments selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

The Plan provides for loans to participants. The maximum loan amount is the lesser of \$50,000 or 50% of the participant's vested interest in the Plan, up to \$50,000. Effective May 1, 2018, the trustees may authorize loans to a participant receiving a pension under the U.A. Local No. 159 Defined Benefit Plan of the greater of the 100% of the first \$10,000 of the participant's vested interest in the Plan or 50% of the participant's vested interest in the Plan, up to \$50,000. No loan shall be made to a participant receiving a pension under the U.A. Local No. 159 Defined Benefit Plan unless it is determined that the participant is creditworthy. A participant may have only one outstanding loan at a time. Five years is the maximum length of the loan. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which is determined periodically by the Board of Trustees. Principal and interest are paid ratably through monthly payments made directly by the participants. During the years ended December 31, 2024 and 2023, loans of approximately \$23,000 and \$31,000, respectively, were deemed to be distributed because participants failed to meet the repayment requirements of their loans.

The Plan also provide a hardship loan program that allows participants to borrow against their accounts to satisfy the immediate and heavy financial need, as outlined in the summary Plan description, if they qualify. Distributions under the hardship loan program shall not exceed the lesser of the amount of the participant's elective contributions shown as of the last annual valuation, or the amount of financial need shown.

Participants should refer to the summary plan description for more information.

3. PRIORITIES UPON TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right to terminate the Plan subject to the provisions of ERISA. Upon the Plan's termination, any and all monies remaining in the Plan, after payment of all expenses and obligations, shall be expended and used for the continuation of the type of benefits provided by the Plan.

4. TAX STATUS

The Plan obtained its latest determination letter, dated August 20, 2015, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of Internal Revenue Code Sections 410(b) and 401(a). The Plan has been amended since applying for the determination letter; however, the trustees believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the trustees believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan entered into a fully benefit-responsive guaranteed income fund contract with the Prudential Retirement Insurance and Annuity Company (“Empower”, or “The insurance company”). The insurance company maintains the contributions in a general account. The account is credited with earnings at guaranteed crediting rates and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Generally, there are no circumstances that could limit the ability of the Plan to transact at contract value or which would result in benefits to be paid out over an extended period of time. There are not any events that allow the issuer to terminate the contract and which require the Plan Sponsor to settle an amount different than contract value paid either within 90 days or over time.

The Plan has determined that the contract value of this fund represents its fair value because there are not any specific securities in the general account that back the liabilities of this annuity contract and it would be inappropriate to look to the market value of the securities within the insurer’s general account to determine a fair value. Also, because the Plan has the right to receive interest at crediting rates which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract, there are not any known cash flows that could be discounted. As a result, the contract value represents the fair value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

7. FUNDING POLICY

The participating employers contribute such amounts as are specified in the collective bargaining agreements. In addition, Plan participants can elect wage deferrals, subject to certain IRS limitations.

8. RELATED-PARTY TRANSACTIONS

The Plan is related to U.A. Local No. 159 (the “Local”), as a sponsor to the Plan, and through common officers and trustees. The Plan reimburses the Local for costs associated with the administration of the Plan. During each of the years ended December 31, 2024 and 2023, the Plan reimbursed the Local \$6,192.

Employer contributions for the Local-related trust funds are remitted by employers with one check and deposited into a single bank account, under the control of the U.A. Local 159 Pension Trust Fund. On a monthly basis, the contributions are allocated by the Administrator and transferred to each related trust fund; any amounts allocated to the Plan and not yet transferred have been recorded as a receivable on the statements of net assets available for benefits. The Plan is related to the other Local-related trust funds through common trustees. As of December 31, 2024 and 2023, \$191,597 and \$151,068, respectively, was due from the U.A. Local 159 Pension Trust Fund.

9. SUBSEQUENT EVENTS
