We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Plan Description

The following description of the KMW Group, Inc. Profit-Sharing and Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a multiple-employer, defined contribution profit-sharing and 401(k) plan covering full-time employees of KMW Group, Inc. (the Company) and its subsidiaries, Skytron, LLC and Great Lakes Marine, LLC. Matrix Trust Company (Matrix) served as trustee of the Plan until April 1, 2024. As of April 1, 2024, Empower Trust Company, LLC (Empower) serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Eligibility*

Full-time and certain long-term, part-time employees become eligible to participate in the Plan and make deferral contributions after 90 days of employment, with monthly entry dates. Participants can elect to make all or a portion of their deferral as a Roth (after-tax) contribution. Certain employees are eligible to receive Company discretionary contributions if they have eligible Plan compensation. Certain employees are also eligible to receive Company discretionary contributions if the employee retires, becomes disabled, or dies during the Plan year.

#### *Contributions*

Eligible employees are automatically enrolled to defer 3% of eligible compensation, unless a different percentage is elected. The deferral percentage is automatically increased by 1% annually, up to a maximum of 12%. The Plan provides for elective deferral contributions by employees in an amount up to the maximum amount allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company provides a safe harbor nonelective contribution to each eligible participant equal to 3% of eligible compensation. For 2024 and 2023, the Company made safe harbor nonelective contributions of approximately \$509,000 and \$453,000, respectively.

In addition to the Company's safe harbor nonelective contributions, the Company may provide a discretionary matching contribution, with the amount of the contribution to be determined each year. For 2024 and 2023, the Company made discretionary matching contributions equal to 20% of the first 5% of employee contributions. For 2024 and 2023, the Company made discretionary matching contributions of approximately \$132,000 and \$102,000, respectively. The Company may also make a discretionary profit-sharing contribution. In 2024 and 2023, the Company made profit-sharing contributions of approximately \$1,188,000 and \$1,072,000, respectively.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, forfeitures, and Plan earnings or losses, and charged with an allocation of

administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

### ***Vesting***

Participants are immediately vested in employee salary deferrals, rollover contributions, and the Company's safe harbor nonelective and matching contributions, plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts, plus actual earnings thereon, are subject to the following vesting schedule below:

### ***Notes Receivable from Participants***

Participants are eligible to borrow up to one-half of their vested account balances not to exceed \$50,000. The interest rate on loans outstanding at December 31, 2024 range from 4.25% to 9.50% (Prime + 1%). Loans are secured by the participant's vested account balance. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the loan is used for the purchase of a principal residence. Participant loans are limited to a maximum of three loans per participant.

### ***Payment of Benefits***

Upon termination of service, death, disability, retirement, or age 59½, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or transfer the amount equal to the value of the participant's vested interest to an eligible retirement plan for the benefit of the participant.

### ***Forfeitures***

Forfeitures resulting from the non-vested portion of accounts of participants who terminate prior to being fully vested are allocated to remaining participants as additional employer contributions. Forfeitures applied in 2024 and 2023 were approximately \$79,000 and \$92,000 respectively. The balance of forfeited non-vested accounts as of December 31, 2024 and 2023 was approximately \$66,000 and \$79,000, respectively.

### *Administrative Expenses*

The Company provides certain administrative services, which have not been charged to the Plan. Fees incurred as a result of participant-directed transactions (e.g., participant loans origination and distribution fees) are charged directly to the participant's account. Certain administrative expenses of the Plan are allocated pro-rata to participant accounts.

## **2. Significant Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements have been prepared under the accrual method of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Contributions Receivable*

Employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit-sharing contributions are recorded in the relevant period in accordance with the terms in the Plan Document.

### *Notes Receivable from Participants*

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balances plus unpaid interest. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Plan Document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Subsequent Events*

Subsequent events were evaluated through August 21, 2025, the date the financial statements were available to be issued.

## **3. Fair Value Measurements**

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets in active markets.

*Level 2* - This level consists of inputs to the valuation methodology that include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

*Level 3* - This level consists of inputs to the valuation methodology that are both significant to the fair value measurement and unobservable.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following valuation methodologies were used to measure the fair value of the Plan's investments:

*Common/Collective Trust (CCT)* - The fair value of the Plan's interest in the CCT is based on information reported by the issuer, the OneAmerica Stable Value Fund, at year-end. The fair value determined is based on the net asset value (NAV). The NAV is based on the value of the underlying assets owned by the CCT, minus its liabilities, then divided by the number of shares outstanding within the fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There is no restriction in place with respect to the daily redemption of the CCT and there are no unfunded commitments.

*Mutual Funds* - These assets are valued at quoted market prices in an exchange and active market, which represent the NAV of shares held by the Plan.

*Life Insurance Policies* - These assets are valued based on the cash surrender value of the policies.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The tables below set forth the Plan's investments by level within the fair value hierarchy. There have been no significant transfers into or out of Levels 1, 2, or 3.

## **4. Information Certified by the Plan's Trustees**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by qualified institutions, Matrix Trust Company for the period from January 1, 2023 to March 31, 2024 and Empower Trust Company, LLC for the period from April 1, 2024 to December 31, 2024.

## **5. Related Party and Party-in-Interest Transactions**

Certain Plan investments are in funds managed by an affiliate of OneAmerica Financial Partners, Inc. (OneAmerica). These transactions qualify as party-in-interest transactions until April 1, 2024.

In 2024 and 2023, fees paid by the Plan to parties-in-interest totaled \$76,469 and \$44,419, respectively. Notes receivable also qualify as party-in-interest transactions.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions, plus actual earnings thereon.

### 7. Income Tax Status

The Plan has adopted a pre-approved profit-sharing plan document with Cash or Deferred Arrangement (CODA). The Internal Revenue Service (IRS) has determined and informed CCH Incorporated, DBA ftwilliam.com, in an opinion letter dated June 30, 2020, that the profit-sharing plan is qualified, and is tax-exempt, in accordance with applicable sections of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has since been amended; however, the Plan Administrator is not aware of any course of action or series of events that might adversely affect the Plan's qualified status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
