## INDEPENDENT AUDITORS' REPORT

**To the Plan Administrator

**Note 1 - Description of Plan**

The following description of the Standard Enterprises, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution Plan covering all full time employees of Standard Enterprises, Inc. and related companies (the Company) who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year participants may contribute up to the maximum allowed by law of their pretax annual compensation as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may make rollover contributions from other qualified Plans. The Company may discretionarily match up to 4% of the participant's annual compensation as safe-harbor contributions. The Company may also make additional profit sharing contributions at the option of the Board of Directors. Participants direct the investments of their contribution and any matching contribution into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and common and collective trusts with various underlying mutual funds as investment options.

**Participant Accounts**

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses generally on a per-transaction basis. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately fully vested in their contribution and any employer safe-harbor contribution accounts plus the earnings thereon. Generally, the Company's retirement contributions plus actual earnings thereon are vested at the rate of 20% per year of continuous service and are fully vested after six years of service, with accelerated vesting in certain circumstances.

**Payment of Benefits**

For termination of services due to reasons other than death, a participant may receive the value of the vested interest in his or her account as a lump-sum payment or in periodic installments of substantially equal amounts over a period between 5 and 20 years. In the event of a participant's death, the beneficiary may receive the value of the vested interest in the participant's account in a lump-sum payment or in periodic

installments of substantially equal amounts over a period elected by the beneficiary, not to exceed the beneficiary's life expectancy.

**In-Service Withdrawals**

Subject to certain limitations, a participant may withdraw all or part of their deferral contributions accounts and rollover accounts prior to meeting normal distribution requirements. A participant who is an employee and attained age 59½ may make withdrawals from his or her vested accounts prior to meeting normal distribution requirements. Certain qualifying hardship withdrawals may be made from the elective deferral portion of their account and vested matching and retirement contributions in accordance with the provisions of the Plan.

**Forfeitures**

Forfeitures can be used to pay Plan expenses and/or to reduce the employer's matching contributions. There were no forfeitures applied during the Plan year.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP generally requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at estimated fair value using the Net Asset Value Practical Expedient. See Note 4 for further information regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefits are recorded when paid.

**Note 3 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the balance of each participant's account would become 100% vested.

**Note 4 - Investments**

The Plan's investments are held in a trust account by Empower Retirement LLC and consist of units of interest in common/collective trust funds and pooled separate accounts with Registered Investment Companies as underlyings. During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) increased in value by \$1,349,949.

All of the Plan's investment assets are measured using the net asset value practical expedient. Participant transactions (purchases and sales) may occur daily. The mutual funds have no unfunded commitments and are generally redeemable daily. If the Plan initiates a full redemption of the Pooled Separate Accounts, the issuer reserves the right to require twelve months notification in order to ensure the underlying securities are liquidated in an orderly business manner.

*Pooled Separate Accounts:* Unregistered pooled separate accounts managed by Empower Retirement LLC are divided into investment divisions called “Sub-Accounts”. Each Sub-Account invests in shares of an underlying publicly traded mutual fund; such mutual funds are deemed to be actively traded. Sub-Account values are measured in terms of ‘Accumulation Units’. The Accumulation Units of a Sub-Account are assigned a unit value on a daily basis, at the end of each day the New York Stock Exchange (NYSE) is open for trading and is valued using the underlying fund’s net asset value (NAV) as adjusted for any daily mortality and expense risk and administrative charges as applicable.

*Common/Collective Trust Accounts:* Common/Collective Trust accounts are valued based on the Plan’s interest, represented by investment units, in the underlying investments held within the trust that are traded in an active market by the Trustee.

**Note 5 - Tax Status**

On March 31, 2020, the Internal Revenue Service (IRS) stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The prototype Plan has been amended since receiving the determination letter, and the Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon by examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the Plan’s financial statements. The Plan is subject to certain routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 6 - Disclosures Regarding Concentrations**

A certain amount of the Plan’s mutual fund assets are invested in pooled separate accounts managed by Empower Retirement LLC (Empower). Due to the nature of the investment in mutual funds, there is no guaranty or insured portion of the investment. All of the investment would be considered at risk. However, by diversification of the investment portfolio, the Plan Administrator has attempted to minimize the risk of loss the Plan would suffer due to market volatility.

**Note 7 - Party-in-Interest and Prohibited Transactions**

Certain Plan investments are shares of mutual funds managed by Empower. Empower is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Custodian amounted to \$31,399 for the year ended December 31, 2024.

Department of Labor regulations require participant contributions to be remitted to the Trust in a timely manner, generally 5 business days or less. In one instance the Sponsor failed to timely remit \$14,607 in participant contributions.

**Note 8 – Subsequent Events**

Management of the Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.
