Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of H.S. Swann, James W. Wills, Jr. Employees' Value Sharing Opportunity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 PLAN DESCRIPTION

The following description of the H.S. Swann, James W. Wills, Jr. Employees' Value Sharing Opportunity Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan, was established on December 11, 1953. The Plan covers substantially all full-time, part-time, and seasonal employees of The Wills Group, Inc., SMO, Inc., Dash In Food Stores, Inc. and Southern Maryland Oil, Inc. (collectively, the Company). A participant is eligible the first day of the month upon attaining 18 years of age and completing 60 days of continuous employment with the Company. Entry dates are the first day of each month following attainment of eligibility. Employees who are members of a collective bargaining agreement, leased, or self-employed are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute from 2% to 100% of their annual eligible compensation, as defined by the Plan. Newly eligible participants are automatically enrolled at a deferral rate set at 4%. The Plan allows for automatic increase of deferral percentages. Auto increase applies to those with contributions less than 6% and were auto enrolled or elected auto increase. Eligible participants will be auto increased by 1% on January 1 of each plan year up until 6%. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants who have attained 50 years of age before the end of the Plan year, are eligible to make catch up contributions. Catch up contributions are not eligible for purposes of calculating Company discretionary matching contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may decide to make a discretionary matching contribution and a discretionary profit-sharing contribution to the Plan. During the years ended December 31, 2024 and 2023, the Company elected to make safe harbor matching contributions of 116.67% of a participant's contribution up to 4% of eligible annual compensation and an additional matching contribution of 116.67% of a participant's contribution which exceeds 4% up to 6% of a participant's eligible annual compensation. In addition, the Company contributed a profit sharing contribution equal to \$5,000 and \$10,000 for each eligible participant for the years ended December 31, 2024 and 2023, respectively. Participants are eligible for the discretionary profit-sharing contribution if they meet the eligibility requirements above, are employed on the last day of the Plan year and have worked 1,000 hours during the year.

Contributions (Continued)

At the end of each plan year, unless a participant is a "grandfathered frozen pension plan" participant (as described below), the Company will also make an additional basic contribution equal to a certain percentage of a participant's eligible annual compensation, based on the table below:

<u>Completed Years of Service</u>	<u>Percentage of Compensation</u>
9 or Less	2%
10 to 19	4%
20 or More	6%

A participant is not required to defer any compensation to the Plan in order to receive this contribution from the Company; however, they must have met eligibility requirements above.

Effective January 1, 2008, if a participant is a "grandfathered frozen pension plan" participant, he/she is not eligible to receive the Company basic contribution under this Plan. A "grandfathered frozen pension plan" participant is defined as a participant who is still entitled to accrue benefits under the otherwise frozen Wills Group, Inc. Employees' Pension Plan (Pension Plan), because as of December 31, 2007, he/she either: a) attained age 55 with at least 10 years of service; or b) has completed at least 20 years of service for Pension Plan vesting purposes.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. All Company contributions are fully vested when such Plan contributions are made.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loans must be repaid in five years unless the proceeds are used to acquire a primary residence, which then must be re-paid in 10 years. The loans are collateralized by the balance in the participants' account and bear interest at an interest rate equal to prime rate plus 1%. Principal and interest are repaid through payroll deductions based upon an established amortization schedule.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant with a vested balance of less than \$5,000 will receive a lump sum distribution. Participants or their beneficiaries who have a balance greater than \$5,000 may elect to receive the total vested balance in a lump sum distribution or installment payments. Participants may withdraw voluntary contributions from their accounts by reason of financial hardship under specific guidelines set forth in the Plan. In-service withdrawals are also allowed for participants who are at least 59½ years old.

Forfeited Accounts

The amounts of forfeitures available were \$69 and \$73 at December 31, 2024 and 2023, respectively. These accounts will be used to satisfy future plan administrative expenses and reduce future Company contributions. The Company used \$73 and \$-0- to pay plan administrative expenses for the years ended December 31, 2024 and 2023, respectively. No forfeitures were used against Company contributions for the years ended December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Pension and Value Sharing Administration Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of plan assets, distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Audit related fees are paid directly from the forfeiture account and administrative budget account. The Plan received \$22,818 and \$19,705 of shared revenue, for which \$21,248 and \$19,300 was used to pay expenses during the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the shared revenue account totaled \$2,824 and \$1,254, respectively. The net of this activity has been recorded as other income on the statements of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INVESTMENTS

T. Rowe Price Trust Company (T. Rowe), the trustee of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observed for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at the NAV of the units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their entire accounts.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by T. Rowe, the trustee as defined by the Plan as of December 31, 2024 and 2023. These investments qualify as party-in-interest investments/transactions. Fees incurred by the Plan for the investment management services are included in administrative expenses. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 RISK AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 TAX STATUS

The Plan is placing reliance on an opinion letter dated August 19, 2020, received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
