Scope and Nature of the 2024 ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Spokane Digestive Disease Center P.S. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Spokane Digestive Disease Center P.S. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for more complete information of the Plan's provisions.

- a. **General** – The Plan is a participant directed, defined contribution profit-sharing plan covering substantially all employees of Spokane Digestive Disease Center P.S. (the Company), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan's asset management and custodian responsibilities are performed by Empower Trust Company, LLC, and Empower Annuity/ Insurance Company of America (Empower). The Board of Trustees is responsible for oversight of the Plan. The Plan's third-party administrative duties are performed by Randall & Hurley, Inc. The Company's human resources department oversees the day-to-day operations of the Plan.

- b. **Eligibility** – Employees are immediately eligible to participate in the Plan to make deferrals. Participants are able to enter the Plan on the first day of the following month after meeting eligibility requirements.

Employees who have attained age 18 and completed at least one year of service and 1,000 hours are eligible to receive employer contributions. Entry dates for employer contributions are January 1 or July 1 after meeting eligibility requirements.

Contributions – Participants may contribute up to 100% of qualified compensation, as defined by the Plan, up to a maximum amount allowed by the Internal Revenue Code (IRC). Participants may also voluntarily elect to contribute after-tax Roth contributions, not exceeding a specific dollar amount determined by applicable law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to regulatory limits.

The Company makes a safe harbor contribution equal to 100% of the first 5% of eligible compensation of each Plan participant. Effective January 1, 2024, the safe harbor nonelective contributions were changed from 5% to 3%. The Company may make an additional discretionary matching contribution and/or a discretionary profit-sharing contribution. The discretionary profit-sharing contributions totaled \$195,249 and \$218,398 for the years ended December 31, 2024, and 2023, respectively. Safe harbor contributions totaled \$299,293 and \$317,063 for the year ended December 31, 2024, and 2023, respectively.

- c. **Participant accounts** – Separate accounts are maintained for each participant. Each participant's account is credited with the participant's contribution, an allocation of any Company contributions, the participant's portion of earnings (losses), and charged with an allocation of administrative expenses. The Company's discretionary contributions are allocated to each participant's account based on a formula as determined by the Board of Trustees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 – Description of the Plan (Continued)

- d. **Vesting** – A participant is 100% vested in their participant elected contributions, the employer safe harbor contributions, and actual earnings thereon. For vesting of the employer discretionary contributions, an employee must complete 1,000 hours of service during a vesting computation period in order to receive credit for one year of service. Effective January 1, 2024, employer discretionary contributions are vested based on a one-five year graded vesting schedule (prior years subject to two-year vesting schedule). Aside from normal vesting periods, a participant can also become fully vested upon reaching age 55, upon the participant's death, or upon permanent disability.
- e. **Forfeitures** – Forfeitures are the nonvested portion of a participant's account that are lost upon termination of employment as specified in the plan agreement. The forfeiture account is available to pay administrative expenses or reduce Company contributions under the Plan provisions. Forfeitures of \$15,990 and \$8,483 were available at December 31, 2024 and 2023, respectively. No forfeitures were used during the year ended December 31, 2024.
- f. **Notes receivable from participants** – The Plan allows for participant loans (notes receivable from participants). Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes are secured by the balance in the participants' account and bear interest at rates of 1% over the prime interest rate. The maximum note term is five years, unless the note is used for the purpose of acquiring a principal residence of the participant, in which case the repayment period may be longer. Principal and interest are paid ratably through payroll deductions.
- g. **Payment of benefits** – Upon termination of service due to retirement after reaching normal retirement age of 55, separation, disability, death, termination, or other reasons, a participant or their beneficiary may elect to receive a lump-sum payment equal to the vested balance in his or her account. Distributions from the Plan after termination for reasons other than death may be made as partial withdrawals as elected by the participant. Withdrawals due to financial hardship are not permitted.
- h. **Plan termination** – Although it has not expressed intent to do so, the employer has the right at any time to terminate the Plan and discontinue its contributions, subject to provisions of ERISA. In the event of Plan termination, participant accounts become fully vested.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.
- b. **Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that may affect certain amounts and disclosures. Actual results could differ from those estimates.

Note 2 – Summary of Significant Accounting Policies (Continued)

- c. **Investment valuation and income recognition** – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments consists of both realized gains or losses and unrealized appreciation or depreciation of the investments held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at the unpaid principal balance plus unpaid accrued interest. Interest income is recorded on the accrual basis. The Plan classifies all notes receivable from participants with no payments received for six months as in default. Defaulted notes receivable from participants are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits. No allowance for credit losses as has been recorded as of December 31, 2024 or 2023.

- e. **Payment of benefits** – Benefits are recorded when paid.

- f. **Administrative expenses** – Certain expenses of maintaining the Plan are paid directly by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses paid to investment advisors and others described in each fund prospectus or other published documents are deducted by the investment funds or accounts prior to the allocation of the Plan’s investment earnings activity and are therefore included in net appreciation/depreciation of fair value of investments in the statement of changes in net assets available for benefits. Participants are also charged for expenses specifically incurred by the participant.

- g. **Subsequent events** – Plan management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued and concluded no other events have occurred which require disclosure.

Note 3 – Risks and Uncertainties

The Plan provides for investments in various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect a participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 4 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 – *Short-term funds, common stocks, mutual funds, and exchange-traded funds (ETF)* - Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Level 2 – *Fixed annuities* – The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract as calculated by the annuity provider. All of these inputs are generally considered obtainable/observable through the review of existing contracts and readily available financial information on the websites of the issuing financial institutions.

Note 4 – Fair Value Measurements (Continued)

Level 2 – Corporate bonds and U.S. securities – Amounts reported are valued by independent third-party pricing agents using either a quoted price in an active market for the identical security, or direct and/or indirect observable inputs for the security. Observable inputs include reported trades (where applicable), benchmark yields, dealer quotes, issuer spreads, bids, offers, benchmark securities, and others.

Level 3 – The Plan had no investments that are classified as Level 3 for the years ended December 31, 2024 or 2023.

Investments measured at net asset value (NAV):

Business Development Companies are valued at the NAV provided by the investment manager.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

North Haven Private Income's investment objective is to achieve attractive risk-adjusted returns via current income and, to a lesser extent, capital appreciation by investing primarily in directly originated senior secured term loans issued by U.S. middle market companies backed by private entity sponsors.

Note 6 – Tax Status

The Plan document is a volume submitter profit-sharing plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Party-in-interest Transactions

Certain Plan investments are managed by Empower, the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Empower and other service providers qualify as party-in-interest transactions. The Plan also allows for notes receivable from participants, which are also party-in-interest transactions.
