Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Thrive Behavioral Health, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control - related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of assets held for investment purposes at end of year December 31, 2024 and delinquent participant contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1: Plan Description

The following description of Thrive Behavioral Health, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Thrive Behavioral Health, LLC (the Sponsor or Employer) on October 1, 2013 and restated January 1, 2016. The Plan is subject to the provisions of ERISA. Plan management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees, except union employees, nonresident aliens, and leased employees, are eligible to participate in the Plan upon hire. To receive employer discretionary matching, participants must complete one year of service, defined as 1,000 hours. Entry date for the employer discretionary match is the first day of the Plan year quarter coinciding with or next following the date the eligibility requirement is met. To receive employer safe harbor matching, participants must be 21 years of age and must complete one year of service. Entry date for the employer safe harbor matching is the first day of the Plan year coinciding with or next following the date the eligibility requirement is met.

Contributions

Individual accounts are maintained for each Plan participant. Each year, participants may contribute pretax or after-tax (Roth) compensation up to the maximum limit established by the Internal Revenue Code (IRC). Participants who are 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is a safe harbor plan and the Sponsor makes safe harbor matching contributions to all eligible participants equal to 100% of participant salary deferrals, not to exceed the first 4% of Plan compensation. In addition, the Sponsor may make discretionary matching contributions. For the year ended December 31, 2024, the employer made a safe harbor contribution of \$490,069.

Participants' Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) the Sponsor's safe harbor and discretionary matching contributions, if any, (b) Plan earnings (losses) and (c) charged with an allocation of any administrative expenses paid by the Plan. Expense allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Hardship Withdrawals

Hardship withdrawals are permitted in accordance with the Plan Agreement.

Vesting

Participants are immediately vested in their salary deferral, safe harbor matching, and rollover contributions. Vesting in employer discretionary matching contributions is determined by the following vesting schedule and is based on continuous service:

Less than 1 Year	0%
2 Years	20%
3 Years	40%
4 Years	60%
5 Years	80%
6 Years	100%

Regardless of the vesting schedule, participants become fully vested upon death.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive a partial amount or an amount equal to the value of the participant's vested interest in their account in either a lump-sum or annual installments at least equal to the required minimum distribution amount. For termination of service due to other reasons, a participant may elect to receive the value of the vested interest in their account as a lump-sum distribution. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 1/2.

Forfeitures

Forfeitures related to employer discretionary matching contributions are to be used to reduce future employer matching contributions, other than contributions that must be fully vested when contributed. At December 31, 2024 and 2023, there was no forfeiture balance and no amounts were used during the year ended December 31, 2024 to reduce the employer matching contributions.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years except for loans for purchase of a primary residence, which may be longer as determined by the Plan Administrator. The loans are secured by the vested balance in the participant's account and bear interest at a rate of 1% above prime at the time of the loan's origination and will remain fixed for the duration of the loan. Principal and interest are paid ratably through payroll deductions.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

Contributions Receivable

Contributions from the Employer and participants of the Plan are accrued in the period in which they become obligations under provisions of the Plan Agreement. The contributions not received by the Plan for the years ended December 31, 2024 and 2023 amounted to \$-0- and \$47,871, respectively, and are reported as receivables on the statements of net assets available for benefits. In the Plan's opinion, the balance of contributions receivable is fully collectible.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of the Plan, including administration of notes receivable from participants and payment of benefits, are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review

The Plan has evaluated events and transactions that occurred during the period from the date of the financial statements through October 13, 2025, the date the Plan's financial statements were available to be issued. There were no events or transactions that occurred during the period that materially impacted the amounts or disclosures in the Plan's financial statements.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds: Valued at cost, which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The custodian also certified to the completeness and accuracy of \$810,968 of net appreciation (depreciation) in fair value of investments, \$388,170 of interest and dividends, and \$4,277 of interest on notes receivable from participants during the year ended December 31, 2024.

Note 5: Tax Status

The Plan is a qualified volume submitter plan under the Internal Revenue Code (IRC) as per opinion letter dated March 31, 2014. The Plan has since been amended; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The previous three tax years remain subject to examination by the IRS.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their sponsor contributions.

Note 7: Rollover Contributions

In accordance with the Plan Agreement, qualified direct rollovers are permitted by the Plan. During the year ended December 31, 2024, \$7,031 of rollovers were contributed to the Plan.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are interests in registered investment companies managed by Capital Bank and Trust. Capital Bank and Trust is the custodian and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, any transactions with Pollard & Associates, Inc., the third-party administrator, and Wells Fargo Advisors, LLC, the investment advisor, also qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. During the year ended December 31, 2024, the Plan made direct payments for certain administrative expenses of \$104,834. The Sponsor pays any other fees related to the Plan's operation.

The trustees of the Plan are also participants in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
