Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Anna Jaques 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Prior to January 1, 2009, records were maintained at a contract, not plan, level; therefore, management has not maintained, and Metropolitan Life Insurance Company ("MetLife") did not provide, sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient



to determine the extent to which the financial statements have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan’s financial statements in accordance with auditing standards generally accepted in the United States of America (“GAAS”) and to issue an auditor’s report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Form 5500 - Schedule H, Part IV, Line 4(a) - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

Notes to Financial Statements

1. Description of Plan

The following description of the Anna Jaques 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Anna Jaques Hospital (the “Hospital”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Board of Trustees has delegated responsibility for oversight of the Plan to Beth Israel Lahey Health (“BILH”), who has delegated to the BILH Retirement Plans Committee the responsibility to oversee the plan, including administrative matters, and to determine the appropriateness of the Plan’s investment offerings as well as to monitor investment performance.

The plan sponsor and plan administrator is the Hospital. Upon the formation of BILH on March 1, 2019, the Hospital became an affiliate of BILH, its sole corporate member. BILH was formed through the combination of hospitals and other affiliates of three legacy health care systems based primarily in the Eastern Massachusetts market, including the former CareGroup system, the former Lahey Health System, and the Seacoast Health System.

Effective December 31, 2024, the Plan was restated and merged into the Beth Israel Lahey Health 403(b) Retirement Savings Plan and the sponsorship of the Plan was transferred to BILH. Concurrent with the merger, the assets of the Plan were transferred to the Beth Israel Lahey Health 403(b) plan as noted in the accompanying statement of changes in net assets available for benefits.

Eligibility

Employees who do not meet the definition of an excluded employee below are eligible to participate in the Plan. Excluded employees include nonresident aliens, employees who are eligible to make a cash or deferred election under an eligible governmental plan (within the meaning of Section 457) of the Hospital, part-time employees regularly scheduled for less than 20 hours of service in the eligibility period, and other per diem employees. Employees who have attained 21 years of age and have at least one year of service are eligible to receive employer matching contributions and discretionary non-elective contributions (with the exception of the previously described exclusions).

Contributions

Each year, participants may elect to contribute a specific percentage of their pretax annual compensation, as defined by the Plan, subject to certain limitations as required by the Internal Revenue Service (“IRS”). Participants may also elect to make Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Each year, the Hospital may elect to make discretionary non-elective contributions. A participant must be employed as of the last day of the plan year to be eligible for discretionary non-elective contributions. Employees enrolled in the Hospital's defined benefit plan are not eligible for these contributions. Discretionary non-elective contributions are made as a percentage of the participant's compensation. The allocated percentage is dependent on years of service as outlined in the plan agreement.

Participants direct the investment of their contributions into various investment options offered by the Plan. Employer contributions are allocated in the same manner as the participants' contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, their respective share of employer matching, an allocation of employer discretionary non-elective contributions, and an allocation of plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, deferrals, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. In the event of death, permanent disability, or retirement, a participant's employer contribution account becomes fully vested.

Vesting

Participants are vested immediately in the amounts attributable to their elective deferral contributions, rollover contributions, employer matching contributions, and actual earnings thereon. Vesting in employer discretionary non-elective contributions is based on a three-year cliff, and a participant is 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Each loan shall be repayable in substantially equal installments over a term not to exceed five years (or 15 years if used to purchase a primary residence) and bear a reasonable rate of interest at the Wall Street Journal prime rate, plus 1.0%. Principal and interest is paid in substantially equal installments over the term of the loan directly by the participants.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period not to exceed the participant's life expectancy. A participant whose vested account balance is \$5,000 or less and has not commenced receiving installment payments will automatically receive an immediate lump-sum distribution equal to their vested account balance.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need,

as defined by the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired, the forfeited contributions are reinstated. Forfeitures may be used to reduce future employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$51,169 and \$41,298, respectively. In 2024, no employer contributions or administrative expenses were reduced with forfeited accounts. Concurrent with the merger, the forfeited non-vested accounts were transferred to the Beth Israel Lahey Health 403(b) plan effective December 31, 2024.

2. Summary of Significant Accounting Policies

Annual Reporting Requirements

Prior to January 1, 2009, Metropolitan Life Insurance Company (“MetLife”), the former trustee of the Plan, maintained records at a contract level and not at the plan level. MetLife administratively decided not to provide accounting records and supporting documentation at the participant or plan level relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. As such, neither the Hospital nor Met Life have been able to produce sufficient records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity contracts and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan, with the exception of the fully benefit-responsive guaranteed investment contract and life insurance contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The BILH Retirement Plan Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

The Plan’s fully benefit-responsive guaranteed investment contract with Variable Annuity Life Insurance Company (“VALIC”) is valued at contract value because contract value is the amount

participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals and administrative expenses. See Note 5 for discussion of the guaranteed investment contract.

The Plan's investment in the life insurance contract is valued at cash surrender value. Cash surrender value is the amount which would be received in the event the investment is terminated or the insured event occurs. See Note 6 for discussion of the life insurance contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available for issuance.

3. Certified Investments

The plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AIG Federal Savings Bank ("AIG"), parent company of VALIC, the trustee of the Plan and a qualified institution, has certified the completeness and accuracy of all the investments and notes receivable from participants, except for the life insurance contract, reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related investment activity and interest income on notes receivable from participants reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board *Accounting Standards Codification* are described as follows:

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage

The Plan's holdings in the self-directed brokerage accounts consist of mutual funds valued at fair value, as determined by the closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Guaranteed Investment Contract

The Plan invests in a fully benefit-responsive guaranteed investment contract with VALIC. VALIC maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is included in the financial statements at contract value, as reported by VALIC. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The initial interest rate for any purchase payment is declared each month and is guaranteed for 12 months. At the end of the 12-month guarantee period, a renewal interest rate will be determined and guaranteed until the end of that calendar year. All future renewal rates are declared each subsequent January 1 and guaranteed through December 31 of that year.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts permit either the Plan or the insurance company to terminate the agreement with written notice. If, in the event of termination, the Plan were unable to obtain a replacement investment contract, withdrawing participants may experience losses if the value of the Plan's assets no longer covered by the contract is below contract value. The Plan may seek to add additional issuers over time to diversify the Plan's exposure to such risk, but there is no assurance the Plan may be able to do so. The combination of termination and an inability to obtain a replacement agreement could render the Plan unable to achieve its objective of maintaining a stable contract value. The terms of an investment contract generally provide for settlement of

payments only upon termination of the contract or total liquidation of the covered investments. Generally, payments will be made pro rata, based on the percentage of investments covered by each issuer.

6. Life Insurance Contract

The Plan invests in a life insurance contract with Transamerica Life Insurance Company totaling \$-0- and \$16,559 at December 31, 2024 and 2023, respectively. The investments are reported at cash surrender value, which is the amount that the policyholders would receive in the event their policies are voluntarily terminated.

7. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by VALIC and AIG. VALIC is the recordkeeper and custodian for the Plan; therefore, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan made direct payments to the third-party administrators in the amount of \$181,654. The Hospital pays directly any other fees related to the Plan's operations. Certain employees of the Hospital who participate in the Plan, perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants also qualify as party-in-interest transactions.

8. Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts. See Note 1 for discussion of the plan merger.

9. Tax Status

The Plan has adopted the VALIC Retirement Services Company pre-approved 403(b) plan. The pre-approved 403(b) plan received a favorable opinion letter from the IRS dated April 5, 2018, stating that the form of the pre-approved plan is qualified under Section 403(b) of the Internal Revenue Code ("IRC"), and therefore, the related trust is tax exempt. Although the Plan has been amended since the date of the letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment

securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Prohibited Transactions

As reported on supplemental schedule, Form 5500 - Schedule H, Part IV, Line 4(a) - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, certain participant contributions totaling \$354,114 in 2024 were not remitted to the Plan by the plan sponsor in a timely manner according to DOL regulations. Failure to segregate and remit contributions within the specified time-period is a prohibited transaction. Plan management is currently working on calculating the loss earnings to be restored to participants accounts resulting from the delinquent transmittal of participant contributions in accordance with the DOL's Voluntary Fiduciary Correction Program ("VFCP").
