## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following brief description of the Eugenio Maria de Hostos Charter School 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established to provide retirement benefits to employees of Eugenio Maria de Hostos Charter School (the School) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The School is the Plan sponsor. Nationwide Trust Company, FSB (Nationwide) was the custodian and recordkeeper of the Plan through October 2024. Effective November 1, 2024, Principal Trust Company (Principal) is the custodian and recordkeeper of the Plan. Rimkus Marciano & Associates is the third-party administrator for the Plan.

#### **Eligibility**

All employees of the School are eligible to begin salary deferrals as soon as administratively feasible after their date of hire, pursuant to a properly completed and valid salary deferral agreement entered into by the employee. Employees not participating in the New York State Teachers' Retirement System are eligible to receive discretionary non-elective contributions. The Plan excludes new employees from receiving the discretionary non-elective contributions until they have completed one year of service. Upon the employee's one year anniversary, the School makes discretionary non-elective contributions on behalf of eligible employees.

#### **Participant Contributions**

Participants may make voluntary pre-tax contributions in the form of salary reductions at a maximum contribution of the lesser of 100% of the participant's total eligible compensation for the plan year or the maximum amount permitted by the Internal Revenue Code (IRC).

#### **Employer Contributions**

The School may make discretionary non-elective contributions to the Plan on behalf of the eligible employees. In 2024 and 2023, the School's discretionary non-elective contributions were equal to 4.5% of the participant's annual compensation.

#### **Rollover Contributions**

The Plan will accept direct rollover contributions from a qualified plan or IRA, as defined by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, an allocation of Plan earnings/losses, and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF PLAN (Continued)

### **Vesting**

Participants are immediately vested in their voluntary and employer contributions, plus actual earnings or losses thereon.

### **Notes Receivable From Participants**

Plan participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and have a maximum of one outstanding loan. The minimum loan is \$1,000. Notes receivable must generally be repaid over a period not longer than five years for general loans and 15 years for residential loans. Notes receivable from participants are secured by their account balances and bear interest at the prime rate plus 1%.

### **Payment of Benefits**

A participant may withdraw any part of their vested account at any time after attaining age 65, or upon termination of service due to death, retirement, or other reasons. A participant or beneficiary may receive an amount equal to the value of the participant's vested interest in their account in a lump-sum amount.

### **Hardship Withdrawals**

Prior to age 59 ½, hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with the Internal Revenue Service (IRS) rules relating to hardships, which are uniformly applicable to all participants.

### **Plan Administration Costs**

Administrative expenses of the Plan are paid by the Plan Sponsor.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investments Valuation and Income Recognition**

Investments in mutual funds and money market funds are stated at fair value based on quoted market prices provided by the Plan's custodian, as of December 31, 2024 and 2023. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation on investments includes the Plan's gains and losses on investments bought, sold, as well as held during the year. All investments are participant-directed.

### **Risk and Uncertainties**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value Measurements**

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly, or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

A description of the Plan's investments within the hierarchy is provided in Note 3.

There were no changes in valuation techniques used during 2024 or 2023.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

### **Estimates**

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 3. INVESTMENTS

#### Certified Investment Information

In accordance with Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the following information was certified as complete and accurate by Nationwide, the custodian, as of December 31, 2023 and for the period of January 1, 2023 through November 1, 2024; and by Principal, the custodian, for the period November 1, 2024 through December 31, 2024. This information is included in the accompanying financial statements and supplemental schedule:

The following is a description of the valuation methodologies used for assets measured at fair value:

Money market funds are valued based on quoted market prices.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The mutual funds held by the Plan are deemed to be actively traded.

**3. INVESTMENTS (Continued)**

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. PLAN TERMINATION**

While the Plan Administrator has not expressed any intent to discontinue the Plan, it has the right to do so at any time, subject to the provisions of ERISA. In the event of the Plan's termination, participants would remain 100% vested in their accounts. All distributions would be made in accordance with any applicable requirements of the ERISA and the IRC.

**5. INCOME TAX STATUS**

The Plan adopted a volume submitter plan offered by FIS Business Systems LLC stating that the written form of the underlying specimen plan is qualified under Section 403(b) of the IRC. The volume submitter plan received an IRS Opinion Letter dated March 31, 2017, that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of December 31, 2024 and 2023, respectively.

**7. PARTY-IN-INTEREST TRANSACTIONS**

Nationwide was the custodian and recordkeeper of the Plan through October 2024. Effective November 1, 2024, Principal is the custodian and recordkeeper of the Plan. The School is the Plan Sponsor. FSC Securities provided investment management services through December 31, 2023. Effective February 1, 2024, Lawley Retirement Advisors provides investment management services. As such, transactions between Nationwide, Principal, the School, FSC Securities, Lawley Retirement Advisors, and the Plan qualify as party-in-interest transactions. Additionally, certain Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

**8. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 14, 2025 which is the date the financial statements were available to be issued.
