## Independent Auditor's Report

To the Participants and Beneficiaries  
Halley Engineering Contractors, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Halley Engineering Contractors, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1. Plan Description**

The following description of the Halley Engineering Contractors, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Halley Engineering Contractors, Inc. (the “Sponsor” or the “Company”) and effective January 1, 2014, who have completed one (1) year of service, and are not members of the following classes of employees: (a) leased employees; (b) union employees; and/or (c) non-resident aliens who have no earned income from sources within the United States of America. Eligible employees may enter the Plan on the earliest of the monthly enrollment dates following satisfactorily meeting eligibility criteria.

The Plan Administrator is responsible for oversight of the Plan. The 401(k) Investment Review Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Sponsor's management. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions:** Eligible participants may elect to make contributions to the Plan by means of a salary deferral agreement of up to 100% of their annual compensation, up to the maximum allowable amount under the Internal Revenue Code (the “IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may also make matching contributions, at its discretion. For the period from January 1, 2023 to December 31, 2024, the Company's Safe Harbor mandatory contribution percentage was 100% of the first 3% of each eligible participant's compensation, plus 50% of the amount of the participant's matched employee contribution that exceeded 3% of the participant's compensation but that did not exceed 5% of the participant's compensation.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments, as made available and determined by the plan administrator. Participants may change their investment options daily. The Plan currently offers various mutual funds as investment options (held by the plan in the form of pooled separate accounts) and an insurance company investment contract.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Each participant's account is reduced by any withdrawals or distributions and charged with an allocation of investment losses, if any, and administrative fees paid by the Plan. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. The portion of participants' accounts attributable to the Company's discretionary matching contributions become 100% vested after five years of credited service (at the rate of 20% per year), as defined in the Plan document. Eligible participants are 100% vested upon death, becoming disabled or reaching normal retirement age. Participants are immediately vested 100% in the Company's Safe Harbor matching contributions. The Company's Safe Harbor matching contributions were \$350,280 and \$292,249 for the years ended December 31, 2024 and 2023, respectively. Upon termination of employment, the non-vested portion of a participant's account is forfeited.

**Note 1. Plan Description (Continued)**

**Payment of benefits:** Upon retirement, total and permanent disability or other termination of service, a participant may elect to receive a lump-sum distribution equal to the participant's vested interest in his or her account. Upon termination, a participant's vested interest is distributed immediately as soon as administratively feasible as a lump-sum cash payment. Upon the death of a participant, the vested balance of the participant's account is distributed to the participant's beneficiary.

The Plan also allows for in-service distributions of fully vested participant deferrals in the event of financial hardship.

**Notes Receivable from Participants:** Participants may borrow from their account balances with interest charged at a rate fixed by the Plan, which remains in effect for the duration of the loan. Loan terms range from 1 to 5 years or may extend beyond 5 years if for the purchase of a primary residence. The maximum loan is the lesser of \$50,000 less the highest outstanding loan balance during the one-year period prior to the new loan application date, or 50 percent of the participant's account balance less any current outstanding loan balance. The loans are secured by up to one-half of the vested portion of the participants' account. Principal and interest are repaid through payroll deductions. As of December 31, 2024 and 2023, the Plan had notes receivable from participants with principal balances totaling \$339,968 and \$213,936, respectively.

**Forfeitures:** Forfeitures are used to reduce future employer contributions or pay Plan expenses. As of December 31, 2024 and 2023, there were \$3,882 and \$2,414, respectively, of forfeited non-vested accounts. Also, for the years ended December 31, 2024 and 2023, no forfeitures were used to reduce employer matching contributions or to pay administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

**Basis of accounting:** The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America except for benefits paid to participants, which are recorded on the cash basis.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Investment Review Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Note 2. Summary of Significant Accounting Policies (Continued)**

**Contributions:** Contributions from participants and the Company's matching contributions are recorded in the year in which the participant contributions are withheld from amounts paid. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed annually under the IRC are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Participant Withdrawal from the Plan:** There were no participants who left the Plan at December 31, 2024 that had requested a distribution of their account balance.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Note 3. Deemed Distributed Loans**

A "Deemed Distributed Loan" ("DDL") occurs when a participant misses a loan payment for any reason other than certain types of leave of absence and fails to make it up by a specified date, or the term for repaying a loan expires without full payment of the outstanding amount by a specified date. At that time, the participant is taxed on the outstanding amount, including applicable interest accrued to-date, as if it had been distributed. Per IRS instructions, the Plan must continue to treat the DDLs as outstanding loans, while the Plan's 5500 Schedule H, I or SF must exclude DDLs from the assets reported. For the years ended December 31, 2024 and 2023, deemed distributed loans totaled \$1,426 and \$9,115, respectively.

**Note 4. Information Certified and Provided by Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the years then ended that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company ("Voya"), the trustee of the Plan.

**Note 5. Fair Value Measurements**

Accounting principles generally accepted in the United States of America establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under that framework are described below:

**Level 1:** Inputs are quoted prices in active markets.

**Level 2:** Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

**Level 3:** Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Pooled Separate Accounts:** Valued at the net asset value (“NAV”) of shares in each account held by the Plan at year-end. The NAV is not a public-quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value.

**Note 6. Investment Contract with Insurance Company**

The Plan holds a group fixed annuity contract, which is a fully-benefit responsive contract with Voya. The contract is a traditional investment contract that offers participants a conservative option and provides a competitive interest rate. Both principal and interest payments, minus applicable fees and expenses, are guaranteed by Voya. Because the annuity contract meets fully benefit-responsive investment contract criteria, it is reported at contract value in the accompanying Statements of Net Assets Available for Benefits.

The crediting rates for the years ended December 31, 2024 and 2023 ranged from 1.00% to 1.50%. The contract does not have a maturity date and continues in force until all assets have been distributed and no further payments are due. Certain events would limit the Plan’s ability to transact at contract value. However, the Plan administrator does not believe any events that would limit the Plan’s ability to transact at contract value are probable of occurring. The contract value was \$895,394 and \$819,078 as of December 31, 2024 and 2023, respectively.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested and the funds of the Plan will be distributed based on individual participant balances.

**Note 8. Related Party and Parties-in-Interest Transactions**

Certain Plan investments are managed by the trustee. Any purchases and sales of these investments are performed in the open market at fair value. The notes receivable from participants are also considered to be party-in-interest transactions. Fees paid to the current trustee by the Plan totaled \$9,400 and \$7,070 for the years ended December 31, 2024 and 2023, respectively. These transactions, while considered party-in-interest transactions under ERISA regulations, are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

**Note 9. Tax Status**

Effective January 1, 2017, the Plan adopted a restated prototype non-standardized profit-sharing plan. The prototype non-standardized profit-sharing plan has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, that the prototype non-standardized profit-sharing plan is acceptable with the applicable section of the IRC. The plan administrator believes the Plan is currently designed and operated in compliance with the applicable provisions of the IRC and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included the SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan’s 2024 financial statements related to SECURE Act 2.0.

**Note 10. Risks and Uncertainties**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participants’ account balances and the amounts reported in the financial statements.

**Note 11. Subsequent Events**

Management has evaluated subsequent events through October 1, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
