## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform the audits of the financial statements of Franklin and Marshall College Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

### **Basis for Disclaimer of Opinion (continued)**

Furthermore, as described in Note 6 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America (U.S. GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

## Notes to Financial Statements

December 31, 2024 and 2023

### **Note 1 - Description of Plan**

The following description of the Franklin and Marshall College Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

#### **General**

The Plan is a defined contribution and Internal Revenue Code (IRC) 403(b) pension plan covering substantially all employees of Franklin and Marshall College and affiliated organizations (collectively, the Organization). All employees of the Organization who work at least 1,000 hours per year, except student employees, are immediately eligible to make participant contributions. These employees, with the exception of adjunct faculty, are eligible to receive employer contributions after two years of service. The Plan is subject to the provisions of ERISA.

#### **Contributions**

Participants may elect to make annual contributions to the Plan up to the maximum contribution as defined by the IRC. Participants may designate all or a portion of their deferral contributions as after-tax contributions in a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute eligible rollover distributions as defined in the plan document. For eligible employees hired on or before July 1, 2006, the employer contribution is as follows: 13% as of July 1, 2019; 12% as of July 1, 2020; 11% as of July 1, 2021; and 10% as of July 1, 2022. Eligible employees hired after July 1, 2006 receive an employer contribution of 10% of the employee's eligible compensation. Participants direct the investment of all contributions into various investment options offered by the Plan.

For a plan participant receiving disability benefits under the Organization's disability plan, a monthly retirement contribution is made to the Plan by the disability insurance carrier. Participants hired on or before July 1, 2006 receive a monthly contribution equal to a certain percentage of the participant's pre-disability actual base monthly salary up to \$2,500 per month. The monthly contribution is as follows: 13% as of July 1, 2019; 12% as of July 1, 2020; 11% as of July 1, 2021; and 10% as of July 1, 2022. Participants hired after July 1, 2006 receive a monthly contribution of 10% of the participant's pre-disability actual base monthly salary up to \$2,500 per month.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (1) the Organization's contribution and (2) plan earnings. Allocations are based on the participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in all contributions, plus actual earnings thereon.

### **Note 1 - Description of Plan (continued)**

#### **Notes Receivable from Participants**

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case, the loan may be for up to ten years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive the value of his or her account, in accordance with the provisions of the Plan, in installment payments, an annuity, or a lump-sum distribution. Withdrawals from the Plan may also be made upon circumstances of substantial financial hardship, in accordance with provisions specified in the Plan.

Actively-employed participants may request, subject to approval, a withdrawal of all or a portion of their pre-tax contributions subject to demonstration of substantial financial hardship.

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

Insurance annuity contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Note 2 - Summary of Significant Accounting Policies (continued)**

#### **Investment Valuation and Income Recognition**

Except for a certain contract held by TIAA and CREF, as described in Note 5, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain administrative expenses are paid by the Organization.

#### **Plan Loans**

Prior to October 2021, participants could borrow from TIAA and CREF using a portion of their account balance as security for the loan. The minimum loan was \$1,000 and could be up to the lesser of \$50,000 or 45% of their account balance, or 90% of the eligible balance available for loans from such participant's account. The loans bear interest at rates that range from 4.25% to 5.73%, which are commensurate with local prevailing rates as determined periodically by TIAA and CREF. Principal and interest are paid ratably through monthly or quarterly payments by the participant to TIAA and CREF. The plan administrator has concluded that these loans are not plan assets and that such arrangements are exempt transactions.

At December 31, 2024 and 2023, the balance of these plan loans was \$250,269 and \$310,383, respectively. At December 31, 2024 and 2023, under the borrowing terms of these loans, \$275,296 and \$341,421, respectively, of plan assets serve as collateral for these loans. Interest paid by participants on such loans during the plan years ended December 31, 2024 and 2023 was approximately \$13,000 and \$18,500, respectively.

In the event of default, such loans are reportable to participants as taxable income, but remain outstanding and continue to accrue interest until repaid by the participant or the participant becomes eligible to receive a distribution under the terms of the Plan. As of December 31, 2024 and 2023, loans in default amounted to \$208,841 and \$198,563, respectively. These amounts include the principal and accumulated interest.

#### **Note 3 - Information Certified and Provided by TIAA and CREF**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by TIAA and CREF (the insurance carriers).

#### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies and temporary cash investments are valued at the net asset value of shares held by the Plan at year-end.

Pooled separate account is valued at the daily unit value published on NASDAQ, beginning in October 2014. The fund is not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the account.

Insurance annuity contract is reported at contract value, which approximates fair value. The contract value of the TIAA and CREF Traditional Annuity equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any. Within this contract are subcontracts that have varying characteristics based on the type of subcontract issued. The Supplemental Retirement Annuity (SRA) and Group Supplemental Retirement Annuity (GSRA) subcontracts have no liquidity restrictions and are fully benefit-responsive. The Retirement Annuity (RA) subcontract does not allow lump-sum cash withdrawals, and transfers must be spread over a period of ten annual installments (or five annual installments for withdrawals after termination of employment). The holdings within the RA subcontract have liquidity restrictions and are not fully benefit-responsive.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 - Insurance Annuity Contract with TIAA and CREF

The Plan has an insurance annuity contract with TIAA and CREF. Under this contract are subcontracts, some of which are fully benefit-responsive while others are not. TIAA and CREF maintains the contributions in a general account. The contract is included in the financial statements at contract value, which approximates fair value, as reported to the Plan by TIAA and CREF. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 1.00% to 3.00%. The crediting rate is reviewed on an annual basis for resetting. There are certain withdrawal limitations for the investment contract. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the contract issuer's ability to meet its financial obligations. The contract issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### Note 6 - Excluded Contracts

The plan administrator has elected to exclude from investments certain annuity contracts and custodial accounts that may have been issued to current and former employees without the plan administrator's knowledge prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the statement of changes in net assets available for benefits. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The plan administrator is not able to determine the amount of these excluded annuity contracts and custodial accounts and the related income and distributions because records relating to these are not available or do not exist.

### Note 7 - Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The plan administrator believes that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Approximately 19% and 20% of the Plan's investments are held in one account with TIAA and CREF at December 31, 2024 and 2023, respectively. As such, this is considered to be a concentration of credit risk.

### **Note 10 - Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are shares of registered investment companies and temporary cash investments, units of a pooled separate account managed by TIAA and CREF, and an insurance annuity contract. TIAA and CREF are the insurance carriers as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and custody services are immaterial.

### **Note 11 - Subsequent Events**

Plan management has evaluated subsequent events through October 1, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We were engaged to perform the audits of the financial statements of Franklin and Marshall College Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Disclaimer of Opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

### **Basis for Disclaimer of Opinion (continued)**

Furthermore, as described in Note 6 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America (U.S. GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

### **Note 1 - Description of Plan**

The following description of the Franklin and Marshall College Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

#### **General**

The Plan is a defined contribution and Internal Revenue Code (IRC) 403(b) pension plan covering substantially all employees of Franklin and Marshall College and affiliated organizations (collectively, the Organization). All employees of the Organization who work at least 1,000 hours per year, except student employees, are immediately eligible to make participant contributions. These employees, with the exception of adjunct faculty, are eligible to receive employer contributions after two years of service. The Plan is subject to the provisions of ERISA.

#### **Contributions**

Participants may elect to make annual contributions to the Plan up to the maximum contribution as defined by the IRC. Participants may designate all or a portion of their deferral contributions as after-tax contributions in a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute eligible rollover distributions as defined in the plan document. For eligible employees hired on or before July 1, 2006, the employer contribution is as follows: 13% as of July 1, 2019; 12% as of July 1, 2020; 11% as of July 1, 2021; and 10% as of July 1, 2022. Eligible employees hired after July 1, 2006 receive an employer contribution of 10% of the employee's eligible compensation. Participants direct the investment of all contributions into various investment options offered by the Plan.

For a plan participant receiving disability benefits under the Organization's disability plan, a monthly retirement contribution is made to the Plan by the disability insurance carrier. Participants hired on or before July 1, 2006 receive a monthly contribution equal to a certain percentage of the participant's pre-disability actual base monthly salary up to \$2,500 per month. The monthly contribution is as follows: 13% as of July 1, 2019; 12% as of July 1, 2020; 11% as of July 1, 2021; and 10% as of July 1, 2022. Participants hired after July 1, 2006 receive a monthly contribution of 10% of the participant's pre-disability actual base monthly salary up to \$2,500 per month.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (1) the Organization's contribution and (2) plan earnings. Allocations are based on the participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in all contributions, plus actual earnings thereon.

##### **Notes Receivable from Participants**

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case, the loan may be for up to ten years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive the value of his or her account, in accordance with the provisions of the Plan, in installment payments, an annuity, or a lump-sum distribution. Withdrawals from the Plan may also be made upon circumstances of substantial financial hardship, in accordance with provisions specified in the Plan.

Actively-employed participants may request, subject to approval, a withdrawal of all or a portion of their pre-tax contributions subject to demonstration of substantial financial hardship.

#### **Note 2 - Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

Insurance annuity contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Note 2 - Summary of Significant Accounting Policies (continued)**

##### **Investment Valuation and Income Recognition**

Except for a certain contract held by TIAA and CREF, as described in Note 5, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain administrative expenses are paid by the Organization.

##### **Plan Loans**

Prior to October 2021, participants could borrow from TIAA and CREF using a portion of their account balance as security for the loan. The minimum loan was \$1,000 and could be up to the lesser of \$50,000 or 45% of their account balance, or 90% of the eligible balance available for loans from such participant's account. The loans bear interest at rates that range from 4.25% to 5.73%, which are commensurate with local prevailing rates as determined periodically by TIAA and CREF. Principal and interest are paid ratably through monthly or quarterly payments by the participant to TIAA and CREF. The plan administrator has concluded that these loans are not plan assets and that such arrangements are exempt transactions.

At December 31, 2024 and 2023, the balance of these plan loans was \$250,269 and \$310,383, respectively. At December 31, 2024 and 2023, under the borrowing terms of these loans, \$275,296 and \$341,421, respectively, of plan assets serve as collateral for these loans. Interest paid by participants on such loans during the plan years ended December 31, 2024 and 2023 was approximately \$13,000 and \$18,500, respectively.

In the event of default, such loans are reportable to participants as taxable income, but remain outstanding and continue to accrue interest until repaid by the participant or the participant becomes eligible to receive a distribution under the terms of the Plan. As of December 31, 2024 and 2023, loans in default amounted to \$208,841 and \$198,563, respectively. These amounts include the principal and accumulated interest.

#### **Note 3 - Information Certified and Provided by TIAA and CREF**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by TIAA and CREF (the insurance carriers).

#### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Note 4 - Fair Value Measurements (continued)

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies and temporary cash investments are valued at the net asset value of shares held by the Plan at year-end.

Pooled separate account is valued at the daily unit value published on NASDAQ, beginning in October 2014. The fund is not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the account.

Insurance annuity contract is reported at contract value, which approximates fair value. The contract value of the TIAA and CREF Traditional Annuity equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any. Within this contract are subcontracts that have varying characteristics based on the type of subcontract issued. The Supplemental Retirement Annuity (SRA) and Group Supplemental Retirement Annuity (GSRA) subcontracts have no liquidity restrictions and are fully benefit-responsive. The Retirement Annuity (RA) subcontract does not allow lump-sum cash withdrawals, and transfers must be spread over a period of ten annual installments (or five annual installments for withdrawals after termination of employment). The holdings within the RA subcontract have liquidity restrictions and are not fully benefit-responsive.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 - Insurance Annuity Contract with TIAA and CREF

The Plan has an insurance annuity contract with TIAA and CREF. Under this contract are subcontracts, some of which are fully benefit-responsive while others are not. TIAA and CREF maintains the contributions in a general account. The contract is included in the financial statements at contract value, which approximates fair value, as reported to the Plan by TIAA and CREF. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 1.00% to 3.00%. The crediting rate is reviewed on an annual basis for resetting. There are certain withdrawal limitations for the investment contract. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the contract issuer's ability to meet its financial obligations. The contract issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

#### Note 6 - Excluded Contracts

The plan administrator has elected to exclude from investments certain annuity contracts and custodial accounts that may have been issued to current and former employees without the plan administrator's knowledge prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the statement of changes in net assets available for benefits. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The plan administrator is not able to determine the amount of these excluded annuity contracts and custodial accounts and the related income and distributions because records relating to these are not available or do not exist.

#### Note 7 - Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The plan administrator believes that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Approximately 19% and 20% of the Plan's investments are held in one account with TIAA and CREF at December 31, 2024 and 2023, respectively. As such, this is considered to be a concentration of credit risk.

#### **Note 10 - Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are shares of registered investment companies and temporary cash investments, units of a pooled separate account managed by TIAA and CREF, and an insurance annuity contract. TIAA and CREF are the insurance carriers as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and custody services are immaterial.

#### **Note 11 - Subsequent Events**

Plan management has evaluated subsequent events through October 1, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.
