The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 7, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with U.S. GAAP, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). 1. Description of the Plan

The following description of the Penobscot Community Health Center 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan sponsored by Penobscot Community Health Center (PCHC or the Employer) for the benefit of its employees. Substantially all employees are eligible to participate in the Plan on the first day of employment. Participants working over 20 hours per week are eligible to receive discretionary matching and profit-sharing contributions immediately upon Plan entry. Principal Trust Company (Principal) serves as the Plan's custodian and maintains the Plan's investments. Downeast Pension Services (the TPA) provides third-party administrative services. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides that eligible employees can contribute to the Plan through payroll deferrals at specified percentages of their compensation (as defined under the Plan). Participants may defer up to 100% of their compensation subject to Internal Revenue Service (IRS) limits. The Plan allows for both pre-tax and Roth elective deferrals. Enrollment in the Plan is automatic upon commencement of employment; however, the employee may elect not to participate.

Employees of PCHC who are eligible and participate in the Plan may receive a discretionary employer matching contribution. Effective January 1, 2023, the Plan will make a matching contribution of 33% of the first 6% of compensation with a maximum matching contribution of 2%. There is also a last day employment requirement in order to receive a match contribution. The match is funded after the year end calculation is completed.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Investment Options

Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers a guaranteed investment contract or various mutual funds.

Vesting

Participants are fully vested at all times in their employee elective deferral account and are not subject to forfeiture for any reason. Participants vest 20% each year of service and become fully vested in employer matching and profit-sharing contributions after five years.

Forfeited Accounts

At December 31, 2024 and 2023, there was \$17,803 and \$2,124 respectively, of forfeited, non-vested accounts. Forfeited balances of terminated participants are used to reduce administrative fees and future employer contributions. During the year ended December 31, 2024, \$92,638 and \$1,077 of forfeitures were used to reduce administrative fees and employer contributions, respectively.

Payment of Benefits

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump-sum payment or a monthly annuity.

Notes Receivable from Participants

Participants may borrow from the pre-tax vested portion of their individual account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at prime, plus 1% at the time of the loan. Principal and interest is paid ratably through bi-weekly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Benefits

Benefits to participants are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the guaranteed investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Participant notes receivable are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Substantially all administrative expenses are paid by the Plan. The Plan Sponsor pays certain other expenses that are excluded from these financial statements.

Subsequent Events

Management has considered transactions or events occurring through October 14, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Investment Contract with Insurance Company

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company (PLIC). PLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by PLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

4. Information Prepared and Certified by Custodian

The investment and notes receivable from participants, related transactions including net appreciation in fair value of investments, and interest and dividend income amounts were obtained by management and agreed to or derived from the information certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a member of Principal Financial Group, the custodian, as complete and accurate.

This information includes the following:

- Statements of Net Assets Available for Benefits
- Statement of Changes in Net Assets Available for Benefits
- Supplemental Schedule – Schedule H, Line 4i – Schedule of Assets (Held at End of Year)

5. Parties-in-Interest

Principal manages the investment contract and certain investment funds. Principal is also the custodian of those investments and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$193,592 to Principal for administrator fees in 2024.

6. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status of the Plan

The Company has adopted the Downeast Pension Services Inc. Volume Submitter 403(b) Plan, which received a favorable advisory letter dated March 31, 2017 from the IRS stating that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the IRC). The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

8. Fair Value Measurement

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. It also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

- Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data.
- Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments consist entirely of mutual funds that are measured using Level 1 inputs of quoted market prices as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
