**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Cottrell, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Securities Act of 1974 (ERISA) as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Cottrell, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Cottrell, Inc. (Plan Sponsor) 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. **General.** The Plan is a 401(k) salary reduction defined contribution retirement plan covering all full-time employees who have one year of service and are age 21 or older, except employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). Management is responsible for oversight of the Plan. The Retirement Plan Administrative Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to management.
- b. **Contributions.** Each year, participants may contribute up to 25% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also accepts Roth 401(k) contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The plan currently offers various mutual funds and guaranteed contracts as investment options for participants. The Company contributes discretionary matching contributions to participants. The discretionary matching contributions will be 60 percent of the participant's eligible contributions at up to 10 percent. The matching Company contribution is invested in the same investment options as the employee's elective deferrals. Contributions are subject to certain limitations. Contributions are subject to certain IRS limitations.
- c. **Participant Accounts.** Participant accounts are completely self-directed, and participants may allocate their contributions among various mutual funds offered under the plan. At any time, participants may change their investment elections among the available options via the Voya Trust website. Each participant's account is credited with the participant's contribution and Plan Sponsor's matching contributions and discretionary contributions, and Plan earnings. Participant accounts are charged with an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. **Vesting.** Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after 5 years of credited service.
- e. **Notes Receivable from Participants.** Under a new loan provision effective December 1, 2024, participants may borrow from their fund accounts a minimum of \$ 1,000 up to a maximum equal to the lesser of \$ 50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at inception of the loan at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.
- f. **Payment of Benefits.** On termination of service due to death, disability, or retirement, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants, who have reached the age of 59½, may receive, for any reason, in-service distributions of the vested interest in any of his contribution accounts. Qualified hardship distributions may be made from the participant's elective deferral or rollover accounts.
- g. **Forfeited Accounts.** At December 31, 2024 and 2023, the balance held in forfeited non-vested accounts totaled \$ 39 and \$ 3, respectively. These account funds will be used to reduce future employer contributions. In 2024, employer contributions were reduced by \$ 62,198 from forfeited non-vested accounts of participants who terminated prior to the partial plan termination.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

**Excess Contributions Payable**

Accounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments. Certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses.

**Subsequent Events**

The plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS AND VALUATION**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*VOYA fixed account:* Valued at the surrender value with daily credited interest net of any market value adjustments as reported by the insurance company. Interest is credited daily at declared rates of interest subject to minimum rate not less than one percent. The credited interest rate, account balance and formula for adjustment are consistent and observable through the contract and related communication.

**NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares managed by Voya. Voya is the trustee and record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the plan for the investment management services are included in net appreciation/(depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Fees recognized by the plan as administrative expenses total \$ 21,847 for 2024. Additional fees for Plan operations and reporting were paid directly by the Plan Sponsor and are not recognized by the Plan.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8 – EXCESS CONTRIBUTIONS PAYABLE**

Accruals for the distribution of excess deferral contributions were made for 2024 and 2023, respectively, in the amounts of \$ 189,620 and \$ 150,998. These funds are set aside to paid in the subsequent year to satisfy the current year relevant nondiscrimination provision of the plan and are recorded as a payable liability and expense that reduces the amount of employee contributions for each of those years. The subsequent payment in 2024 of excess funds from 2023 paid was reduced by \$ 2,484 for unvested matching contributions deemed to be forfeitures to total \$ 148,514 actually repaid.

**NOTE 9 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by Voya Institutional Trust Company (the trustee of the Plan).
