### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mercy Health Services, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### **Note 1. Description of Plan**

The following description of the Mercy Health Services, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution (salary deferral) plan covering all full-time employees of Mercy Health Services, Inc. (the Company) who are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC).

##### **Contributions**

A Participant can elect to defer annually up to the amount allowed under the current IRC. Participants may also contribute amounts representing distributions from other qualified plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a matching contribution of 50% of deferrals up to 3% of eligible compensation. Participants are eligible for the matching contribution after completing one year of service. Any Company matching contributions are allocated to the Participant directed investment options pro-rata to Participant contributions.

##### **Participant Accounts**

Each Participant's account is credited with the Participant's contributions and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administration expenses and Plan losses. Allocations are based on Participant earnings or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

##### **Vesting**

Participants are immediately vested in their contribution plus actual earnings thereon. Participants are immediately vested in the Company's matching contributions plus actual earnings.

##### **Payment of Benefits**

On termination of services due to death, disability, or retirement, a Participant will receive a lump-sum amount equal to the value of the Participant's vested interest in his or her account. For termination of services due to any other reason, a Participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

##### **Notes Receivable from Participants**

Participants may borrow up to the lesser of \$50,000 or 50% of their vested interest. The loans are secured by the balance in the participant's account. The loan interest is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

##### **Basis of Accounting**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

### Note 2. **Summary of Significant Accounting Policies**

#### **Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date. Purchase and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

### Note 3. **Certification**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, Reliance Trust Company, and Transamerica Financial Life Insurance Company Inc, the custodians of the Plan and Transamerica Trust Company, the trustee of the Plan. The Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this information:

- Investments at fair value
- Investment at contract value
- Notes receivable from participants
- Net change in fair value of investments
- Interest income on notes receivable from participants

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Registered Investment Companies:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods appropriate and consistent with other market Participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

#### Note 5. **Investment Contract with Insurance Company**

During 2024, the Plan entered into a stable value fund investment contract under a group annuity contract issued by Transamerica. Transamerica maintains the funds in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed on a semi-annual basis for resetting. There is no minimum guaranteed interest rate under the contract.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other Employer events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

During 2023, the Plan was invested in the Mutual of America Interest Accumulation Account (Contract) which was a fully-benefit responsive contract with Mutual of America. Mutual of America maintained the contributions in its general account. The account was credited with earnings on the underlying investments and charged for Participant withdrawals and administrative expenses. The Contract issuer was contractually obligated to repay the principal and interest and a specified interest rate that was guaranteed to the Plan.

Because the Contract is fully benefit-responsive, the Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Contract. The Contract value, as reported to the Plan by Mutual of America represents contributions made under the Contract, plus earnings, less Participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at Contract value. There are no reserves against Contract value for credit risk of the Contract issuer or otherwise.

**Note 6. Related Party and Party-in-interest Transactions**

The Plan held investments in certain mutual funds with Mutual of America Life Insurance Company, the custodian of the plan at December 31, 2023 and Transamerica Trust Company, the trustee of the Plan at December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for investment management services are included in net change in fair value of investments because they are paid through revenue sharing rather than a direct payment.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan under the provisions of ERISA. In the event of Plan termination, participants will become 100% invested in their accounts.

**Note 8. Tax Status**

The Plan adopted a non-standardized pre-approved profit sharing plan from of a plan sponsored by Mutual of America Life Insurance Co. The non-standardized pre-approved profit sharing plan practitioner has received an opinion letter from the IRS as to the non-standardized pre-approved profit sharing plan's qualified status. The non-standardized pre-approved profit sharing plan's opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to IRS examinations for the years prior to 2021.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Non-exempt Transactions**

During the year ended December 31, 2024, participant contributions totaling \$41,677 were not remitted to the Plan within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company has taken the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest, and has further implemented a procedure to ensure that all future remittances are made within the prescribed time period.
