### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Gregory M. Parker, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of the Plan

The following description of the Gregory M. Parker, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan is a defined contribution, safe harbor 401(k) plan maintained by Gregory M. Parker, Inc. (the Company or Employer) for the benefit of its eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Eligibility*

Effective January 1, 2023, all employees, excluding union employees and non-resident aliens, who have completed three months of employment and are at least 21 years of age are eligible to participate in the Plan. Eligible employees may enter the Plan on the first day of the first, fourth, seventh, or tenth month of the Plan year, coincident with or immediately following the satisfaction of the eligibility conditions. Long-term part-time employees who met eligibility requirements under SECURE 2.0 Act of 2022 are also eligible to participate in the Plan.

#### *Participant Contributions*

Participants may elect to make contributions on a pre-tax basis, an after-tax basis (Roth deferral contributions), or a combination of the two, not to exceed the limit under the Internal Revenue Code (IRC). In addition, eligible Participants are permitted to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

#### *Employer Contributions*

The Company has elected to operate the Plan under a safe harbor provision whereby Participants in the Plan receive a matching contribution, calculated on a pay period basis as 100% of the Participant's contribution up to 3% of eligible compensation plus 50% of the next 2% of the Participant's eligible compensation, and may receive an additional discretionary matching contribution calculated on an annual basis (collectively, Employer matching contributions). Such matching contributions also apply to Participant catch-up contributions. The Employer may also make a discretionary non-elective contribution (Employer non-elective contribution) calculated as a uniform percentage of Participant compensation. To receive an allocation of such contributions, a Participant generally must be employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year. During 2024, no discretionary contributions were made.

#### *Participant Accounts*

Each Participant's account is credited with the Participant's contributions and Employer contributions, as well as allocations of the Plan's income (loss). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings (losses), account balances, or specific Participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

#### *Vesting*

Participants are always 100% vested in their salary deferral and rollover contributions, Employer safe harbor matching contributions, and any earnings (losses) thereon. Employer discretionary contributions, and the earnings (losses) thereon, vest in accordance with the following schedule:

A Participant will become fully vested in Employer discretionary contributions, regardless of length of service, in the event of death or disability.

#### *Benefit Payments*

A Participant becomes eligible for benefits at the normal retirement date (age 65), at the early retirement date (age 59½ and five years of service), upon termination from the Company, or at the date the Participant dies or becomes totally disabled. In addition, a Participant is eligible to receive an in-service distribution upon the attainment of age 59½ or in the events of financial hardship or deemed severance, as defined by the Plan document. The Plan will make mandatory distributions for certain terminated Participants with account balances of up to \$7,000, including rollover accounts. Distributions will be made in lump sum or installment payments directly to the Participant or rolled over to another qualified retirement plan.

#### *Forfeitures*

Forfeited account balances may be utilized to reduce Employer contributions or to pay Plan fees. The forfeiture account balance was \$0 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no funds were used to offset Employer contributions or Plan fees.

#### *Notes Receivable from Participants*

Participant loans are not permitted by the Plan.

#### *Reclassification*

Certain reclassifications of prior year amounts have been made to conform with current year presentation.

### 2. Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

### 2. Significant Accounting Policies (cont.)

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income (Loss) Recognition*

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date (the exit price). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

Purchases and sales are recorded on a trade-date basis. Interest is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan Participants and the contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Plan Expenses*

Certain administrative expenses related to distributions and other Participant-initiated transactions are charged to the account of the Plan Participant. Other administrative expenses and investment management fees are paid from the Plan's forfeitures and through reductions of investment returns under the Plan's investment options.

#### *Payment of Benefits*

Benefit payments to Participants are recorded upon distribution.

### 3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Charles Schwab Trust Bank (Charles Schwab), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### 4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are as follows:

#### *Basis of Fair Value Measurement*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies* - Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Interest-bearing cash* - Consists of a money market fund which is valued using the amortized cost or penny-rounding method as permitted by Rule 2a-7 under the Investment Company Act of 1940, which approximates its fair value.

*Common collective trusts* - Valued at the NAV based on the latest reported sales price of the underlying investments held. The NAV is used as a practical expedient to estimate fair value. The Plan's interest in the common collective trusts is based on unit values reported by the funds' trustee at year-end and are not classified within the valuation hierarchy.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes valuation methodologies are appropriate and consistent with other market Participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA (pre-approved plan) sponsored by The Retirement Plan Company, LLC (TRPC). The Internal Revenue Service (IRS) has opined and informed TRPC by a letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Plan Termination

While the Company has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination of the Plan, affected Participants would become 100% vested and the assets remaining shall be distributed to Participants in proportion to their respective account balance at the date of termination, subject to the provision of ERISA.

### 7. Related Parties and Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. The custody and recordkeeping functions of the underlying investments held by the Plan are performed by Charles Schwab; therefore, these transactions qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules. Usual and customary fees were paid for investment management services. No officer or employee receives compensation from the Plan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### **8. Risks and Uncertainties**

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

### **9. SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

### **10. Subsequent Events**

The Company has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.
