INDEPENDENT AUDITOR'S REPORT

To the Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Elizabeth Charles Corporation 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of Plan

The Elizabeth Charles Corporation 401(k) Profit Sharing Plan and Trust (Plan) was created by Elizabeth Charles Corporation (Company) effective January 1, 1994, and was amended and restated effective January 1, 2004. The following Plan description is provided for information purposes only. Participants should refer to the Plan document for more complete information.

Eligibility

Employees generally become participants on the first entry date after completing six months of employment and attaining age 18. Entry dates are January 1 and July 1. Employees are automatically enrolled upon meeting the eligibility requirements unless they elect not to be covered.

Contributions

Participants may elect to contribute a percentage of their compensation. Salary deferral contributions may not exceed annual limitations specified in the Plan. The Company may make matching and non-elective contributions, at their discretion, as determined by the Company's Board of Directors. Matching contributions are allocated based on each participant's elective contributions. Non-elective contributions are allocated in the same proportion that each participant's compensation bears to the total qualified compensation of all participants. Rollover contributions are allowed for new participants from their previous qualified plan. Contributions are subject to certain limitations. Participants may direct the investment of the contributions into various investment options under the Plan. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching and non-elective contributions and (b) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants who terminate their employment for any reason other than permanent disability or death will receive 100% of any participant and rollover contributions and related earnings, plus the vested amount in their account contributed by the employer and those related earnings.

Participants' interest in employer contributions and related earnings vest at 20% for each year of service, after two years of service. Upon termination of employment, any nonvested portion of employer contributions is forfeited.

Payment of Benefits

On termination of service or attaining age sixty, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in their account. The Plan also allows for in-service withdrawals.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a variety of pooled separate accounts maintained by Minnesota Life Insurance Company (MN Life). The investment options range from low risk income funds to high-risk international growth funds. Additionally, the Plan offers an individual brokerage account option.

Forfeitures

Forfeitures of terminated participants' nonvested amounts may be used to pay Plan administrative expenses or to reduce Company contributions for the Plan year in which the forfeiture occurs. No forfeitures were used in 2024 and there are no unused forfeitures at December 31, 2024 and 2023.

Notes Receivable from Participants

The Plan allows participants to borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balances. The loans are collateralized by the participant's account balance, bear interest at 4.25% to 9.50%. Principal and interest are paid through payroll deductions.

Administration

Certain members of the Company serve as Plan Trustees. Certain Plan expenses are absorbed by the Company at the Company's discretion.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in various combinations of investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Assets Available for Benefits in future periods.

Subsequent Events

The Plan has evaluated all subsequent events through **October 14, 2025**, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by **Minnesota Life Insurance Company (MN Life)**, the custodian of the Plan.

Note 4. Tax Status

The Plan sponsor relies on the Internal Revenue Service determination letter issued to the volume submitter plan sponsor dated September 4, 2001, and believes the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5. Termination of Plan

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 6. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 2 Fair Value Measurements

Pooled Separate Accounts: Valued at the NAV of units of an insurance pooled account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal in order to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Party-in-Interest Transactions

The Custodian manages the pooled separate account investments. Transactions related to these funds thereby qualify as party-in-interest transactions; however, the Department of Labor has issued prohibited transaction exemptions indicating that these types of transactions are to be considered exempt party-in-interest transactions.

Note 8. Subsequent Events

The Plan changed Custodians to Principal Life Insurance effective January 1, 2025. All Plan assets were transferred to Principal and invested according to participant elections.

Note 9. Nonexempt Transactions

During the Plan year ended December 31, 2024, employee withholdings in the amount of \$218,134 were not remitted within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company is aware of the occurrence and has taken the appropriate steps to correct the situation.


