### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Sutphen Corp. 401(k) Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### Note 1. Plan Description

The following description of The Sutphen Corp. 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan was established on December 31, 1998. The Plan is a defined contribution plan covering substantially all employees of Sutphen Corporation (Company) who met certain service criteria as defined in the Plan document. Employees are eligible the first day of the month following completion of three months of service. Effective January 1, 2021, entrance date of eligible participants changed to immediate entry. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may contribute to the Plan each year up to the maximum percentage of their compensation allowable on a pretax basis or a Roth basis, not to exceed the limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 1% unless they affirmatively elect not to participate in the Plan or elect a different deferral rate. The Company may also make a discretionary profit sharing contribution to the Plan. The Company elected to make a profit sharing contribution totaling \$216,360 for the year ended December 31, 2024.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of (a) the Company's profit sharing contribution and (b) Plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's contributions plus actual earnings thereon is based on years of continuous service, as defined in the agreement. Vesting in the employer's contributions along with earnings thereon is as follows:

**Forfeited accounts:** As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,394 and \$109,776, respectively. Forfeitures of \$131,000 were reallocated to participants as stated in the Plan document. Accumulated forfeitures will be applied to pay expenses or reduce the employer contributions in 2025.

#### Note 1. Plan Description (Continued)

**Payment of benefits:** Upon termination of service due to death, disability, retirement or attainment of age 59½ (in-service distribution), a participant or his/her beneficiary will receive a lump-sum distribution equal to the value of the participant's vested interest in his/her account. Hardship withdrawals, as defined by the Plan, are also available to participants.

**Notes receivable from participants:** Participants may borrow from their participant account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance reduced by the highest outstanding loan balance in the previous 12 months even if the amounts have been repaid. The number of outstanding loans is limited to one per participant. The loans are secured by the balance in the participant's account and bear interest at the prime lending rate on the date the loan is made. Principal and interest are paid through weekly payroll deductions.

**Plan termination:** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants will become fully vested in their accounts.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are presented on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**Contributions:** Contributions from Plan participants and all matching and profit sharing contributions from the employer are recorded in the year in which participant compensation is earned.

**Payments of benefits:** Benefits paid to participants are recorded when paid.

**Administrative expenses:** The Plan is responsible for certain administrative expenses, which are recognized when incurred. A portion of the administrative expenses are paid by the Company, at the Company's discretion.

**Risks and uncertainties:** The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

Accounting standards established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the net asset value (NAV) of shares held by the Plan at year-end.

#### **Note 5. Guaranteed Annuity Contract With Insurance Company**

The Plan has a guaranteed annuity investment contract with Empower. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the traditional investment contract at December 31, 2024 and 2023 was \$491,509 and \$544,493, respectively. Fair value approximates contract value at December 31, 2024 and 2023.

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0% and is reset at least as frequently as annually.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC.
2. The Plan's total investment in the contract falls below an amount specified in the contract.
3. Premature termination of the contract.
4. Plan termination of merger.
5. Changes to the Plan's prohibition on competing investment of other Plan provisions that have an adverse effect on the investment.
6. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **Note 6. Party-in-Interest Transactions**

Certain Plan investments are managed by Empower, the trustee of the Plan's assets and, therefore, these transactions qualify as party-in-interest transactions. During 2024, the Plan paid administrative fees of \$37,575 to Empower.

#### **Note 7. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.
