Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Good Shepherd Health Care System Tax Sheltered Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by qualified institutions agrees to or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan:

The following description of Good Shepherd Health Care System Tax Sheltered Retirement Plan (the Plan) is provided for general information only. Participants should refer to the plan agreement, as amended, for more complete information.

General – The Plan is a defined contribution 403(b) plan covering substantially all employees of Good Shepherd Health Care System (the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – All employees are eligible to participate in the Plan for purposes of making deferral contributions and rollover contributions to the Plan from the date of hire. Employees are eligible for employer contributions on the first day of the next calendar quarter after completing two years of service, in which at least 1,000 hours are worked each year.

Contributions – As of January 1, 2014, Lincoln Financial Group Trust Company, Inc., is the only custodian to which participant contributions can be made. Participants may make voluntary tax-deferred contributions to the Plan through payroll deductions of up to the Internal Revenue Service (IRS) maximum allowable contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

As of January 1, 2014, Lincoln Financial Group Trust Company, Inc., is the only custodian to which the plan sponsor will make employer contributions. The plan sponsor may elect to make matching and discretionary profit-sharing contributions to the Plan. The plan sponsor matches 50 percent of employee contributions, up to 4 percent of eligible compensation deferred to the Plan for all employees except union nurses and management employees who will receive a match of 50 percent of employee contributions up to 6 percent of eligible compensation. Discretionary profit-sharing contributions are allocated to participants as follows:

- 2-5 years of service – 4 percent of compensation.
- 6-10 years of service – 5 percent of compensation.
- 11-20 years of service – 6 percent of compensation.
- 20+ years of service – 8 percent of compensation.

Nurses covered by a collective bargaining agreement who have 20+ years of service and have elected additional paid time off may receive 6 percent of compensation, and nurses covered by a collective bargaining agreement who have 20+ years of service and did not elect to have additional paid time off may receive 8 percent of compensation.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contribution, and (b) the Plan's earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued):

Vesting – Participants are immediately vested in their salary deferral contributions and all employer contributions plus actual earnings thereon.

Benefit payments – Normal retirement under the Plan occurs at age 65. The Plan provides for retirement distributions to persons under age 65, if certain conditions are met as specified in the plan document. Participants, or their beneficiaries, are eligible to receive payment of benefits in the event of the participant's retirement, death, disability, or termination of the Plan. Benefits are distributed according to provisions set forth in the plan document. Participants' nonforfeitable account balances less than \$5,000 shall be distributed in a lump-sum payment. If the vested amount exceeds \$5,000, participants may elect for the benefits to be distributed in a lump-sum payment or annual installments. For benefits held at an insurance company, a participant will receive their benefits with a qualified joint and survivor annuity or by any other payout options that may be provided under their insurance company investment arrangement.

Notes receivable from participants – Participants who contribute to Lincoln Financial Group Trust Company, Inc., investments may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years and must be for a safe harbor hardship purpose. Under the terms of the Plan agreement, plan loans will bear interest based on the quarterly prime rate plus 1.00 percent. Principal and interest are paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25 percent to 9.50 percent with various maturities through June 2043.

Prior to December 31, 2009, participants who participated in other insurance product investments (Variable Annuity Life Insurance Company [VALIC], Great American Insurance Group Annuities, ReliaStar Life Insurance Company, and Kansas City Life Insurance Company) could borrow directly from the insurance companies a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their elective deferral account balance, subject to the rules of the individual agreements. These loans are secured by the balance of the participant's account and bear fixed, reasonable rates of interest, as determined by the individual agreements. The participant was required to transfer funds equal to the amount of the loan plus 10 percent into a collateral account for use as collateral on the loan. These funds are restricted with respect to withdrawals and transfers while the loan is outstanding. The loans themselves are not reported assets of the Plan.

Plan termination – Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants would become 100 percent vested in their accounts.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

2. Summary of Significant Accounting Policies (continued):

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation – Investments are reported at fair value and contract value. The Plan’s trustee and custodians (Lincoln Financial Group Trust Company, Inc., VALIC, MassMutual Ascend Life Insurance Company, and ReliaStar Life Insurance Company) certify the contract value of the guaranteed investment contracts and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts (FBRICs) because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative expenses – The Sponsor pays certain administrative expenses on behalf of the Plan.

Benefit payments – Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 or 2023.

Subsequent events – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

4. Fair Value Measurements:

Financial Accounting Standards Board *Accounting Standards Codification* 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

4. Fair Value Measurements (continued):

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies (mutual funds) – These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Pooled separate accounts – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

Guaranteed investment contracts – The guaranteed investment contract is valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (see Note 5).

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Guaranteed Investment Contracts with Insurance Companies:

The Plan invests in several FBRICs with insurance companies. The insurance companies maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

FBRIC Contracts Held by the Plan:

- *Kansas City Life Insurance Company* – The Plan invests in FBRICs with Kansas City Life Insurance Company. The crediting rate is based on a formula established by the contract issuer but may not be less than 4.00 percent.
- *Lincoln Financial Group Trust Company, Inc.* – The Plan invests in a FBRIC with Lincoln Financial Group Trust Company, Inc. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.50 percent.
- *Variable Annuity Life Insurance Company* – The Plan invests in FBRICs with VALIC. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.00 percent.

FBRIC Contracts Held by the Plan (continued):

- *MassMutual Ascend Life Insurance Company* – The Plan invests in FBRICs with the MassMutual Ascend Life Insurance Company. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.00 percent.

The contracts meet the FBRIC criteria and, therefore, are reported at contract value. Contract value is the relevant measure for FBRICs, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the trustee and custodians, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

Non-FBRIC Contracts Held by the Plan:

- *Variable Annuity Life Insurance Company* – The Plan also invests in a contract with VALIC. The annuity contract may have potential to restrict certain transfers and withdrawals. The Sponsor does not consider this contract as fully benefit responsive, and, as a result, this investment is shown at fair market value on the statements of net assets available for benefits. VALIC maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The crediting rate is reviewed on an annual basis for resetting.

- *ReliaStar Life Insurance Company* – The Plan also invests in a contract with ReliaStar Life Insurance Company (ReliaStar). The annuity contract may, under certain circumstances, have potential to restrict certain transfers and withdrawals. The Sponsor does not consider this contract as fully benefit responsive and as a result, this investment is shown at fair market value on the statements of net assets available for benefits. ReliaStar maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The crediting rate is reviewed on an annual basis for resetting.

6. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The Plan has a concentration of investments in Vanguard Total Bond Market Index Institutional Shares, Vanguard Institutional Index Institutional Shares, and Lincoln Stable Value Account - J87D. A change in the value of these funds could cause the value of the Plan's net assets available for benefits to change due to this concentration. In addition, as a result of funds being selected by participants, certain other funds may individually represent a concentration of greater than 10 percent of the Plan's investments at fair value in the statements of net assets available for benefits. Although these individual funds maintain a level of diversification by investing in multiple equity, debt, or other instruments, there may be a concentration of risk, because the funds are invested at the direction of a single fund manager. At December 31, 2024, Vanguard Total Bond Market Index Institutional Shares, Vanguard Institutional Index Institutional Shares, and Lincoln Stable Value Account - J87D each represented greater than 10 percent of the Plan's investments at fair value.

7. Plan Tax Status:

The plan terms have been drafted in reliance on the sample language provided by the IRS in the draft Listing of Required Modifications issued April 4, 2009. The Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain the exclusion from tax for plan participants. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The plan administrator intends to apply for a determination letter on the Plan when eligible.

7. Plan Tax Status (continued):

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are no audits for any tax periods in progress.

8. Party-in-interest Transactions:

The Plan's advisory committee consists of employees of the plan sponsor. There are no transactions between the parties other than contributions to the Plan, if eligible.

Plan investments include shares of registered investment company funds, pooled separate accounts, and guaranteed investment contracts managed by the trustee and custodians of the Plan. Therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Lincoln Financial Group Trust Company, Inc., also prepares the IRS Form 5500.

The plan auditor performs the required annual audit of the Plan.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
