Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matters***

#### (1) Description of Plan

The following summary description of the Geode Health 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering substantially all employees of Geode Health LLC (the Company) who have attained age 18, except for union employees and non-resident aliens. There is no service requirement for eligibility. The Plan was originally adopted on January 1, 2021, and was amended and restated effective January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

##### ***Contributions***

Each year, participants may elect to make salary deferral contributions to the Plan as a percentage of their annual compensation, as defined by the Plan, subject to the maximum limits established under the Internal Revenue Code (IRC). Participants may designate their deferrals as either pre-tax or after-tax (Roth) contributions. Those who attain age 50 before the end of the plan year are eligible to make catch-up contributions.

In addition to salary deferrals, participants may contribute amounts representing rollovers from other qualified retirement plans. All contributions are directed by participants into a range of investment options offered under the Plan.

The Plan includes a qualified automatic contribution arrangement (QACA). Unless a participant affirmatively elects otherwise, they will be automatically enrolled at a deferral rate of 3% of compensation. This rate increases by 1% annually, up to a maximum of 6%.

The employer provides a safe harbor matching contribution equal to 100% of deferrals up to 3% of compensation, plus 50% of deferrals that exceed 3% but do not exceed 5%. The employer may also elect to make discretionary profit-sharing contributions. For the year ended December 31, 2024, no profit-sharing contributions were made. To be eligible for any profit-sharing contribution, participants must be employed on the last day of the plan year.

##### ***Participant Accounts***

Each participant's account is credited with the participants' contribution and allocation of the Company's contribution and plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### (1) Description of Plan, Continued

##### *Vesting*

Participants are immediately vested in their own contributions and any profit-sharing contributions to the Plan, including any earnings thereon. Employer matching contributions made under the Plan's qualified automatic contribution arrangement (QACA) become vested after one year of service.

A participant becomes fully vested in all contributions upon death or total and permanent disability.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only one loan may be outstanding at any time. Loan transactions are treated as a transfer from the participant's investment fund to their note fund. The maximum loan term is five years, unless the loan is used for the purchase of the participant's primary residence. Loans are secured by the balance in the participant's account, and interest rates range from 7.75% to 8.50% as of December 31, 2024, which is consistent with local prevailing rates as determined by the Plan Administrator.

Loans may not be made from Roth deferral contributions.

##### *Payment of Benefits*

On termination of service due to death, disability, retirement, or in the event of financial hardship, subject to certain limitations, a participant or their designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27,597 and \$15,680, respectively. These accounts will be used to reduce future employer contributions and plan expenses. During 2024, forfeitures of \$35,864 and \$4,013 were used to offset plan expenses and employer contributions, respectively.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Contributions*

Contributions from plan participants, matching contributions and any profit-sharing contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

#### (3) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC (Ascensus), a qualified institution.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### (4) Fair Value Measurements, Continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Registered investment companies and money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### (5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### (6) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Vanguard. Vanguard is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment.

Administrative expenses paid by the Plan amounted to \$48,344 for the year ended December 31, 2024.

#### (7) Tax Status

The Plan uses a prototype plan document sponsored by Ascensus LLC. Ascensus LLC has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. The plan administrator believes that the prototype plan under which the Plan has been adopted is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan and the related trust are tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### (9) Prohibited Transactions

During 2024, there were multiple payroll periods remitted outside the time frame specified by the Department of Labor's Rules and Regulations, thus constituting nonexempt prohibited transaction between the Plan and the Company. The Company is in the process of calculating the missed earnings on these delinquent contributions and intends to make the appropriate corrections during 2025.
