

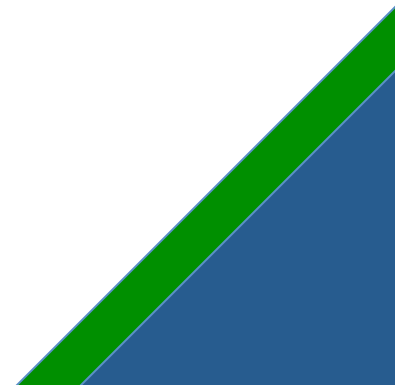

## INDEPENDENT AUDITORS' REPORT

To the Trustees and 401k Plan Committee of  
Revitalize Capital, LLC 401k Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of Revitalize Capital LLC 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Revitalize Capital LLC 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Revitalize Capital LLC 401(K) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Revitalize Capital LLC 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Revitalize Capital LLC 401(K) Plan (the “Plan”) provides only general information. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants should refer to the plan document for more complete information.

**General**

The Plan is a multiple-employer defined contribution plan covering employees of Graphic Village LLC, CTS Packaging LLC, and Kardol Quality Products LLC (collectively referred to as the “Company”). It was adopted by the Company on January 1, 2013 and was amended and restated July 1, 2022, to comply with the ERISA and changes in the Internal Revenue Code (“IRC”) and other acts affecting the Plan. The Plan’s assets are held in trust and are administered by the Plan’s trustees. The Company appoints trustees to administer the Plan.

**Eligibility**

The Plan is a defined contribution plan covering all employees of the Company. Eligibility for Company contributions requires at least 18 years of age. Entry date is the first day of the month following sixty days after the hire date.

**Contributions**

Each participant may make voluntary contributions to the Plan by an employee salary reduction election up to IRC limits. The Company can make a discretionary match, based on different calculations for each participating company based on the amount contributed each pay period. The Company can also elect to make additional discretionary contributions.

**Participants’ Accounts**

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s matching contribution, (b) the Company’s discretionary contribution, if any, and (c) plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary portions of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 20% vested in Company match and discretionary contributions after two years of service and are fully vested upon completion of six years of credited service.

**Forfeitures**

Forfeitures may be used in succeeding years to reduce employer contributions. The balance in the forfeiture account at December 31, 2024 was \$12,129 and at December 31, 2023 was \$11,491.

**NOTE 1 - DESCRIPTION OF THE PLAN** (Continued)

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed as soon as administratively feasible. Distributions under the Plan may be made by lump-sum, by a partial withdrawal, or by installments for participants or beneficiaries who must receive required minimum distributions. If a participant's vested interest is less than \$5,000, the Plan can distribute their balance without the participant's consent.

In conditions of "financial hardship," a participant may apply to the plan administrator for approval to withdraw that portion of their 401K retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and IRC.

A participant who makes a withdrawal after age 59½ will not be subject to penalty and can remain an active participant in the Plan.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balance. The maximum loan period cannot exceed five years. Loans bear interest at 1% over the Prime Rate for the month as determined by the plan administrator. Interest is charged until the loan is repaid and loans are not placed on nonaccrual status. Loans are always fully collected and are not charged off as uncollectible. Loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized at the time payment is made. Principal and interest is paid ratably through payroll deductions and is credited to each participant's account balance.

**Administrative Expenses**

Certain expenses for administering the Plan are paid by the Company. The Company provides the Plan with certain accounting and administrative services for which no fee is charged.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**Basis of Accounting**

The accompanying financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") and conform to the accounting requirements of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Accounting Estimates**

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans, if material, are reclassified as distributions based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, (except for fully benefit-responsive investment contract which are reported at contract value). Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussions of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payments of Benefits**

Benefits are recorded when paid.

**NOTE 3 - FAIR VALUE MEASUREMENT**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value) in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 3 - FAIR VALUE MEASUREMENT** (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 1 or Level 3 inputs were available to the Plan.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Level 2 Fair Value Measurements*

*Pooled separate accounts:* The fair value of pooled separate accounts is based on the unit price reported by the sponsoring insurance company. Generally, the unit price is based on quoted market prices of the underlying investments owned, less any accrual of fees and expenses borne by the account, and divided by the number of shares outstanding.

Gains and losses (realized and unrealized) included in changes of net assets available for benefits for the year-ended December 31, 2024 are reported in net appreciation (depreciation) in fair value of investments.

**NOTE 4 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 5 - INCOME TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan which has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date and no provision for income taxes has been included in the Plan's financial statements.

The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021. There are currently no audits for any tax periods in progress.

**NOTE 6 - INFORMATION CERTIFIED BY THE CUSTODIAN**

**NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

All of the Plan investments are managed by Ameritas. Ameritas is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

**NOTE 8 - GUARANTEED INVESTMENT CONTRACT**

In 2013, the Plan entered into a benefit-responsive guaranteed investment contract with Ameritas. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net asset available for benefits at contract value. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$313,390 at December 31, 2024 and \$278,520 at December 31, 2023. The crediting interest rate is based on a formula agreed upon where the interest rate that is determined at the beginning of each deposit period cannot be less than 1.5%.

Certain events limit the Plan's ability to transact at contract value with Ameritas. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.
