December 31, 2024 and 2023

1. Description of Plan

The following description of the Lineage Logistics 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 2016, as restated January 1, 2022. The Plan covers generally all employees, excluding certain union employees, employees covered by a collective bargaining agreement and temporary employees of Lineage Logistics Holdings, LLC (the Company or Plan Administrator). Employees who have completed 30 days of continued employment are eligible to participate in the Plan beginning on the first day of the following month. Eligible employees of the Company who have completed 6 months of service are eligible to receive safe harbor match starting the first day of the month after completing 6 months. Eligible employees of the Company who have completed 12 months of service are eligible to receive employer profit sharing contributions. Eligible employees must be employed on the last day of the Plan year to qualify to receive a profit sharing contribution. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan. The Plan also covers certain union employees with various eligibility requirements as defined in the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan. The Plan's investment advisors, Sage View Advisory Group and Lockton Investment Advisors, LLC, determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Retirement Plan Committee.

In July 2023, the Plan amended its plan agreement relating to service requirements for certain union employees to receive employer contributions. As amended, to be eligible for both Company match and nonelective contributions, the Plan requires these certain union employees to complete one year of service or the equivalent of working 1,000 hours.

On July 22, 2024, the Plan Administrator approved the merger of City Ice Bargaining Unit 401(k) Plan into the Plan. The merger did not impact participant benefits as the benefit provisions were incorporated into the Plan. Active participants' accounts were transferred to the Plan. Therefore, the assets, liabilities and benefits of the plan were not being settled but rather continuing as part of the Plan. The total amount of assets transferred to the Plan was \$1,863,636.

On August 30, 2024, the Plan Administrator approved the merger of the Seafreeze Warehouse Savings Plan into the Plan. The merger did not impact participant benefits as the benefit provisions were incorporated into the Plan. Active participants' accounts were transferred to the Plan. Therefore, the assets, liabilities and benefits of the plan were not being settled but rather continuing as part of the Plan. The total amount of assets transferred to the Plan was \$2,392,680.

On September 30, 2024, the Plan Administrator approved the merger of the Hanson Cold Storage Co. Employees' 401(k) Retirement Savings Plan into the Plan. The merger did not impact participant benefits as the benefit provisions were incorporated into the Plan. Active participants' accounts were transferred to the Plan. Therefore, the assets, liabilities and benefits of the plan were not being settled but rather continuing as part of the Plan. The total amount of assets transferred to the Plan was \$2,661,098.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby certain union employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Generally, the Company makes safe harbor matching contributions equal to 100% of participant's elective deferrals that do not exceed 3% of participant's compensation, plus 50% of participant's deferrals between 3% and 5% of the participant's compensation. For certain union participants, the Company contributes various amounts as defined by the plan agreement. In addition, the Company may contribute profit sharing amounts at the option of the Board of Directors for nonunion participants. For certain union participants, the Company may make nonelective contribution resulting in discretionary pro-rata contributions. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor contributions plus actual earnings thereon, unless considered to be part of certain union groups.

Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service.

Participants who are members of certain union groups are vested immediately in their contributions plus actual earnings thereon. Union participants are 100% vested in the Company's contribution after six years of credited service.

All participants are 100% vested in the Company's discretionary profit sharing contributions plus actual earnings thereon after four years of credited service. Upon a participant's death, permanent disability or attainment of early or normal retirement date, as defined, the full amount of the Company's discretionary contributions becomes 100% vested.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at inception, is set at the determined by the Plan Administrator, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range from twelve months to 60 months years or greater for the purchase of a primary residence. Notes receivable from participants bear interest at rates that range from 3.25% to 10.50% at December 31, 2024 and 2023, and mature through May 2045.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installed payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$286,901 and \$300,156, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$0 and plan administrative expenses were reduced by \$189,894, from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Notes receivable from participants bear interest at rates that range from 3.25% to 10.50% at December 31, 2024 and 2023, and mature through May 2045. No allowance for credit losses was recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions as well as recordkeeping fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Recent Regulatory Updates

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

Subsequent Events

Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued.

In March 2025, the Plan Administrator approved the merger of the New Orleans Cold Storage 401(k) Plan, an affiliated plan of the Company, into the Plan. Total assets of \$3,107,214 were transferred to the Plan in March 2025.

In August 2025, the Plan Administrator approved the merger of the Allied Frozen Storage Inc. 401k Retirement Plan & Trust, an affiliated plan of the Company, into the Plan. Total assets of \$1,379,679 were transferred to the Plan in August 2025.

Management has concluded that no other events have occurred subsequent to December 31, 2024 that requires consideration as adjustments to, or disclosure in, its financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end. The money market fund is deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at net asset value: Consisting of common-collective trusts, valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$107,465,499 and \$97,390,981, respectively, that were concentrated in two funds consisting greater than 10% of net assets available for benefits.

5. Transfers in from Affiliated Plans

From time to time, employees may no longer meet the eligibility requirements of the Plan and become eligible to participate in another qualified plan sponsored by the Company, or vice versa. These employees have their account balances transferred between the Plan and another qualified plan sponsored by the Company.

On July 22, 2024, the Plan Administrator approved the merger of the City Ice Bargaining Unit 401(k) Plan into the Plan. The total amount of assets transferred to the Plan was \$1,863,636.

On August 30, 2024, the Plan Administrator approved the merger of the Seafreeze Warehouse Savings Plan into the Plan. The total amount of assets transferred to the Plan was \$2,392,680.

On September 30, 2024, the Plan Administrator approved the merger of the Hanson Cold Storage Co. Employees' 401(k) Retirement Savings Plan into the Plan. The total amount of assets transferred to the Plan was \$2,661,098.

6. Information Certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Vanguard Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

7. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by Vanguard Trust Company, the Trustee, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

During the year ended December 31, 2024, certain notes receivable from participants exceeded the 50% threshold of their vested account balances. The Plan Administrator and the Trustee are mitigating the noncompliance in 2025 and treating the excess amounts as deemed distributions which are reportable as taxable income to the impacted participants.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

9. Tax Status

The Plan adopted a pre-approved plan offered by The Vanguard Group. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
