Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Planned Parenthood of Wisconsin Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Planned Parenthood of Wisconsin Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Planned Parenthood of Wisconsin Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements

Note 1: Description of Plan

The following description of the Planned Parenthood of Wisconsin Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a defined-contribution plan sponsored by Planned Parenthood of Wisconsin (Company). Johnson Bank is the custodian of the Plan.

Eligibility

All employees, excluding those residing in Puerto Rico, are immediately eligible to make voluntary pretax and roth contributions to the Plan through a salary reduction agreement. All full-time employees of the Company who are 19 or older are immediately eligible for Company contributions.

Contributions

Each year, participants may contribute a portion of their compensation, as defined by the Plan, not to exceed the limits of the Internal Revenue Code (IRC), or the Plan, as defined. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute distributions from other qualified plans (rollovers).

In 2024, the Company made a discretionary matching contribution, which is equal to 50% of a participant's contribution to the Plan, up to 6% of compensation, as defined. In addition, the Company made a discretionary Company contribution to the Plan equal to 3% of each participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching and discretionary contributions and allocations of Plan net earnings thereon. Allocations are based on participant earnings or account balances, as defined in the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows participants to self-direct the investments of their accounts among various designated investment fund options. Participants may change investment allocations at any time.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately 100% vested in all contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their account balance the lesser of \$50,000 or one-half of the participant's vested account balance, with a minimum of \$1,000. Notes to participants are treated as a separate investment of the participant and all principal and interest payments on note balances are credited to the participant account from which the note was made. The notes are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator, which are commensurate with prevailing market rates. Principal and interest are paid through payroll deductions. Interest rates on the notes range from 4.25% to 9.50% depending on when the note was issued.

Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination. Upon termination of service, a participant can elect to receive their account balance, either as a lump-sum amount, in installments, or through optional forms of annuity-type payments. Under certain circumstances, participants may qualify for hardship withdrawals and in-service distributions. All participant accounts under \$7,000 are automatically paid in cash upon the participant's separation from employment.

Secure 2.0 Act of 2022

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, as well as allowing long-term, part-time workers who work at least 500 hours in three consecutive years to be eligible to participate in the Plan effective January 1, 2024. Management is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on an accrual basis. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan and are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Certain administrative expenses directly attributable to a participant's transaction are deducted from that participant's account. Investment related expenses are included in net appreciation in fair value of investments. All other administrative expenses are paid by the Company and are excluded from these financial statements.

Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: The fund is a commingled pool managed by BNY Mellon. Fair value was estimated using NAV per unit by the issuer of the common collective trust. Investment in the common collective trust can be purchased or sold continuously. While a notice of redemption is not required, BNY Mellon's discretion may, at its discretion, defer payments of withdrawals over a period of time, not to exceed twelve months. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, interest and dividends, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Johnson Bank, the custodian of the Plan.

Note 5: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 6: Tax Status

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 7: Party-In-Interest Transactions

Notes receivable from participants qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Planned Parenthood of Wisconsin Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a defined-contribution plan sponsored by Planned Parenthood of Wisconsin (Company). Johnson Bank is the custodian of the Plan.

Eligibility

All employees, excluding those residing in Puerto Rico, are immediately eligible to make voluntary pretax and roth contributions to the Plan through a salary reduction agreement. All full-time employees of the Company who are 19 or older are immediately eligible for Company contributions.

Contributions

Each year, participants may contribute a portion of their compensation, as defined by the Plan, not to exceed the limits of the Internal Revenue Code (IRC), or the Plan, as defined. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute distributions from other qualified plans (rollovers).

In 2024, the Company made a discretionary matching contribution, which is equal to 50% of a participant's contribution to the Plan, up to 6% of compensation, as defined. In addition, the Company made a discretionary Company contribution to the Plan equal to 3% of each participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching and discretionary contributions and allocations of Plan net earnings thereon. Allocations are based on participant earnings or account balances, as defined in the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows participants to self-direct the investments of their accounts among various designated investment fund options. Participants may change investment allocations at any time.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately 100% vested in all contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their account balance the lesser of \$50,000 or one-half of the participant's vested account balance, with a minimum of \$1,000. Notes to participants are treated as a separate investment of the participant and all principal and interest payments on note balances are credited to the participant account from which the note was made. The notes are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator, which are commensurate with prevailing market rates. Principal and interest are paid through payroll deductions. Interest rates on the notes range from 4.25% to 9.50% depending on when the note was issued.

Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination. Upon termination of service, a participant can elect to receive their account balance, either as a lump-sum amount, in installments, or through optional forms of annuity-type payments. Under certain circumstances, participants may qualify for hardship withdrawals and in-service distributions. All participant accounts under \$7,000 are automatically paid in cash upon the participant's separation from employment.

Secure 2.0 Act of 2022

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, as well as allowing long-term, part-time workers who work at least 500 hours in three consecutive years to be eligible to participate in the Plan effective January 1, 2024. Management is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on an accrual basis. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan and are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Certain administrative expenses directly attributable to a participant's transaction are deducted from that participant's account. Investment related expenses are included in net appreciation in fair value of investments. All other administrative expenses are paid by the Company and are excluded from these financial statements.

Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: The fund is a commingled pool managed by BNY Mellon. Fair value was estimated using NAV per unit by the issuer of the common collective trust. Investment in the common collective trust can be purchased or sold continuously. While a notice of redemption is not required, BNY Mellon's discretion may, at its discretion, defer payments of withdrawals over a period of time, not to exceed twelve months. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Information Prepared and Certified by the Custodian

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, interest and dividends, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Johnson Bank, the custodian of the Plan.

Note 5: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 6: Tax Status

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 7: Party-In-Interest Transactions

Notes receivable from participants qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA.
