Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following description of the Security Lock Distributors, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Plan participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on September 1, 1986 and restated September 11, 2017 by Security Lock Distributors, Inc. 401(k) (the Company), for the purpose of providing their employees with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All full-time employees of the Company who are not members of union or nonresident aliens, or leased employees (as defined in the plan document), and who are over 18 years old, are eligible to participate in the Plan.

Participant Contributions

Eligible participants may make voluntary pre-tax contributions through salary reductions up to 100% of eligible annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional "catch up" contribution (\$7,500 in 2024). The Plan allows rollover contributions from other qualified plans, as defined in the plan document.

The Plan also allows participants to defer funds into a "Roth 401(k) deferral." These deferrals are subject to federal income taxes, and the maximum allowable combined contributions of the Roth 401(k) deferrals and pre-tax deferrals is \$23,000.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

Employer Contributions

The Company may make discretionary matching contributions equal to a percentage of a participant's 401(k) elective deferral contribution. The discretionary matching contributions may be limited to a percentage of a participant's compensation or a dollar amount. The Company did not make a matching contribution for the year ended December 31, 2024.

The Plan also permits discretionary profit-sharing contributions. The Company made a discretionary profit-sharing contribution of \$1,838,751 related to the plan year ended December 31, 2024, which was deposited into the Plan during the year ending December 31, 2025.

Eligibility for employer discretionary match or employer discretionary profit-sharing contributions requires a participant to have completed one year of service.

Vesting

Participant's voluntary contributions, rollover contributions, and any earnings thereon vest immediately. Vesting in the employer matching and profit-sharing contributions portion of their accounts is based on years of continuous service (as defined). Participants vest in their accounts at a rate of 20% per year, beginning with the second year of service, with full vesting after completing six years of credited service. In the event of death, disability, or attainment of age 65, participants' accounts become fully vested.

Participants' Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with their respective contribution and its allocation of (a) employer discretionary contributions and (b) plan earnings or losses.

Payment of Benefits

Upon termination of employment, retirement, death, disability, special "hardship" reasons (as defined) or attainment of age 59 ½ (early retirement at age 55 is also available as defined in the plan document) a participant may receive a lump sum amount equal to the value of the vested interest in his or her account in accordance with Internal Revenue Service (IRS) regulations and plan provisions. Distributions are recorded when paid.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will serve to reduce future Company matching or profit-sharing contributions or to pay administrative expenses incurred by the Plan. During the year ended December 31, 2024, forfeitures totaling \$26,076 were used to pay for expenses incurred by the Plan, \$42,127 was forfeited during the year and \$95 was received in investment income. The balance in the forfeiture account as of December 31, 2024, was \$29,617.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023.

If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Participants may borrow up to 50% of their vested account balance with a minimum loan of \$1,000 and a maximum of \$50,000. Participants may only have one loan outstanding at any time. The interest rate is 1% above the prime interest rate. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Loans are secured by the balance in the participant's account. Principal and interest are paid ratably through automatic payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 8 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the plan year or at the time of purchase during the plan year.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Administrative Expenses

The Company may, at its discretion, pay the expenses incident to administering the Plan. In the event the Company does not pay plan expenses, the expenses shall be paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3. Financial Information Certified by The Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank (Charles Schwab), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions and Related-Party Transactions

Certain plan investments are shares of a money market fund managed by Charles Schwab. Charles Schwab is the trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA. Certain plan investments are shares of common collective trusts sub-advised by Sentinel Pension Advisors, Inc. (SPA), a division of Sentinel Benefits Group, Inc. (SBGI). SBGI is the record-keeper, and therefore, these transactions also qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA. SPA and SBGI received \$60,246 and Charles Schwab received \$21,860 in direct compensation during the year ended December 31, 2024, which is included in administrative expenses on the statement of changes in net assets available for benefits.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, at its discretion, to terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 6. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various securities. Investment securities are exposed to various risks such as interest rate, market and credit.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could, in the near term, materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 7. Tax Status

On November 30, 2020, the Internal Revenue Service (IRS) stated that the volume submitter plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Disclosures About Fair Value of Plan Assets and Liabilities

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** Inputs to valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** Significant unobservable inputs, including the Company's own assumptions in determining the fair value of investments

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued based on the underlying unit value of the assets held. The assets on the underlying funds are invested in mutual funds, equity securities, debt securities. The NAV of the units of the accounts is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Money market account: Valued at the closing price reported by the fund sponsor from an actively traded exchange.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
